NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the TireHub 401(k) plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of TireHub, LLC ("TireHub," "Employer," "Plan Sponsor" or "Company"), who have completed 60 days of service and have elected to participate in the Plan. Employees covered by a collective bargaining agreement and non-resident aliens are excluded from the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Administration

The trustee of the Plan is Empower Trust Company, LLC and the insurance provider is Empower Annuity Insurance Company of America. Empower Retirement performs participant recordkeeping and other administrative duties for the Plan. The TireHub 401(k) Plan Committee oversees the Plan's operations.

Contributions

Participants are automatically enrolled at 3% with annual increases of 1% per year to 6% of their pretax eligible compensation, unless they elect otherwise and may contribute up to 100% of their eligible compensation, subject to limitations established by the Internal Revenue Code ("IRC"). Participants who have obtained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution retirement plans, as well as direct rollovers from individual retirement accounts or annuities. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan provides an Employer matching contribution whereby the Company matches 100% up to 4% of eligible earnings contributed to the Plan by the participant. At the option of the Company's board of directors, discretionary contributions may also be made by the Company. No discretionary contributions were made by the Company during the years ended December 31, 2024 or 2023. All Company contributions are participant directed. Contributions are subject to certain limitations established by the IRC.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contribution, as applicable, and an allocation of Plan earnings and charged with withdrawals, an allocation of Plan losses and administrative expenses, if any.

Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contributions plus actual earnings thereon, is based on years of service as follows:

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of:

- \$50,000 reduced by the highest outstanding loan balance incurred by the Participant during the 12 month period ending on the day before the date on which the loan was made, or
- 50% of the participant's vested account balance.

Participants may only have one loan outstanding under the Plan at any one time. Loan terms range from one to five years. The loans are secured by the balance in the participant's account. Interest rates on loans outstanding ranged from 3.25% to 8.5% as of December 31, 2024 and 2023. Interest rates are at the prime rate plus 1% in accordance with the terms of the Plan and do not exceed the maximum amount permitted under applicable statutory law. Principal and interest is paid ratably through payroll deductions.

Benefits Paid to Participants

Upon retirement, termination of service, hardship, disability or the attainment of age 59½, a participant may receive all or part of the value of the participant's vested interest in his or her account as a lump-sum distribution. Upon death of a participant, the balance of the participant's vested interest in his or her account will be distributed in a lump sum to the participant's beneficiary.

Minimum required distributions for participants who have reached age 73 also apply per IRC regulations.

Forfeited Accounts

As of December 31, 2024 and 2023, forfeited, nonvested accounts totaled approximately \$98,000 and \$128,000, respectively. Forfeitures may be used to pay administrative expenses of the Plan, if not paid by the Plan Sponsor or to reduce future Company contributions. During the years ended December 31, 2024 and 2023, forfeitures of approximately \$515,000 and \$347,000, respectively, were used by the Plan to reduce Company contributions.

Administrative Expenses

The Plan will pay some or all Plan-related expenses, unless otherwise paid by the Company. The expenses charged to the Plan are charged pro rata to each participant in relation to the size of each participant's account balance. In addition, some types of expenses may be charged only to participant accounts based upon their use of a Plan feature or receipt of a Plan distribution.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America ("U.S. GAAP") requires management to make certain estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for the fully benefit-responsive investment contract, which is stated at contract value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. See Note 5 for investments at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as distributions based on terms of the Plan document.

Benefits Paid to Participants

Benefits are recorded when paid.

Administrative Expenses

The Company pays most administrative expenses associated with the Plan. Expenses relating to Plan investments are paid by the Plan and borne on a pro-rata basis by each participant and included in net appreciation in fair value of investments.

NOTE 3 - CERTIFIED INFORMATION

The Plan Administrator has elected the method of annual reporting compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following investment information in the financial statements and supplemental schedule of assets (held at end of year) was summarized from information supplied and certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC.

- Investments, at fair value and contract value and notes receivable from participants, as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants as shown in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Schedule H, line 4i schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 - FAIR VALUE MEASUREMENTS

Fair value represents the amount that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. In accordance with the standard on fair value, the Plan's financial assets and liabilities that are recorded on the statements of net assets available for benefits are determined using the following fair value hierarchy:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Company has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If an asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Company believes its valuation methods are appropriate and consistent with other market participants. The use of different methodologies or assumptions to determine the fair value of certain financial assets and liabilities could result in a different fair value measurement at the reporting date.

Following is a description of the valuation methodologies used for assets measured at fair value. There were no changes during the years ended December 31, 2024 and 2023, to the valuation techniques used to measure asset and liability fair values on a recurring basis.

Mutual Funds - The Plan's mutual fund investments are stated at fair value based on quoted net asset value, as reported on national security exchanges on which the mutual funds are traded. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 5 - INVESTMENT AT CONTRACT VALUE

The Plan entered into a fully benefit-responsive guaranteed investment contract with the Empower Annuity Insurance Company of America. Empower Annuity Insurance Company of America maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption

under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

NOTE 6 - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan's investments include a group annuity contract issued by Empower Annuity Insurance Company of America. Transactions in the investment qualify as party-in-interest transactions as defined by ERISA. Empower Advisory Group, LLC, an affiliate of the certifying entities, provides investment management services to the Plan which are also party-in-interest transactions. In addition, notes receivable from participants are party-in-interest transactions.

NOTE 7 - PLAN TERMINATION

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their account balances.

NOTE 8 - TAX STATUS

The Plan utilizes a prototype plan document. The Internal Revenue Service ("IRS") has determined and informed Empower Trust Company, LLC by a letter dated June 30, 2020, that the prototype plan document was designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan is qualified, and the related trust is tax exempt.

Plan management evaluates tax positions taken by the Plan and recognizes a tax asset or liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. As of December 31, 2024 and 2023, no uncertain tax positions have been taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 11 - SUBSEQUENT EVENTS

The Plan has analyzed its activity through September 30, 2025, the date these financial statements were available to be issued. There were no subsequent events that require adjustment or disclosure within these financial statements.
