

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Silver Cloud Inns Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Silver Cloud Inns Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note H to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Silver Cloud Inns Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Silver Cloud Inns Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

SILVER CLOUD INNS RETIREMENT PLAN**NOTES TO FINANCIAL STATEMENTS****YEAR ENDED DECEMBER 31, 2024****NOTE A - DESCRIPTION OF PLAN:**

The following description of the Silver Cloud Inns Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General -

The Plan is a defined contribution 401(k) plan, subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), covering all employees of the Company, except construction workers, who have reached age 21 and completed 60 days of service. A portion of the Plan administrative expenses are paid directly by the Company as Plan sponsor.

Eligibility -

Employees are eligible to participate in the Plan once they have reached age 21 and completed two consecutive months from the eligible employee's employment commencement date and during which at least one hour of service is completed.

Contributions -

Participants may elect to defer their annual wages, up to the maximum amount allowable under the Internal Revenue Code, and contribute these amounts to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Company contributes a discretionary match equal to a percentage of salary deferrals for each participating employee. The percentage is determined by the Company's management. In 2024, the matching contribution was 50% of the first 6% of compensation that a participant contributed to the Plan. In addition, the Company may contribute a discretionary profit-sharing contribution in an amount as determined by the management of the Company at the end of the year (none in 2024).

Participant Accounts -

Each participant's account is credited with the participant's elective salary deferral and the Company's matching contribution and charged for forfeitures upon their termination and administrative expenses. Each participant account is also credited with an allocation of the Company's discretionary contribution, if any, for participants credited with a year of service during the plan year and an allocation of Plan earnings or losses. Allocations are based on participant compensation or account balances, as indicated in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting -

Participants are immediately vested in their elective deferrals plus actual earnings thereon. Vesting in employer contributions is based upon years of continuous service. A participant is 100% vested after six years of credited service.

Forfeited Accounts -

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$73,350 and \$63,371, respectively. These accounts are used to reduce future employer contributions and pay administrative expenses. In 2024, employer contributions were not reduced by any forfeited non-vested accounts.

NOTE A - CONTINUED:**Payment of Benefits -**

On termination of service, a participant may elect to receive a lump-sum amount equal to the vested portion of his or her account. The trustees may elect to make the distribution in a lump-sum payment without consent or transfer the money to an IRA if the present value of a participant's benefit at termination is less than \$1,000. If the present value of a participant's benefit at termination is at least \$1,000 but less than \$5,000, the trustees can only transfer the money to an IRA without consent. The Plan also allows for hardship withdrawals.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:**Basis of Accounting -**

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates -

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Contributions -

Contributions from participants are recorded in the period in which they are withheld from the participant's compensation. Matching contributions from the Company are recorded in the period in which the related participant contributions are recorded.

Payment of Benefits -

Benefits are recorded when paid.

Date of Management's Review -

Management has evaluated subsequent events through September 5, 2025, the date which the financial statements were available to be issued.

Legislative and Regulatory Developments -

The Setting Every Community Up for Retirement Enhancement ("SECURE 2.0") Act of 2022 was signed into law on December 29, 2022, under Public Law 117-328. SECURE 2.0 contains several provisions that affect employee benefit plans, including provisions for automatic enrollments, required minimum distributions, and catch-up contributions amongst others. The plan is operating in accordance with all the mandatory provisions of SECURE 2.0 and has not opted to adopt any of the optional provisions. The Trustees are aware of the various provisions and will implement them as required.

Plan Amendment -

The Plan was amended effective July 21, 2022 to comply with the Cycle 3 plan restatement required by the IRS for pre-approved defined contribution plans.

NOTE C - FAIR VALUE MEASUREMENTS:

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available.

Level 2 Fair Value Measurements

Pooled separate accounts within the investment contract with the insurance company are stated at fair value as determined by observable Level 1 quoted pricing inputs or by quoted prices for similar assets in active or non-active markets. While pooled separate accounts may have publicly quoted pricing inputs (Level 1), the account values of separate accounts are not publicly quoted and are therefore classified as Level 2 investments.

Level 3 Fair Value Measurements

The general account portion of the investment contract with the insurance company is not actively traded and significant other observable inputs are not available. Thus, the fair value of the general account portion is based upon the approximate amount that would have been paid by the issuer if the investment contract had been terminated as of the last day of the reporting period. The following table provides further detail of the Level 3 fair value measurements.

General account realized gains and losses, if any, are reported in the statement of changes in net assets available for benefits and are reported in net appreciation in fair value of investments.

NOTE D - INVESTMENTS:

The Plan's investments are maintained under an investment contract with Voya Retirement Insurance and Annuity Company. It is funded through general account obligations and pooled separate accounts. The Plan owns units of participation in the fair value of the underlying pooled assets. The fair value represents the approximate contract value, and does not take into account surrender charges or certain market value adjustments that would apply if the contract was terminated. Each participant may direct the allocation of his or her own account balance among the various underlying investment options. The Plan sponsor has determined that the contract is not fully benefit-responsive as described in the plan accounting – defined contribution pension plans accounting literature.

NOTE E - RELATED PARTY TRANSACTIONS:

Voya Retirement Insurance and Annuity Company (Voya) is the issuer of the group funding contract as defined by the Plan and therefore is a party-in-interest. Certain Plan investments are sponsored by Voya. Voya received no eligible direct compensation for the year ended December 31, 2024.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE F - PLAN TERMINATION:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

NOTE G - INCOME TAX STATUS:

The Plan is intended to be a qualified plan under Section 401(a) of the Internal Revenue Code, and the Plan is interpreted, applied and administered consistent with the intent to qualify. The Plan was established through a regional prototype plan of Pension Design & Administration, Inc., who has received a letter from the Internal Revenue Service indicating the Plan is acceptable. The Plan has been amended and restated since the Pension Design & Administration, Inc. prototype plan received its letter from the Internal Revenue Service stating it was acceptable.

The Company has not obtained a specific determination letter from the Internal Revenue Service for the Plan as adopted, however, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan's annual return/report is subject to examination by the Department of Labor and the Internal Revenue Service. Because many types of transactions are susceptible to varying interpretations under Department of Labor and Federal tax laws and regulations, the amounts reported in the accompanying financial statements may be subject to change at a later date upon final determination by the Department of Labor.

NOTE H - INFORMATION PREPARED AND CERTIFIED BY TRUSTEE:

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
