Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Fred Beans Automotive Group 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Opinion (Continued)

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. NOTES TO FINANCIAL STATEMENTS

Note 1. Description of the Plan

The following description of the Fred Beans Automotive Group 401(k) Plan (the Plan) sponsored by Fred Beans Family of Dealerships (Company) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a voluntary salary reduction plan available to employees of the Company who have met certain eligibility requirements and was previously amended and restated to bring the Plan into compliance with certain laws and regulatory changes. Employees are eligible to participate in the Plan following two months of service and attainment of age 18 for employee deferral contributions, qualified non-elective contributions, employer matching contributions and employer non-elective contributions. The Plan has an automatic enrollment feature of 3%, with increases of 1% annually each June 25th up to a maximum of 10%. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Note 1. Description of the Plan (Continued)

Contributions: Each year participants may voluntarily contribute 1% to 50% of their eligible compensation to the Plan, within the IRC Section 415 deferral limitations. Employees are eligible to participate once they reach 18 years of age and have two months of service. The Plan has an automatic enrollment feature whereby eligible employees shall have elective deferrals withheld in the amount of 3% of compensation unless they opt not to participate in the Plan. The Plan has an auto-escalation feature of 1% on each successive June 25th thereafter, up to maximum deferral of 10%. The Company matches 25% of the contributions of each participant up to a maximum of 8% of each participant's annual compensation. In addition to the matching contributions, the Company may make contributions to the Plan at the option of the Company's Board of Directors.

Participant Accounts: Each participant's account is credited with the participant's contributions, the Company's matching contributions and an allocation of (a) Plan earnings net of expenses and (b) discretionary contributions. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their accounts is gradual based on years of continuous service. A participant is 100 percent vested after six years of credited service.

Investment Options: Participants may direct the investment of their account into any investment options offered by the Plan. If a participant makes no election, the account is invested in the applicable Fidelity Advisor Freedom Target Date Fund based on their expected normal retirement date. Participants may change their investment options as often as they like.

Participant Loans: Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or up to ten years for the purchase of primary residence. Interest rates on loans are based on a fixed rate similar to a bank's rate for a comparable personal loan. Loans are secured by the vested balance in a participant's account. Loan repayments must be paid directly to the Plan through payroll withholdings and are then credited to the participant's account. Participants may have only one loan outstanding at a time.

Payment of Benefits: Payment of benefits on account of retirement, death, disability or termination of employment will be made in one lump-sum or in installment payments based on life expectancy.

Forfeited Accounts: Forfeitures of participants' non-vested accounts may be used to pay administrative expenses or reduce employer matching contributions. At December 31, 2024 and 2023, forfeited non-vested accounts amounted to \$5,863 and \$78,198, respectively. During 2024, forfeitures of \$306,043 were used to offset employer match and \$115 were used for plan fees.

Note 2. Summary of Significant Accounting Policies

Accounting Method: It is the Plan's policy to maintain its books and records on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balances plus any accrued interest. Delinquent loans are treated as distributions based upon the terms of the plan document surrounding defaulted loans.

Payment of Benefits: Benefits are recorded when paid.

Subsequent Events: In preparing these financial statements, the Plan Sponsor has evaluated events and transactions for potential recognition or disclosure through September 15, 2025, the date the financial statements were available to be issued. See Note 9.

Note 3. Information Certified by the Trustee

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to information certified as complete and accurate by Fidelity Management Trust Company, (the trustee of the Plan).

Note 4. Investments and Fair Value Measurements

The Plan measures, on a recurring basis, its investments at fair value in accordance with Financial Accounting Standards Board (FASB) codification *Fair Value Measurement*, which provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy are as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that are accessible to the Plan. These generally provide the most reliable evidence and are used to measure fair value whenever available.
- Level 2: Inputs to the valuation methodology include significant inputs, other than Level 1 inputs, that are observable either directly or indirectly for substantially the full term of the asset through corroboration with observable market data. Level 2 inputs include quoted prices for similar assets in active markets, quoted market prices in markets that are not active for identical or similar assets, and other observable inputs.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The inputs or methodology used for valuing investments are not an indication of the risk associated with investing in those securities.

The following is a description of valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Shares of registered investment companies (mutual and money market funds) are valued at the daily closing price as reported by the funds. The funds held by the Plan are open-ended mutual funds registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

Note 5. Related Party and Party-in-Interest Transactions

Certain Plan investments are shares of registered investment companies managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the Trustee of the Plan, and therefore, these transactions qualify as party-in-interest transactions.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

Note 7. Tax Status

The Company has adopted a non-standardized pre-approved profit-sharing plan sponsored by Fidelity Management & Research Company, LLC (FMR LLC). The non-standardized pre-approved profit-sharing plan has received an opinion letter from the Internal Revenue Service dated June 30, 2020, as to the Plan's qualified status. The IRS has determined that the volume submitter plan is designed in accordance with the applicable sections of the Internal Revenue Code. The non-standardized pre-approved profit-sharing plan opinion letter has been relied upon by this Plan. Although the Plan has been amended subsequently, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

Note 9. Subsequent Events

In October 2024, the Plan Sponsor, Fred Beans Automotive Group, acquired Freysinger Automotive. Freysinger, consisting of GMCB Autos of Mechanicsburg, Inc., HY Imports of Mechanicsburg, Inc., and MA Imports of Mechanicsburg Inc., entered the Plan in 2025.

Effective May 15, 2025, the Plan allows distributions in the form of installment payments and partial withdrawals.
