INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator
Blue Stone Therapy 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Blue Stone Therapy 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974, as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Blue Stone Therapy 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

Basis for Opinion

Note A - Description of Plan and Summary of Accounting Policies

Description of Plan

The following description of the Blue Stone Therapy 401(k) Plan ("Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

- 1) General. The Plan is a single-employer defined contribution 401(k) plan covering all eligible employees of Premier Health Services LLC d/b/a Blue Stone Therapy Services ("Company"), age 21 years or older with sixty (60) days of service. Employees subject to collective bargaining are not eligible to participate in the Plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The assets of the Plan are held by Principal Trust Company, the trustee and custodian for the Plan.

As of September 15, 2023, the employer Premier Health Services LLC d/b/a Blue Stone Therapy Services, spun-off from the LTC Accounting Services LLC 401(k) Plan & Trust. As of September 15, 2023, Blue Stone Therapy Services participants represented \$5,218,000 of Plan assets and \$44,260 of outstanding Plan loans.

- 2) Contributions. Participants may elect to contribute up to 100% of their gross compensation to the Plan, subject to the statutory maximum allowed by law. Participants may also contribute amounts representing distributions from other qualified plans. The Company matches 50% of employees salary deferral up to a maximum of 4% of employees salary deferral to the Plan. The Company also can make employer profit sharing contributions which are determined by the Company and are discretionary. Participants direct the investment of all contributions into various investment options and may change their investment options at any time. The Plan currently offers 13 mutual funds, 9 collective investment trusts, 1 pooled separate account, and 1 guaranteed interest account as investment options for participants. Participants may change their investment options daily.
- 3) Participant Accounts. Each participant's account is credited with the participant's contributions and an allocation of the employer's contribution and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- 4) Vesting. Participants are immediately vested in their elective deferral contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.
- 5) Notes Receivable from Participants. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 reduced by the excess, if any, of the participant's highest outstanding loan balance during the 12-month period ending on the date of the loan or 50% of the participant's vested account balance. The loans are secured by the vested portion of the participant's account up to 50% of a participant's vested balance, and bear interest at a rate commensurate with local prevailing rates, as determined by the plan administrator, which are 4.25% to 9.50%. Principal and interest is paid ratably through payroll deductions.

- 6) Payment of Benefits. On termination of service due to death, disability, retirement, or other reasons all distributions from the Plan will be made in one lump-sum payment as soon as administratively practicable following the participant's separation of service. The Plan allows for hardship withdrawals to participants who meet an immediate and heavy financial need and are limited to a participant's elective deferral account balance.
- 7) Forfeited Accounts. At December 31, 2024 and 2023, forfeited accounts totaled \$38,882 and \$7,827, respectively. These accounts are used to reduce the employer's matching contribution. During the year ended December 31, 2024 and 2023, forfeitures of \$0 and \$31, respectively, were used to reduce employer contributions.

Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's mutual funds are registered investment companies and are stated at fair market value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The collective investment trusts and guaranteed interest account is stated at fair value as determined by Principal Trust Company and are based on the net asset value of units held by the Plan at year-end.

Purchases and sales of securities are reflected on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation or depreciation in market value of investments includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

Administrative Expenses

A portion of administrative expenses incurred on behalf of the Plan are paid by the Company, which also provides certain administrative services that have not been charged to the Plan. The amount of such expenses and cost of such services have not been determined. Additionally, no Company employee receives compensation from the Plan. Investment-related expenses are included in net appreciation in fair value of investments. All administrative expenses are charged to participant accounts.

Concentration of Credit Risk

Financial instruments that potentially subject the Plan to concentrations of credit risk are part of the holdings in Plan's investments. Management believes that the Custodian maintains the Plan's investments with high credit quality institutions and attempts to limit the credit exposure to any particular investment.

Payments of Benefits

The Plan records benefit payments to withdrawing participants when paid.

Date of Management's Review

For the year ended December 31, 2024, the Plan has evaluated subsequent events for potential recognition and disclosure through September 30, 2025, the date the financial statements were available to be issued.

Note B - Tax Status

The IRS has determined and informed the Plan sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the advisory opinion, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Note C - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

Note D - Information Prepared and Certified by Principal Trust Company

Note E - Fair Value Measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies.

Level 3 - Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

Note F - Investment Contracts with Insurance Company

The Plan has entered into a guaranteed interest account with Principal Life. The account is credited with actual earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Principal Trust Company has certified that the account is included in the statements of net assets available for benefits at contract value. The guaranteed interest account is fully benefit-responsive. For example, participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan has entered into a pooled separate account with Principal Life. The account is credited with actual earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Principal Trust Company has certified that the account is included in the statements of net assets available for benefits at net asset value.
