Notes to Financial Statements

NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The financial statements of Clarke Power Services, Inc. Employee Retirement Savings Plan (the "Plan") are prepared under the accrual basis of accounting using accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statement of net assets available for benefits.

Notes Receivable from Participants

For reporting purposes, participant loans are classified as notes receivable from participants. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

Related-Party Transactions

In 2024 and 2023, certain Plan investments are invested in funds with a registered investment company managed by Delaware Charter Guarantee and Trust Company d.b.a. Principal Trust Company. Principal Trust Company is the asset custodian as defined by the Plan. Therefore, these transactions qualify as party-in-interest.

Several employees of the Company provide administrative services to the Plan. These services include Plan oversight and day-to-day Plan administration. The Plan is not charged by the Company for the services of the employees to the Plan.

Estimates

The preparation of financial statements in conformity with United States generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Benefit Payments

Benefit payments are recorded when paid.

Subsequent Events

In preparing its financial statements, the Plan sponsor has evaluated events subsequent to the balance sheet date through September 3, 2025, which is the date the financial statements were available to be issued.

NOTE 2 DESCRIPTION OF THE PLAN

The following description of the Plan provides only general information. Participants should refer to their Clarke Power Services, inc. Employee Retirement Savings Plan handbook for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Clarke Power Services, Inc., Clarke Fire Protection Products, Inc. and VehiCare Asset Management Group, Inc. (the Company) who are 18 years of age or older. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

A participant may contribute up to 75% of eligible compensation through pre-tax or Roth elective deferrals. The Plan provides for pre-tax automatic deferrals at 6% of eligible compensation unless the participant elects a different percentage or elects to not make elective deferrals. The automatic deferrals will increase annually by 1% to a maximum elective deferral contribution of 15% of eligible compensation. Participants may change the percentage of contributions invested in each account and may make transfers between accounts anytime during the year. Participants designate the percentage of their total contribution to be invested in any of the Plan's investment funds. Contributions may not exceed limitations established under Section 402(g) of the Internal Revenue Code of 1986 as amended (\$23,000 at December 31, 2024). For 2024, Section 414(v) of the Internal Revenue Code of 1986 as amended allowed a maximum catch-up contribution of \$7,500.

The Plan requires the Company to make employer matching contributions to the Plan. In 2024, the Company made a contribution of 50% of participant's contributions, up to \$100. The total amount of the matching contribution was \$85,336 for the year ended December 31, 2024.

The Plan requires the Company to make a qualified non-elective contribution in the amount equal to 3% of eligible compensation each pay period for all active participants. Contributions are 100% vested in the Plan. The total amount of this employer contribution was \$1,770,059 for the year ended December 31, 2024.

Discretionary contributions may be made for each Plan year in an amount determined by the Company to salaried and salaried non-exempt employees. The total amount of the discretionary contributions was \$491,295 for the year ended December 31, 2024.

Contributions (continued)

Effective July 26, 2019, the plan was amended to require the Clarke Power Services, Inc. (CPS) to contribute to all employees of the District No. 34 of International Association of Machinists and Aerospace Workers AFL-CIO (Union 34) \$460 for all those employed as of July 26, 2019. Furthermore, effective the second full week of January 2020 and continuing each week thereafter, CPS is required to contribute \$0.50 per hour (up to a maximum of 40 hours per week) for each hour worked or paid for vacation or holiday. Finally, for all Union 34 employees hired before March 18, 2019 who did not have 5 years of vesting service in the I.A.M. National Pension Fund as of March 18, 2019, CPS will make a one-time additional contribution on the employee's fifth anniversary of their date of hire equal to CPS's total contributions into the I.A.M. National Pension Fund on their behalf. Effective March 14, 2022, the plan was amended to eliminate this contribution and increase the non-elective contribution from 3% to 5% of eligible compensation. This additional contribution was \$90,085 for the year ended December 31, 2024.

Effective September 1, 2019, the plan was amended to require Clarke Fire Protection Products, Inc. (CFPP) to contribute to all employees of the District No. 34 of International Association of Machinists and Aerospace Workers AFL-CIO (Union 34) \$0.50 per hour (up to a maximum of 40 hours per week) for each hour worked or paid for vacation or holiday. Finally, for all Union 34 employees hired before September 1, 2019 who did not have 5 years of vesting service in the I.A.M. National Pension Fund as of September 1, 2019, the Company will make a one-time additional contribution on the employee's fifth anniversary of their date of hire equal to the Company's total contributions into the I.A.M. National Pension Fund on their behalf. The total amount of this employer contribution was \$83,524 for the year ended December 31, 2024.

Rollover Contributions

Participants may roll over their taxable portion of funds previously held for their account in another qualified employee benefit plan to the Plan on a tax-free basis.

Participant Accounts

Each participant's account is credited with the participant's and Company's contributions and a pro-rata allocation of the Plan's earnings. The pro-rata allocation is based upon the proportion of individual account balances to total participants' account balances in the respective investment funds. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants become immediately vested at the time of participation in the Plan in their contributions and qualified nonelective contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts, plus actual earnings thereon is based on years of continuous service. Participants become 100% vested after one year of credited service. Non-vested portions of participant accounts that are forfeited upon payment of benefits are retained in the Plan and used to reduce administrative expenses.

Forfeitures

Forfeitures of the Plan may be used to reduce administrative expenses of the Plan or to reduce the employer matching contributions to the Plan. At December 31, 2024 and 2023, the amounts of unallocated forfeitures were nominal. During 2024, forfeitures in the amount of \$13,785 were used to reduce the employer contributions.

Payment of Benefits

Upon a participant's retirement date, the participant may receive benefit in accordance with the Plan's provisions and existing laws and regulations.

In conditions of "financial hardship", a participant may apply to the Plan administrator for approval to withdraw that portion of his or her 401(k) retirement account balance necessary to meet the financial hardship, subject to the limitations of the Plan and the Internal Revenue Code.

Upon termination of the Plan, the assets will be distributed to participants in accordance with the Plan's provisions and existing laws and regulations.

Notes Receivable from Participants

Notes receivable from participants are available on amounts in the participant's account. The minimum note receivable amount is \$1,000 and the maximum is the lesser of one-half of the participant's vested account balance or \$50,000. The vested participant account balance will be used as collateral for any note receivable. All notes receivable shall bear a reasonable rate of interest as determined by the Plan administrator. Note receivable terms range from one to five years or beyond five years, as agreed upon by the Participant and the Administrator, for the purchase of a primary residence.

Self-Directed Portfolio

Participants are permitted to self-direct their account through the Principal Self-Directed Brokerage Account. Participants are not permitted to work with outside investment advisors.

Administrative Expenses

Certain Plan expenses are paid by the Plan sponsor.

NOTE 3 TAX STATUS

The Plan sponsor has adopted a volume submitter specimen plan which has received an opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020, which states that the provider's prototype, as designed, is in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan itself had not received a determination letter from the IRS. The Plan has been amended since receiving the determination letter. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, therefore, no provision for income tax has been included in the Plan's financial statements.

NOTE 5 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 6 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs.

The hierarchy is broken down into three levels based on the ability to observe inputs as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation approaches used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Valued at the daily closing price as reported by the fund. Registered investment companies' funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective investment trust: Valued based on the NAV of units of a collective trust as published by the trustee. The existence of certain conditions can limit the trust's ability of the Plan to transact with participants at fair value of the collective trust. Specifically, any event outside the normal operation of the trust which causes a withdrawal from the investment contract may result in a negative market value adjustment with respect to such withdrawal. Examples of such events include, but are not limited to, layoffs, bankruptcy, plant closings, plan termination, mergers, early retirement incentives, communications designed to induce participants to transfer from the fund, competing fund transfer or violation of equity wash or equivalent rules in the plan, and changes in qualification status of employer or plan. As of December 31, 2024, the occurrence of an event outside the normal operation of the trust which would cause a withdrawal from the investment contract is not considered probable.

Pooled separate accounts: The NAV of the pooled separate account is based on the market value of its underlying investments. The pooled separate account is not a publicly-quoted price in an active market. The pooled separate accounts invest in various mutual funds, equity and debt securities and commercial real estate to generate their investment return.

Self-directed portfolio: Portfolio consists of publicly traded securities that are valued at the closing price reported on the active market on which the individual securities are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different approaches or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
