INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of the
ADS 401(K) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of **ADS 401(K) Plan**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of **ADS 401(K) Plan's** financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

The firm of Philip+Rae & Associates, CPA's, which audited the financial statements of the Plan for the year ended December 31, 2023, was acquired by Platform CPA's, LLP effective November 4, 2024.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of **ADS 401(K) Plan** and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about **ADS 401(K) Plan's** ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Note 1 – Description of the Plan

The following brief description of ADS 401(K) Plan (Plan) is provided for general information purposes only. Participants should refer to the plan agreement for more complete information.

General

The Plan is a defined contribution plan covering all non-union employees of Alarm Detection Systems, Inc. (“Company”) who have completed two months of service prior to February 1, 2023 or 30 days of service subsequent to February 1, 2023. It is subject to the provision of the Employee Retirement Income Security Act of 1974, as amended. (“ERISA”).

Contributions

Each year, participants may contribute in either dollars or whole percentages of pre-tax compensation as defined by the plan or after tax Roth contributions. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Participants who have attained the age of 50 before the end of the Plan’s year are eligible to make catch-up contributions. Participants may also transfer (rollover) amounts representing distributions from other qualified plans. The Company, in its sole discretion, may make a matching contribution to each participant. The matching contribution shall be contributed to each eligible participant in accordance with the nondiscriminatory formula determined by the Company. Matching contributions will be calculated on a bi-weekly basis. All contributions are participant directed into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Code (IRC) limitations.

Participant accounts

Each participant’s account is credited with the participant’s contribution, the Company’s matching contribution and Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined.

Vesting

Participants’ contributions and earnings thereon are immediately fully vested. A participant’s portion of the Company’s contributions and related investment income vests according to the following schedule:

Note 1 – Description of the Plan (continued)***Investment options***

The assets of the Plan, both employee and employer, are allocated to the various funds at the direction of the participant. The Plan offers various investment options. A participant may maintain their entire account in one of the funds or may elect to split their account among the funds in accordance with the Plan.

Participants may change their investment direction of future contributions and may elect to transfer their existing account balances from one fund to another daily.

Payment of benefits

On termination of services due to disability, retirement, or other reasons, a participant may elect to receive the value of the participant's vested interest as a single lump-sum distribution or installment payments over a period of not more than the participant's life expectancy (or the assumed life expectancy of the participant's beneficiary) only if the vested account balance exceeds \$7,000. On termination of services due to death, the beneficiary of death benefit exceeding \$7,000 may elect payment in a single lump-sum distribution or annual installments at least equal to required minimum distribution amounts but not exceeding 10 years.

Notes receivable from participants

Participant loans are permitted in accordance with the Plan's established loan procedures as follows: All loans will be limited to 50% of the participant's vested account balance, provided such loan does not exceed \$50,000. Loans will only be permitted for certain reasons as established by the Company. Loans are secured by a maximum of 50% of the participant's vested account balance. Loans shall bear an interest rate of 1% over the prime rate on the first business day of the month before the loan is originated. The interest rate is fixed for the life of the loan. Principal and interest payments will be made bi-weekly through payroll withholding.

Forfeited accounts

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$44 and \$496, respectively. These accounts will be used to reduce future employer contributions or pay reasonable plan expenses. During 2024 and 2023, employer contributions were reduced by \$45,969 and \$45,929 respectively, from forfeited non-vested accounts.

Other nonparticipant accounts

As of December 31, 2024 and 2023, other non-participant accounts totaled \$8,770 and \$7,600, respectively. These accounts are a result of excess fees and unclaimed property, in the form of un-cashed distribution checks.

Plan termination

The Company anticipates that the Plan will continue without interruption but reserves the right to discontinue the Plan. In the event that the Plan is terminated, all participants shall be fully vested, and each participant will be entitled to a distribution equal to his or her contributions and his or her share of Company contributions, investment income and loss, and unrealized appreciation or depreciation in the fair value of investments.

Note 1 – Description of the Plan (continued)***Plan Amendments and other Plan changes***

The plan was amended to change eligibility conditions to be 30 days of service for employees whose commencement date is on or after February 1, 2023. Two months of service is required for employees who were hired prior to that date.

Note 2 – Summary of Significant Accounting Policies***Basis of accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment valuation using fair value measurements

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Investment transactions and investment income

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023, as all notes receivable are secured by vested account balances.

Use of estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Payment of benefits

Benefit distributions are recorded when paid.

Operating expenses and investment fees

The Company pays a portion of the administrative expenses on behalf of the Plan. Expenses that are paid by the Company are excluded from these financial statements. The plan pays an asset-based fee and annual participant account maintenance fee. Prior to March 2023, the Company paid certain embedded investment expenses under a revenue sharing agreement.

Note 3 – Tax Status

The Plan was established under the Great-West Trust Company, LLC Defined Contribution Prototype Plan and Trust, As such, the Internal Revenue Service had determined by a letter dated June 30, 2020 that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (“IRC”) The Company and Plan management believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC, and the Plan and related trust continue to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing authorities, however, there are currently no audits for any tax period in progress.

Note 4 – Information Certified by Trustee

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan management instructed the plan’s independent auditors not to perform any auditing procedures with respect to the following information certified by Empower Trust Company, LLC , the trustees of the Plan, as complete and accurate, except for comparing such information certified by the trustee with information in the plan’s financial statements and supplemental Schedule H, line 4i – Schedule of Assets (Held at End of Year).

Note 5 – Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

Level 3 - Inputs are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used for the years ended December 31, 2024 and 2023.

- Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held in the fund are deemed to be actively traded.
