NOTES TO FINANCIAL STATEMENTS

Safeguard Properties Management, LLC 401(k) Profit Sharing Plan

1 Description of Plan

The following description of Safeguard Properties Management, LLC 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering all employees of Safeguard Properties Management, LLC (the “Company”) who meet the hour and age requirements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan was amended and restated November 1, 2021 to update certain definitions.

Eligibility:

All employees of the Company who have been employed for one month of full-time service by the first day of any calendar month are eligible to participate in the Plan.

Contributions:

Employee Contributions - Participants may elect a portion of their compensation up to 100% of their annual wages to be contributed to the Plan by the Company. The Plan includes an automatic-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they elect not to participate. Automatically enrolled participants will have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated fund until changed by the participant. In addition, the Plan has an automatic 1% annual deferral increase for auto enrolled participants up to 10%. The Plan also allows catch-up contributions for employees who meet certain eligibility requirements, Roth and rollover contributions.

Employer Contributions - The Company may make contributions to each eligible participant's account by matching 50% of the salary deferrals limited to 4% of participants' eligible wages of the Participant's elective deferral for the plan year.

Employer Discretionary Contributions - The Company may also make additional contributions. Such additional contributions, if any, shall be allocated to each Participant in proportion to his or her compensation for the calendar year. No discretionary contributions were made in 2024 or 2023.

Effective November 1, 2021, the Plan was amended to include in-plan Roth rollovers and transfers. This provision allows participants to convert their existing accounts held within the Plan to designated Roth accounts held within the Plan, provided certain conditions are met in accordance with the Plan document.

Contributions are subject to limitations on annual additions and other limitations imposed by the Internal Revenue Code, as defined in the Plan agreement.

NOTES TO FINANCIAL STATEMENTS

1 Description of Plan, Continued

Participants' Accounts:

Each participant's account is credited with the participant's elective contributions, employer matching contributions, employer discretionary contributions, earnings and losses thereon.

Vesting:

All participants are 100% vested in elective deferrals, qualified non-elective contributions and rollover contributions made to the Plan. Vesting in the participant's account balance is based on years of service. Participants vest in Company matching and discretionary contributions ratably over a 5-year period with 20% being vested upon one year of service, 20% for each year of service thereafter, and full vesting after the fifth year of service.

Forfeitures:

Forfeited non-vested accounts totaled \$7,367 and \$7,720 as of December 31, 2024 and 2023 respectively. The Company may use forfeitures to reduce future employer contributions or pay plan fees.

Notes Receivable from Participants:

Loans are permitted under certain circumstances and are subject to limitations. Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loans are repaid over a period not to exceed 5 years with exceptions for the purchase of a primary residence. Loans are valued at unpaid principal plus accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

The loans are secured by the balance in the participant's account and bear interest at rates established by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

Other Plan Provisions:

Distributions from a participant's account are not permitted before age 59 1/2 except in the event of death, disability, termination of employment or financial hardship, as defined. However, a participant may retire at the age of 55 and receive 100% of their account balance if they have completed at least five years of service, as defined.

Payment of Benefits:

Upon termination of service by reason of separation of service, retirement, death or total and permanent disability, a participant receives a lump sum amount equal to the value of his or her account as long as the vested balance does not exceed \$5,000. If the vested balance exceeds this threshold, the participant has the option to receive the benefits through a single lump-sum cash payment, installment payments, partial withdrawals, or rollover into a separate plan.

1 Description of Plan, Continued

Payment of Benefits, Continued:

With respect to distributions, if the vested balance is greater than \$1,000 and less than \$5,000, and the participant does not make an election to either receive or to roll over the distribution, the distribution must be rolled over to an IRA. Benefits are recorded when paid. There are no early retirement provisions.

Hardship Withdrawals:

Hardship withdrawals are permitted in accordance with Internal Revenue Service guidelines.

Investment Options:

Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan.

2 Summary of Significant Accounting Policies

Basis of Accounting:

The Plan's transactions are reported on the accrual basis of accounting.

Valuation of Investments:

Investments held in the Plan are stated at fair value. Mutual funds and common collective trusts are reported at fair market value as of the balance sheet date. Fair market values represent quoted market prices or, if quoted market prices are not available, estimated fair values as determined by the Plan's investment broker.

The fair value of the Plan's investment in the stable value fund represents the sum of the participant contributions less distributions and includes interest at a stated rate ("contract value"). Contract value approximates fair value of the investment as it's the dollar amount participants would receive upon distribution. Participant transactions may occur daily.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as held during the year.

Use of Estimates:

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

NOTES TO FINANCIAL STATEMENTS

2 Summary of Significant Accounting Policies, Continued

Administrative Fees:

Substantially all administrative fees are paid by the Company.

Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

Risks and Uncertainties:

The Plan's investments include investments in mutual funds, collective trusts and a stable value fund with varying degrees of risk, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the Statement of Net Assets Available for Plan Benefits.

Contributions:

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Subsequent Events:

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements.

Subsequent events have been evaluated through September 25, 2025, which is the date the financial statements were available to be issued.

3 Tax Status

On June 30, 2020, the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended; however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities.

NOTES TO FINANCIAL STATEMENTS

3 Tax Status, Continued

The Plan Administrator has analyzed tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress.

4 Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- * Quoted prices for similar assets or liabilities in active markets.
- * Quoted prices for identical or similar assets or liabilities in inactive markets.
- * Inputs other than quoted prices that are observable for the asset or liability.
- * Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable inputs for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds:

The fair value of the mutual funds is based on quoted market prices and are included in level 1 of the hierarchy.

4 Fair Value Measurements, Continued

Stable Value Fund:

The fair value of the stable value fund is based on the principal and guaranteed interest credited to participant accounts. The contract value of the account approximates fair value as that is the amount that is paid out upon distribution to the participants.

The stable value fund is valued based on NAV as the practical expedient, as it can be redeemed at its net asset value on their measurement date. The stable value fund can be redeemed on a daily basis, and there are no unfunded commitments.

Common Collective Trusts:

The fair value of the common collective trusts is based on the net fair value of the underlying assets. The underlying investments are valued at fair value based on commercial quotation services. The fair value is allocated among the contract holders based on a unit value. The common collective trusts are valued based on NAV as the practical expedient, as they can be redeemed at their net asset value on their measurement date. The common collective trusts can be redeemed on a daily basis, and there are no unfunded commitments.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.
