INDEPENDENT AUDITORS' REPORT

To the Management and the Trustees of
the Diversified Search Group Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Diversified Search Group Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Diversified Search Group Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements, related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. 1. The Plan

The following description of the Diversified Search Group Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan covering substantially all employees of SV-DVS Holdings, LLC, and Subsidiaries (the “Company”) who are not excluded employees, as defined. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions – Each year, participants may make pre-tax contributions and after-tax Roth contributions to the Plan, deferring a percentage of total compensation as specified by the Plan document, subject to Internal Revenue Service (“IRS”) regulations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Plan also allows in plan Roth rollovers.

The Company may make a discretionary matching contribution. For the years ended December 31, 2024 and 2023, the Company contributed 3% of a participant’s eligible compensation to the Plan. Matching contributions made for the years ended December 31, 2024 and 2023 were \$953,662 and \$1,305,883, respectively. The Company may also make an additional discretionary non-elective contribution. There were no additional Company contributions for the years ended December 31, 2024 and 2023.

Participant Accounts – Each participant’s account is credited with the participant’s contribution and allocation of: (a) the Company’s contributions; and (b) Plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Forfeitures – Forfeitures, which are created when participants terminate employment before becoming entitled to their full benefits under the Plan, may be allocated to reduce employer contributions or pay Plan expenses, and may be allocated as additional employer contributions. At December 31, 2024 and 2023, the balance in the forfeited non-vested account was \$16,891 and \$175,828, respectively. During the years ended December 31, 2024 and 2023, \$235,382 and \$19,434, respectively, were used to reduce employer contributions or allocated as additional contributions. During 2024 and 2023, forfeitures of \$17,200 and \$15,900, respectively, were used to pay Plan expenses.

Vesting – Participants are immediately vested in their contributions plus actual earnings thereon. A participant is fully vested in the Company's contributions upon death, disability, normal or early retirement age, or after three years of credited service, according to the following schedule:

For purposes of determining years of vesting service, a participant will be credited for hours of service with certain predecessor employers as defined in the Plan agreement.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may not take out more than one (1) loan at one time. Loan terms range from one to five years or longer for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the prime lending rate plus 1%. Prior to January 1, 2021, loans bore interest at a reasonable rate as established by the plan administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits – On termination of service, a participant is entitled to receive the vested balance in their account. Benefits are payable in a lump-sum distribution. The plan administrator may elect to authorize an automatic lump-sum distribution or rollover for terminated participants whose vested account balances are less than \$5,000. Terminated participants who have reached normal retirement age whose account balances are greater than \$5,000 may have their account balances distributed without consent unless an affirmative election is made to postpone the distribution. Participants may also receive certain in-service distributions upon attainment of age 59½, or for other reasons in accordance with the Plan documents. The Plan permits hardship distributions to current participants.

Amounts allocated to accounts of persons who, at December 31, 2024 and 2023, have elected to withdraw from the Plan but have not been paid were \$-0- and \$36,219, respectively.

Plan Expenses – The Company pays certain expenses of maintaining the Plan; therefore, they are not reflected in the accompanying financial statements. Investment expenses are deducted and reflected in the calculation of the unit value of investments.

2. Summary of Significant Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Use of Estimates – The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value (except for the fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurements. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. See Note 4 for a discussion of the investment contract with an insurance company at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Net appreciation (depreciation) in fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

The Plan’s custodian and trustees determine the Plan’s investment policies utilizing information provided by the third-party administrators and the insurance company.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related administrative expenses are recorded when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits – Benefits are recorded when paid.

3. Information Certified by Custodian

Certain information related to investments included in the Plan’s financial statements and ERISA-required supplemental schedules, was obtained or derived from information prepared by Empower Trust Company, LLC and Empower Life & Annuity Insurance Company (collectively, “Empower”), the custodian of the Plan, and furnished to the plan administrator. Plan management has obtained certifications from the custodian, that such information is complete and accurate. The certifications, referred to above, apply to the Plan’s investment balances and notes receivable from participants as of December 31, 2024 and 2023 and the related activity for the years then ended.

4. Investment Contract with Insurance Company

The Plan has a fully benefit-responsive investment contract with Empower, which includes an investment option in the EI Fixed Account – Series Class I. Empower maintains the amounts allocated to the contract in a general account. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed. The crediting interest rate is determined on a quarterly basis, as designated by Empower.

The contract meets the fully benefit-responsive investment contract criteria for participant-initiated transactions and therefore is reported, and included in the accompanying financial statements at contract value. Contract value, as reported to the Plan by Empower represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

There are no reserves against contract value for credit risk of the contract issuers or otherwise. The contract value of the guaranteed contract at December 31, 2024 and 2023 was \$935,480 and \$1,354,526, respectively.

Certain events limit the ability of the Plan to transact at contract value with Empower. Such events include, but are not limited to: (1) amendments to the Plan agreement (including complete or partial Plan termination or merger with another Plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, (5) or premature termination of the contract. The plan administrator believes that no events are probable of occurring that might limit the ability of the Plan to transact at contract value with Empower and that would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the Empower contract with the Plan and settle at an amount different from the contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

The guaranteed contract does not permit Empower or the Plan to terminate the agreement prior to the scheduled maturity date.

5. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access;

Level 2: Inputs other than quoted prices that are observable for the assets or liabilities, either directly or indirectly. These include quoted prices for similar assets or liabilities in active markets and quoted prices for identical or similar assets or liabilities in inactive markets;

Level 3: Unobservable inputs that reflect the reporting entity's own assumptions and are significant to the fair value measurement.

- (a) In accordance with Accounting Standards Codification (“ASC”) Subtopic 820-10, certain investments that were measured at Net Asset Value (“NAV”) per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statement of net assets available for benefits.

The asset or liability’s fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price reported by the fund. The funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value, and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Common Collective Trust Fund: The common collective trust fund is valued using the NAV as a practical expedient as determined by the issuer based on the fair value of the underlying assets within the fund.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investments Measured at NAV – The following table summarizes investments measured at fair value based on the NAV per share practical expedient as of December 31, 2024. Participant redemption restrictions may be imposed for these investments; the redemption notice period is applicable to the Plan.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

7. Tax Status

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the restated Plan, as evidenced by a prototype document, and the related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Related-Party and Party in Interest Transactions

Certain Plan investments are investments managed by the custodian of the Plan; therefore, these transactions qualified as party in interest transactions. Additionally, notes receivable from participants and fees incurred by the Plan and paid to Empower and third-party service providers also qualify as party in interest transactions. These party in interest transactions are exempt from the prohibited transaction rules of ERISA.

The Plan sponsor failed to remit certain participant contributions and loan repayments in a timely manner for certain periods during 2021, 2022, and 2023 as required by Department of Labor (“DOL”) Regulation 2510.3-102 and are considered prohibited transactions. As of December 31, 2024 and 2023, there were no contributions pending full correction outside of the Voluntary Fiduciary Correction Program (“VFCP”). Contributions pending correction in the VFCP as of December 31, 2024 and 2023 totaled \$124,692. The Plan sponsor is working to expedite the process to ensure the Plan is in full compliance with DOL regulations.

9. Risk and Uncertainties

The Plan invests in various investment instruments. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment instruments, it is at least reasonably possible that changes in the value of investment instruments will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

10. Subsequent Events

Subsequent events are defined as events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are issued or are available to be issued. Management has evaluated subsequent events through September 19, 2025, the date that the financial statements were available to be issued and determined that there have been no events that have occurred that would require adjustments to the financial statements.

Subsequent to the year end, the Plan changed its third-party administrator from DWC to Empower. This change does not affect the accompanying financial statements. In addition, effective May 15, 2025, the Plan was amended to implement certain provisions of the Setting Every Community up for Retirement Enhancement (“SECURE”) Act and other law changes, including, among other things, an increase in the mandatory cash-out limit from \$5,000 to \$7,000, an increase in the age for required minimum distributions to age 72, and certain changes to eligibility provisions for long-term part-time employees.
