### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements**

We have performed an audit of the financial statements of Storey-Kenworthy Company 401(k) Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements (2024 Financial Statements).

As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **NOTE 1 — DESCRIPTION OF THE PLAN**

The following description of the Storey-Kenworthy Company 401(k) Profit Sharing Plan and Trust (Plan) provides only general information. Participants should refer to the Plan agreement (Agreement) for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering substantially all employees of Storey-Kenworthy Company (the Company) who have completed 30 days of service to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Plan Administration**

The Company has contracted Principal Trust Company (Principal) to hold the Plan's assets, execute investment transactions, perform allocations of contributions and investment earnings, and make benefit payments.

#### **Contributions**

The Plan allows for employee contributions up to 100% of pay, subject to certain Internal Revenue Code (IRC) limitations. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 6% of eligible compensation. Participants also have the option to contribute post-tax compensation through Roth 401(k) contributions. The Plan provides for a discretionary Company match. The Company made discretionary matching contributions of 50% of the participant's contribution, up to 6% of their gross pay. The Company may also make discretionary contributions from time to time. For the years ended December 31, 2024 and 2023, the Company made additional discretionary contributions of 5% of participant's eligible wages, regardless of participant contributions.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, an allocation of the Company's contribution and Plan earnings. Plan expenses are netted against the Plan earnings of the participants. Allocations of the Company's contribution and Plan earnings and expenses are based upon participant contributions, compensation, and account balance, as defined in the Agreement.

#### **Vesting**

All participants are 100% vested in their contributions and allocated Plan earnings. Participants become vested in the Company-matching and discretionary contributions and allocated Plan earnings on a schedule beginning after two years of service, as defined in the agreement. The initial vesting percentage is 20%, increasing by 20% annually, until becoming fully vested after six years of vesting service, as defined in the Agreement. Participants are considered 100% vested if they reach the age of fifty-five, become totally disabled as defined in the Agreement, or die, while participating in the Plan.

### **NOTE 1 — DESCRIPTION OF THE PLAN (Continued)**

#### **Notes Receivable from Participants**

Participants are permitted to borrow from their fund accounts a minimum of \$1,000 up to a maximum of 50% of their account balance or \$50,000, whichever is less. Principal and interest are paid ratably through payroll deductions. The loans are secured by the balance in the participant's account and must bear a reasonable rate of interest.

#### **Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant (or participant's beneficiary in the event of death) may elect to receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution as described in the Agreement. In addition, hardship distributions are permitted if certain criteria are met.

#### **Forfeitures**

Forfeited accounts are used to offset the Company's future matching contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$17,115 and \$1,667, respectively. Forfeitures of \$69,987 and \$83,593 were utilized to offset Company contributions for 2024 and 2023, respectively.

#### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to terminate the Plan subject to the provisions of ERISA. In the event that the Plan terminates, the accrued benefits of all participants shall be distributed to participants as provided in the Agreement.

### **NOTE 2 — SIGNIFICANT ACCOUNTING POLICIES**

#### **Basis of Accounting**

The accompanying financial statements have been prepared on an accrual basis, in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### **Use of Estimates**

The preparation of the financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

#### **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is, at least, reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **NOTE 2 — SIGNIFICANT ACCOUNTING POLICIES (Continued)**

#### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note 4 for discussions of the fair value measurements. The Plan's guaranteed interest accounts are not considered benefit responsive and are held in the general account of Principal. Because the accounts are not benefit responsive, fair value is the appropriate measurement for financial statement purposes. See Note 5 for further information related to the guaranteed interest accounts.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is reported on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

#### **Contributions**

Contributions from the Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

#### **Administrative Expenses**

Certain expenses incurred in connection with the general administration of the Plan are paid by the Plan and are recorded in the accompanying statements of changes in net assets available for benefits as administrative expenses. Other expenses related to the Plan are paid by the Company. Certain investment-related expenses are included within net appreciation in fair value of investments.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Reclassifications**

Certain amounts in the December 31, 2023 financial statements have been reclassified to conform to the current year presentation.

### NOTE 4 — FAIR VALUE MEASUREMENTS

GAAP establishes a three-tier fair value hierarchy, which categorizes the inputs used in measuring fair value. These categories include (in descending order of priority): Level 1, defined as observable inputs such as quoted prices in active markets for identical assets; Level 2, defined as inputs other than quoted prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore requiring the Plan to develop its own assumptions. The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Pooled separate accounts:* The fair values of units held in pooled separate accounts are valued based on quoted redemption values, also known as net asset value (NAV), determined by using available market information and appropriate valuation methods, as provided by Principal and represent the value at which the Plan (or the participant) could initiate a transaction with Principal. There are no imposed redemption restrictions on participants, except for certain short-term trading restrictions, which prohibit participants from reinvesting into the same account within 30 days. Other than the U.S. Property Separate Account, there are no limitations on redemptions.

The NAV of the Principal U.S. Property Separate Account is based on the underlying real estate assets, which are valued using discounted cash flow valuation models that utilize public real estate market data such as: transaction prices, market rents, vacancy levels, leasing absorption, market cap rates and discount rates. In addition, each property is appraised annually by an independent appraiser. Principal has the ability to apply a contractual limitation, which delays the payment of withdrawal requests (Withdrawal Limitation). At December 31, 2024 and 2023, the Withdrawal Limitation was in effect; and, the Plan had outstanding distribution requests of \$428,000 and \$0, respectively.

- *Common collective trusts:* The fair value of units held in the collective trust fund are valued based on quoted redemption values, also known as NAV, determined by using available market information and appropriate valuation methods, as provided by Principal and represent the value at which the Plan (or participant) could initiate a transaction with Principal.
- *Mutual funds:* Valued based on quoted prices of identical assets in active markets.
- *Guaranteed interest accounts:* Valued at the amount participants would receive currently for a withdrawal for an event other than death, disability, termination, or retirement based on current market interest rates as estimated by Principal. This fair value represents contract value adjusted to reflect current market interest rates only to the extent such market rates exceed contract crediting rates. Contract value represents contributions made under the contract, plus interest at the contract rate, less funds used to pay Plan benefits and Principal's administrative expenses.

If the applicable interest rate is equal to or less than the interest rate on account, the fair value is equal to the contract value. If the applicable interest rate is greater than the interest rate on the account, the fair value is the contract value reduced by a percentage. This percentage is equal to the difference between the applicable interest rate and the interest rate on account, multiplied by the number of years (including fractional parts of a year) until the maturity date.

### NOTE 5 — GUARANTEED INTEREST ACCOUNTS

The Plan's investments in guaranteed interest accounts are maintained in Principal's general account. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed interest accounts promise contract value for a benefit event (termination, death, disability and retirement). However, there is a possible surrender charge when funds are withdrawn prior to their maturity. Thus, the guaranteed interest accounts are not considered benefit responsive. Fair value is the amount that would be received were the funds to be withdrawn or transferred within the Plan prior to maturity. This fair value represents guaranteed interest account contract value adjusted to reflect current market interest rates only to the extent such market rates exceed crediting rates.

All withdrawals from the guaranteed interest accounts are made on a last-in, first-out basis at the lesser of contract or fair value. The guaranteed interest accounts are, therefore, included in the financial statements at fair value as reported to the Plan by Principal. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment is not materially different from its fair value.

**NOTE 6 — PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of separate accounts and general insurance account of Principal's affiliate. Additionally, certain Plan investments are common collective trust investments managed by Principal. Principal is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments. Principal also charged administrative fees of \$106,058 and \$97,542 for the years ending December 31, 2024 and 2023, respectively.

**NOTE 7 — INCOME TAX STATUS**

The Plan uses a prototype plan document sponsored by Principal. Principal received a letter from the Internal Revenue Service (IRS), dated June 30, 2020, which states that the prototype plan document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

GAAP requires the Company to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Company has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there have been no uncertain positions taken.
