We have performed the audit of the financial statements of Titmouse, Inc. 401(k) Profit Sharing Plan & Trust ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

### 1. Description of the Plan

The following description of the Titmouse, Inc. 401(k) Profit Sharing Plan & Trust (the “Plan”) provides only general information. Participants and all others should refer to the Plan document or adoption agreement for a more complete description of the Plan’s provisions.

#### *General*

The Plan, adopted on January 1, 2010, is a defined contribution plan sponsored by Titmouse, Inc. (the “Company”) to provide employees with an opportunity to accumulate funds for their retirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”), and certain provisions of the Internal Revenue Code (“IRC”). The Company’s Vice President and Co-Founder serves as the Plan’s Trustee.

#### *Eligibility*

Substantially all full-time employees of the Company who complete two consecutive months of service and are age twenty-one or older are eligible to participate in the Plan upon meeting eligibility requirements. See Note 10. Excluded employees include union employees and non-resident aliens.

#### *Contributions*

Participants may contribute up to 92% of annual compensation as pre-tax or Roth contributions, as defined in the Plan. Participants may also rollover amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company makes safe harbor matching contributions in an amount equal to 100% of each contributing participant’s elective deferrals that does not exceed 3% of annual compensation, plus 50% of each contributing participant’s elective deferrals that exceeds 3% but does not exceed 5% of annual compensation. Additionally, the Plan allows for discretionary profit-sharing and/or qualified non-elective contributions (“QNEC”). There were no discretionary contributions made by the Company for the year ended December 31, 2024. Contributions are subject to certain IRC limitations.

#### *Participant investment account options*

Participants direct the investment of their contributions into a variety of mutual funds and a common collective trust fund as investment options offered for participants.

### *Allocations*

Each participant's account is credited with the participant's contributions, Company contributions and Plan earnings or losses. Participant's accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### *Vesting*

Participants immediately 100% vest in their contributions plus actual earnings thereon. Participants also immediately 100% vest in the Company's safe harbor matching, discretionary and QNEC contributions plus actual earnings thereon.

### *Notes receivable from participants*

Participants may borrow from their account up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable from participants are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates at the time the note receivable originates. Note repayment periods may not exceed five years except for notes used to acquire a principal residence, which have a maximum repayment period of ten years. Principal and interest are paid ratably through weekly payroll deductions. A note receivable is deemed in default if it is not repaid according to the terms of the note agreement. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

### *Benefit payments*

Benefits to participants or their beneficiaries generally are payable as a lump sum, installments or partial payments equal to the value of their vested account balance upon retirement, disability, death or termination of the participant. Additionally, participants may request in-service withdrawals upon attainment of age 59½ or upon incurring a financial hardship, as defined in the Plan document, if certain criteria are met. Benefits are recorded when paid.

### *Forfeitures*

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$11,120 and \$13,999, respectively. These accounts will be used to reduce future employer contributions. During 2024, there were no forfeited amounts from nonvested participant accounts and none were used to reduce employer contributions.

### 2. Summary of Significant Accounting Policies

#### *Basis of accounting*

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

#### *Use of estimates*

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

#### *Investment valuation and income recognition*

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or would be paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *Notes receivable from participants*

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

#### *Administrative expenses*

Certain expenses of the Plan are paid by the Company and are not included in the statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

### 3. Information Prepared and Certified by the Custodians

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company held the Plan's investment assets and executed investment transactions from January 1, 2023 through March 11, 2024 and Empower Trust Company, LLC held the Plan's investment assets and executed investment transactions from March 12, 2024 to December 31, 2024. The Plan's custodians have certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments:

- Investments at fair value
- Investments at net asset value
- Notes receivable from participants
- Net appreciation in fair value of investments
- Dividends
- Interest income on notes receivable from participants
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

### 4. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

### 4. Fair Value Measurement, Cont'd

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust fund:* Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

### 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of such termination, the Plan document provides that participants would become fully vested in their accounts.

### 6. Tax Status

The Internal Revenue Service (“IRS”) has determined and informed the Plan Administrator by letter dated June 30, 2020, that the Non-Standardized Prototype Volume Submitter 401(k) Profit Sharing Plan and the related trust, sponsored by Pentegra Services, Inc., are designed in accordance with the applicable sections of the IRC.

### 6. Tax Status, Cont'd

Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires management of the Plan to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 7. Party-In-Interest Transactions

Certain officers of the Company and the Trustee are current participants in the Plan. The Plan has notes receivable from certain of its participants. The Plan paid certain expenses related to the Plan's operations and investment activity to service providers, including Pentegra Services, Inc. and Empower Retirement, LLC, the Plan's record-keepers during 2024. These transactions qualify as party-in-interest transactions that are exempt from prohibited transaction rules.

### 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' accounts balances and the amounts reported in the statements of net assets available for benefits.

At December 31, 2024 and 2023, approximately 16% and 14% of the Plan's investments were invested in the American Funds Target Date Retirement 2045 R6 Fund, respectively.

At December 31, 2024 and 2023, approximately 15% and 14% of the Plan's investments were invested in the American Funds Target Date Retirement 2060 R6 Fund, respectively.

### 9. Reconciliation of Financial Statements to Schedule H of Form 5500

Net assets available for benefits and the net increase in net assets available for benefits, as reported in the accompanying financial statements, are consistent with amounts reported in Schedule H of Form 5500.

### 10. Subsequent Events

Effective February 6, 2025, the Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions are invested in a designated balanced fund until changed by the participant. The automatic deferral percentage will increase by 1% per year, up to a maximum of 10% of eligible compensation.

The Plan has evaluated subsequent events through September 30, 2025, which is the date the financial statements were available to be issued. No other significant matters were identified for disclosure during this evaluation.
