#### NOTE 1 - DESCRIPTION OF PLAN

The following description of Brady Services Holdings, Inc. (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan established August 1, 1995. All employees of Brady Services Holdings, Inc., and participating affiliates, as defined in the Plan, (the "Company" and "Plan Sponsor") who have completed one month of service, as defined by the Plan, and are age 18 or older are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan administrator is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan management.

#### **Contributions**

Each year, participants may contribute up to 90% of pretax annual compensation, as defined by the Plan, up to the maximum amount allowed by law. Participants may also make qualified Roth contributions to the Plan and may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Eligible participants are automatically enrolled at 1% of eligible wages unless they elect otherwise. The Plan provides for automatic increase of deferrals by 1% on the second payroll of each year up to 10% of eligible compensation. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may elect a separate deferral election for bonus compensation. Participants direct the investment of all contributions into various investment options offered by the Plan.

The Company makes a non-discretionary matching contribution equal to 100% of an employee's deferrals up to 5% of the employee's compensation. Employees must complete one month of service and be at least 18 years of age to be eligible for the Company's non-discretionary match. Additional profit sharing amounts may be contributed at the option of the Company's Board of Directors. There was no discretionary profit sharing employer contributions in 2024. Participants must earn at least 1,000 hours of service during the Plan year and be employed as of the last day of the Plan year to be eligible for the discretionary profit sharing employer contribution. Contributions are subject to annual limits established by the Internal Revenue Service.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, including amounts rolled over from other qualified plans, the Companies' matching contributions, and the Companies' discretionary profit sharing employer contributions, as well as allocations of Plan earnings. Allocations are based on the participant's plan compensation or participant account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### NOTE 1 - DESCRIPTION OF PLAN (Continued)

##### **Vesting**

Participants are vested immediately in their contributions, including amounts rolled over from other qualified plans, and actual earnings thereon. Vesting in the Companies' contribution portion of their accounts is based on years of continuous service. For participants with at least one hour of service on or after January 1, 2007, employer contributions vest at 20% annually after one year of service. Participants are fully vested after six years of service.

For participants with no service on or after January 1, 2007, employer contributions vest at 20% annually after two years of service and are fully vested after seven years of service.

Participants automatically become 100% vested upon attainment of normal retirement age or retirement due to disability or death, as defined by the Plan.

##### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may have one outstanding loan at a time. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 2%, at the time of issuance, which is commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest are paid ratably through regular payroll deductions.

##### **Payment of Benefits**

On termination of service due to death, disability, or retirement, or any other reason, a participant or their beneficiary may elect to receive a lump sum amount, installment payments or an annuity equal to the vested portion of the value of the funds credited to the participant's account. Postponed distributions are permitted for the following employer contribution sources: discretionary employer matching contribution, non-elective employer contribution (frozen pension source), profit sharing contribution, termed (PPA) MPP contribution and termed (PPA) PS contribution. Under the postponed distribution provision, distributions can be made in the Plan year following the Plan year in which the participant's employment with the employer is terminated. Effective September 5, 2014, the postponed distribution provision was amended to exempt participants who have reached normal retirement age.

Upon reaching age 59½ or becoming disabled, participants who are still employed may elect to receive a lump-sum amount of their vested account balances. In addition, participants can withdraw funds attributable to participant contribution balances through the use of a hardship distribution under qualified circumstances. The Plan includes a small balance terminated account sweep of distributions for accounts \$5,000 and less.

##### **Forfeited Accounts**

Forfeited nonvested accounts totaled \$65,310 and \$17,856 as of December 31, 2024 and 2023 respectively. These accounts may be used to pay administrative expenses and to reduce future Company contributions. During 2024, \$92,937 of forfeitures were used by the Company to reduce Company contributions.

#### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by investment advisers, custodians and trustee. See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

##### **Contributions**

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

##### **Payment of Benefits**

Benefits are recorded when paid.

##### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation or depreciation of fair value of investments in accordance with Plan provisions. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses.

##### **Administrative Expenses (Continued)**

Expenses not paid by the Company are paid using the Plan's assets and will generally be allocated among the accounts of all participants in the Plan. These expenses will be allocated either proportionately based on the value of the account balances or as an equal dollar amount based on the number of participants in the Plan. The method of allocating the expenses depends on the nature of the expense itself.

##### **Subsequent Events**

The Plan has evaluated events and transactions for potential recognition or disclosure through September 25, 2025, which is the date the financial statements were issued.

#### NOTE 3 - INFORMATION CERTIFIED BY A QUALIFIED INSTITUTION (Unaudited)

Certain information related to investments from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivables from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Fidelity Management Trust Company.

#### NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 - *Fair Value Measurement* are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

## NOTE 4 - FAIR VALUE MEASUREMENTS (Continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Stable value collective trust fund:* A stable value fund that is composed primarily of benefit-responsive investment contracts that is valued using the NAV, is provided by the administrator of the trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Common collective trust fund:* A common collective trust fund that is composed primarily of benefit-responsive investment contracts that is valued using the NAV, is provided by the administrator of the trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

#### NOTE 6 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of the stable value collective trust and mutual funds sponsored by Fidelity Management Trust Company, subsidiaries, and affiliated companies, therefore, these transactions qualify as party-in-interest transactions. The Plan receives revenue sharing payments from the mutual fund service providers, which offsets fees paid by the Plan. Fees in excess of the revenue sharing are allocated to participant accounts and expensed.

#### NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

#### NOTE 8 - TAX STATUS

The Plan is a prototype plan sponsored by FMR LLC. The Internal Revenue Service has issued an opinion letter dated June 30, 2020, that the prototype plan document was designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since adopting the prototype plan, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset, or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### NOTE 1 - DESCRIPTION OF PLAN

The following description of Brady Services Holdings, Inc. (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan established August 1, 1995. All employees of Brady Services Holdings, Inc., and participating affiliates, as defined in the Plan, (the "Company" and "Plan Sponsor") who have completed one month of service, as defined by the Plan, and are age 18 or older are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan administrator is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan management.

#### **Contributions**

Each year, participants may contribute up to 90% of pretax annual compensation, as defined by the Plan, up to the maximum amount allowed by law. Participants may also make qualified Roth contributions to the Plan and may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Eligible participants are automatically enrolled at 1% of eligible wages unless they elect otherwise. The Plan provides for automatic increase of deferrals by 1% on the second payroll of each year up to 10% of eligible compensation. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may elect a separate deferral election for bonus compensation. Participants direct the investment of all contributions into various investment options offered by the Plan.

The Company makes a non-discretionary matching contribution equal to 100% of an employee's deferrals up to 5% of the employee's compensation. Employees must complete one month of service and be at least 18 years of age to be eligible for the Company's non-discretionary match. Additional profit sharing amounts may be contributed at the option of the Company's Board of Directors. There was no discretionary profit sharing employer contributions in 2024. Participants must earn at least 1,000 hours of service during the Plan year and be employed as of the last day of the Plan year to be eligible for the discretionary profit sharing employer contribution. Contributions are subject to annual limits established by the Internal Revenue Service.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, including amounts rolled over from other qualified plans, the Companies' matching contributions, and the Companies' discretionary profit sharing employer contributions, as well as allocations of Plan earnings. Allocations are based on the participant's plan compensation or participant account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### NOTE 1 - DESCRIPTION OF PLAN (Continued)

##### **Vesting**

Participants are vested immediately in their contributions, including amounts rolled over from other qualified plans, and actual earnings thereon. Vesting in the Companies' contribution portion of their accounts is based on years of continuous service. For participants with at least one hour of service on or after January 1, 2007, employer contributions vest at 20% annually after one year of service. Participants are fully vested after six years of service.

For participants with no service on or after January 1, 2007, employer contributions vest at 20% annually after two years of service and are fully vested after seven years of service.

Participants automatically become 100% vested upon attainment of normal retirement age or retirement due to disability or death, as defined by the Plan.

##### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may have one outstanding loan at a time. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 2%, at the time of issuance, which is commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest are paid ratably through regular payroll deductions.

##### **Payment of Benefits**

On termination of service due to death, disability, or retirement, or any other reason, a participant or their beneficiary may elect to receive a lump sum amount, installment payments or an annuity equal to the vested portion of the value of the funds credited to the participant's account. Postponed distributions are permitted for the following employer contribution sources: discretionary employer matching contribution, non-elective employer contribution (frozen pension source), profit sharing contribution, termed (PPA) MPP contribution and termed (PPA) PS contribution. Under the postponed distribution provision, distributions can be made in the Plan year following the Plan year in which the participant's employment with the employer is terminated. Effective September 5, 2014, the postponed distribution provision was amended to exempt participants who have reached normal retirement age.

Upon reaching age 59½ or becoming disabled, participants who are still employed may elect to receive a lump-sum amount of their vested account balances. In addition, participants can withdraw funds attributable to participant contribution balances through the use of a hardship distribution under qualified circumstances. The Plan includes a small balance terminated account sweep of distributions for accounts \$5,000 and less.

##### **Forfeited Accounts**

Forfeited nonvested accounts totaled \$65,310 and \$17,856 as of December 31, 2024 and 2023 respectively. These accounts may be used to pay administrative expenses and to reduce future Company contributions. During 2024, \$92,937 of forfeitures were used by the Company to reduce Company contributions.

#### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by investment advisers, custodians and trustee. See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

##### **Contributions**

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

##### **Payment of Benefits**

Benefits are recorded when paid.

##### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation or depreciation of fair value of investments in accordance with Plan provisions. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses.

##### **Administrative Expenses (Continued)**

Expenses not paid by the Company are paid using the Plan's assets and will generally be allocated among the accounts of all participants in the Plan. These expenses will be allocated either proportionately based on the value of the account balances or as an equal dollar amount based on the number of participants in the Plan. The method of allocating the expenses depends on the nature of the expense itself.

##### **Subsequent Events**

The Plan has evaluated events and transactions for potential recognition or disclosure through September 25, 2025, which is the date the financial statements were issued.

#### NOTE 3 - INFORMATION CERTIFIED BY A QUALIFIED INSTITUTION (Unaudited)

Certain information related to investments from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivables from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Fidelity Management Trust Company.

#### NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 - *Fair Value Measurement* are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

## NOTE 4 - FAIR VALUE MEASUREMENTS (Continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Stable value collective trust fund:* A stable value fund that is composed primarily of benefit-responsive investment contracts that is valued using the NAV, is provided by the administrator of the trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Common collective trust fund:* A common collective trust fund that is composed primarily of benefit-responsive investment contracts that is valued using the NAV, is provided by the administrator of the trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

#### NOTE 6 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of the stable value collective trust and mutual funds sponsored by Fidelity Management Trust Company, subsidiaries, and affiliated companies, therefore, these transactions qualify as party-in-interest transactions. The Plan receives revenue sharing payments from the mutual fund service providers, which offsets fees paid by the Plan. Fees in excess of the revenue sharing are allocated to participant accounts and expensed.

#### NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

#### NOTE 8 - TAX STATUS

The Plan is a prototype plan sponsored by FMR LLC. The Internal Revenue Service has issued an opinion letter dated June 30, 2020, that the prototype plan document was designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since adopting the prototype plan, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset, or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
