## NOTES TO FINANCIAL STATEMENTS

December 31, 2024 And 2023

### 1. Description Of The Plan

The following description of Martin Energy Services Group 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan established and sponsored by Martin Energy Services Group (the Company or Plan Sponsor). The Plan was established effective August 1, 2016.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### Eligibility

All employees of the Company, except employees covered by a collective bargaining agreement, nonresident aliens, and leased employees, who are age 18 or older and have completed 60 consecutive days of service are eligible to make effective deferral contributions and share in the allocation of Company contributions. Employees can begin participating immediately upon satisfying the eligibility requirements.

#### Contributions

Participants may contribute a dollar amount or percentage of their eligible compensation, as defined in the Plan Document, in the form of pre-tax deferrals, Roth contributions or a combination thereof. In addition, participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Company provides a discretionary matching contribution. For the years ended December 31, 2024 and 2023, the Company contributed 50% of the first 6% of eligible compensation that a participant contributes to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

The Company also provides for a discretionary profit sharing contribution. There were no discretionary profit sharing contributions in 2024 or 2023.

Participants direct the investment of all contributions into various investment options offered by the Plan. Participants may change their investment elections or future contributions or balances at any time during the year.

### Notes To Financial Statements (*Continued*)

#### **Forfeitures**

Forfeitures of nonvested participant balances may be used to pay Plan expenses or offset future Company discretionary matching and profit sharing contributions. There were no forfeitures used during the years ended December 31, 2024 and 2023. Forfeited amounts available for future use amounted to \$51,351 and \$22,770 as of December 31, 2024 and 2023, respectively.

#### **Vesting**

Participants are immediately vested in their contributions, plus actual earnings thereon. For the Company's matching and profit sharing contributions, a participant is 20% vested after two years of credited service, increasing 20% each year to 100% after six years of credited service. Participants also become 100% vested upon death or becoming disabled.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, Company contributions and an allocation of Plan earnings. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Payment Of Benefits**

Upon termination of services, death, disability, or retirement, a participant or beneficiary may elect to receive either a lump sum amount equal to the value of the participant's vested interest in their account or a partial payment from the participant's vested interest in their account.

#### **In-Service Withdrawals**

A participant may also elect to receive an in-service distribution of all or part of their vested interest in his or her account upon attaining age 59 ½ or reaching normal retirement age.

Active participants who experience a qualifying hardship may withdraw all or part of their vested account attributable to elective deferrals. Hardship withdrawals will be approved only if they conform to Plan and established IRS safe harbor provisions.

#### **Administrative Expenses**

Salaries and related benefits of the employees who administer the Plan are provided by the Company. Fees related to the administration of benefit payments are charged directly to participants. Investment-related expenses are included in the net change in fair value of investments. Significant administrative expenses of the Plan are paid by the Company. These amounts are not reflected in the financial statements.

## **2. Summary Of Significant Accounting Policies**

#### **Basis Of Accounting**

The financial statements of the Plan have been prepared on the accrual basis of accounting.

#### **Estimates And Assumptions**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

#### **Investment Valuation And Income Recognition**

The Plan's investments, other than fully benefit-responsive investment contracts, are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividends are recorded on the ex-dividend date. The net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment contracts held by a defined contribution plan that are fully benefit-responsive are reported at contract value, rather than fair value, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's investment in the Standard Stable Asset Fund is a fully benefit-responsive investment contract and is reported at contract value in the statement of net assets available for benefits.

#### Payment Of Benefits

Benefits are recorded when paid.

#### Subsequent Events

Management has evaluated subsequent events through the date the financial statements were available for issue, which is the Independent Auditors' Report date.

### 3. Certified Investment Information

As described in Note 2, because the Contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by The Standard, represents contributions made under the Contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Contract permits the Company or The Standard to terminate the Contract within 30 days of receiving notification. The crediting interest rate ranged from 3.00% to 3.10% during the year ended December 31, 2024. The crediting interest rate ranged from 2.65% to 2.95% during the year ended December 31, 2023.

## 5. Fair Value Measurements

The Plan utilizes an established framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value:

#### **Mutual Funds**

Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The method described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### **7. Income Tax Status**

The Plan uses the non-standardized pre-approved profit sharing plan sponsored by Ascensus, Inc. Ascensus received a favorable IRS opinion letter dated June 30, 2020. The Plan itself has not received a determination letter and has not been amended since the date of the opinion letter. The Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code (IRC).

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **8. Party In Interest Transactions**

The Plan pays administrative fees to Ascensus for recordkeeping services. These transactions qualify as allowable party in interest transactions under ERISA.

### **9. Risks And Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
