Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Pulse Technologies 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of May 31, 2025 and December 31, 2024, and the related statement of changes in net assets available for benefits for the five months ended May 31, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Pulse Technologies 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Notes to the Financial Statements

Note 1: Description of Plan

The following description of the Pulse Technologies 401(k) Plan (the "Plan"), prior to its merger with the Integer 401(k) Plan, provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

Effective January 1, 2025, Pulse Technologies, Inc. elected to become a participating employer in the Integer 401(k) Plan. All employee and employer contributions will be contributed to the Integer 401(k) Plan on and after January 1, 2025. Effective February 19, 2025, the Pulse Technologies 401(k) Plan merged into the Integer 401(k) Plan and all plan assets were subsequently transferred.

Eligibility

The Plan was established July 1, 1997 and is sponsored by Pulse Technologies, Inc. The Plan is a defined contribution plan covering all employees. Employees are eligible to participate in salary deferral contributions after completing at least 60 days of service. Employees are automatically enrolled at 6% in salary deferral contributions after 60 days of service if no opt out election is made. Employees are eligible for matching and discretionary contributions after completing twelve months of consecutive service and having attained the age of 18. All employees meeting the eligibility requirements will be automatically enrolled in the Plan and must sign an opt out form if they do not wish to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may make elective salary deferral or Roth 401(k) contributions to the Plan, which are not to exceed the maximum amount allowed under the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Company contributes 10% of the amount of the salary deferral that each participant has elected to defer, limited to salary deferrals up to 6% of each participant's compensation.

The Plan includes an automatic salary deferral feature in which 6% of the participant's compensation will be automatically withheld and contributed to the Plan once the participant meets the eligibility requirements. A participant may elect not to participate in the Plan upon notification to the Plan Administrator.

Participant Accounts

Each participant's account is credited with the participant's contributions, employer contributions, and an allocation of Plan earnings or losses, expenses and the market value adjustments to Plan investments. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective deferrals, Roth elective deferrals, and any rollover contributions and earnings thereon. Vesting in employer contributions and earnings thereon is based on years of credited service. A participant is 100% vested, under a graduated vesting schedule, after six years of credited service, as defined.

Notes to the Financial Statements

Note 1: Description of Plan (Continued)

Notes Receivable From Participants

Participants may borrow a total of the lesser of 50% of their vested account balance (\$1,000 minimum) or \$50,000. A maximum of one outstanding loan is permitted. Loans provide for repayment over a period not to exceed five years unless such loan is used to purchase a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Participants' benefits under the Plan are payable to participants, or their beneficiaries, upon the termination of employment, normal retirement (the attainment of age 65), disability, death or financial hardship. In-service withdrawals are available to participants who have reached age 59-1/2 and are 100% vested in the account from which the distribution is made. Participants may withdraw their rollover accounts at any time. Benefits are payable in the form of lump-sum distributions.

Forfeitures

The portion of a participant's account balance which is not vested upon termination of employment will be forfeited and may be used in future periods to pay for employer contributions or administrative expenses.

Forfeitures amounting to \$- and \$13,322 at May 31, 2025, and December 31, 2024, respectively, were available for reduction of future employer contributions and administrative expenses. For the the five months ended May 31, 2025, the forfeited funds were not used to reduce plan expenses and the balances in the forfeiture accounts were transferred to the Integer 401(k) Plan.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States ("GAAP").

Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Note 2: Summary of Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of May 31, 2025, and December 31, 2024. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net appreciation (depreciation) in fair value of investments.

Subsequent Events

Subsequent events have been evaluated through September 25, 2025, the date that the financial statements were available to be issued.

Notes to the Financial Statements

Note 3: Information Prepared and Certified by the Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 31, 2024, and net appreciation (depreciation) in fair value of investments, interest and dividends for the five months ended May 31, 2025, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Matrix Trust Company.

Note 4: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 5: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Plan contributions. As disclosed in Note 1, the Plan merged with Integer 401(k) Plan during 2025.

Note 6: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

Note 7: Related-Party Transactions and Party-in-Interest Transactions

Certain plan investments are managed by Fulton Financial Advisor, a division of Fulton Bank N.A. Fulton Bank N.A. is the recordkeeper, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Direct fees incurred and paid by the Plan for investment management and recordkeeping services were \$10,818 for the five months ended May 31, 2025.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 8: Tax Status

The Plan adopted a nonstandard prototype document with an IRS notification letter which states the prototype plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

There is no schedule of assets held at the end of the year attached as this is a plan termination and there are no assets in the plan as of 5/31/2025.
