## Independent Auditor's Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Vanguard National Trailer, Inc. 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

#### Note 1. Plan Description

The following description of the Vanguard National Trailer, Inc. 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

**General:** The Plan was established on January 1, 2007, by Vanguard National Trailer Corporation (the Company), a wholly-owned subsidiary of Vanguard Global Trailer Holding, Inc. The Plan is a defined contribution plan covering substantially all employees of the Company. The Plan also includes certain employees from Vanguard Global Trailer Holding, Inc. and CIMC Reefer Trailer, Inc., a wholly-owned subsidiary of Vanguard Global Trailer Holding, Inc. Employees who are age 21 or older and have completed 90 days of service become eligible to make salary deferral contributions. An employee is automatically enrolled in the Plan on the first day of the quarter after which the eligibility requirements are met, unless the employee elected to opt out of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions:** Each participant may contribute a percentage of pre-tax annual compensation, as defined in the Plan, up to the maximum amount allowable by the Internal Revenue Service. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Upon eligibility, all participants who do not select their own contribution percentage or opt out of the Plan are automatically enrolled at the contribution rate of 3% until they elect otherwise. The contributions of participants automatically enrolled are invested in the respective lifetime fund that is closest to the anticipated retirement date of the participant. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may, at its discretion, make a matching contribution to the Plan. The Company's discretionary matching contributions provide for employer matching contributions equal to 50% of the first 6% of a participant's contribution. For the year ended December 31, 2024, the Company contributed approximately \$511,000 of matching funds to the Plan. Matching contributions are invested in a manner consistent with participant contributions and are subject to certain limitations.

Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

**Participant accounts:** Each participant's account is credited with the participant's contributions and an allocation of: (a) the Company's contribution, (b) Plan earnings and charged with an allocation of certain administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. Participants vest in contributions made by the Company at 33% after a year of service and become fully vested after three years of service. In case of death or disability, the participant is deemed to be 100% vested. Upon normal retirement age of 65, the participant is also considered 100% vested.

**Notes receivable from participants:** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as of the date of the note. Principal and interest is paid ratably through payroll deductions. A participant may only obtain one loan during each plan year and may have up to three loans outstanding at any one given time.

#### Note 1. Plan Description (Continued)

**Payment of benefits:** Upon termination of service, a participant may elect to receive either a lump-sum amount equal to the value of his or her account, equal installments over the beneficiary's life expectancy, or as an annuity contract as defined in the Plan. In addition, participants may make withdrawals of their vested account any time after reaching age 59½ or by determination that a financial hardship, as defined by the Plan Agreement, has been incurred. Benefits are recorded when paid.

**Hardship withdrawals:** Participants may request that all or a portion of their account be distributed in case of severe financial hardship, as defined in the Plan document. The Company must approve any such hardship withdrawals.

**Administrative expenses:** Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain administrative expenses are paid by the Company and, therefore, are not reflected in the Plan's financial statements.

**Forfeited accounts:** If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future Company contributions. Approximately \$75,000 of the forfeitures were used to offset employer matching contributions during the year ended December 31, 2024. Forfeited non-vested accounts at December 31, 2024 and 2023, were approximately \$8,000 and \$4,000 respectively.

#### Note 2. Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared under the accrual method of accounting in accordance with generally accepted accounting principles of the United States of America.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Participant notes receivable:** Participant notes receivable are recorded at their unpaid balances plus any accrued interest. For delinquent notes which have not been fully repaid by the end of its term, the outstanding balance will be treated as deemed distribution.

**Risks and uncertainties:** The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Investment valuation and income recognition:** Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See below for discussion of fair value measurements. See Note 5 for discussion on contract value investment.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Note 2. Significant Accounting Policies (Continued)

**Fair value measurements:** Accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

**Level 1:** Inputs to the valuation method are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation method include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation method are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation method used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Shares of mutual funds:** Valued at the quoted market price reported on the active market on which the individual securities are traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methods or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Subsequent events:** The Company has evaluated subsequent events for potential recognition and/or disclosure through September 29, 2025, the date the financial statements were available to be issued.

**Changes in fair value levels:** To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers into or out of Level 3 Investments.

#### **Note 5. Guaranteed Annuity Contract with Insurance Company**

The Plan has a benefit-responsive guaranteed investment contract with Empower Annuity Insurance Company of America. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by Empower. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Empower is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly or semi-annual basis for resetting.

Certain events may limit the ability of the Plan to currently transact at contract value and may result in a deferral of the payment at contract value for up to 12 months. Such events include but may not be limited to the following: (1) removal of a group of participants from Plan coverage as a result of temporary absence, change in position or other occurrence qualifying as a temporary break in service under the Plan; (2) transfer or other change of position resulting in employment by an entity controlling, controlled by, or under other common control with the Company; (3) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the Plan sponsor's business; (4) removal from the Plan of one or more groups or classifications of participants; (5) partial or complete Plan termination; or (6) Plan disqualification. The Plan Administrator does not believe that the occurrence of any events which would limit the Plan's ability to transact at contract value with participants is probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to 90 days' written notice.

#### **Note 6. Related-Party and Party-in-Interest Transactions**

Certain Plan assets are investments and a guaranteed annuity contract managed by Empower. Empower is the custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions as defined under ERISA guidelines. Administrative expenses presented on the statement of changes in net assets available for benefits totaling approximately \$104,000 were paid to the custodian for the year ended December 31, 2024.

#### **Note 7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

#### **Note 8. Income Tax Status and Uncertain Tax Positions**

The Plan has adopted a preapproved plan document sponsored by Empower Retirement, LLC that has received an opinion letter from the Internal Revenue Service (IRS) dated November 14, 2022, stating that the preapproved plan document was designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The plan document has been amended since receiving the preapproved opinion letter; however, the Plan Administrator believes that the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

#### **Note 8. Income Tax Status and Uncertain Tax Positions (Continued)**

The Plan's Administrator has evaluated the Plan's tax positions and concluded that the Plan has maintained its tax-exempt status and has taken no uncertain tax positions that require adjustment to the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state or local tax authorities for years before 2021.
