Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024 and Schedule of Delinquent Participant Contributions for the year ended December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTE 1. PLAN DESCRIPTION

The following description of Pankow Employees' Profit Sharing 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering employees of Charles Pankow Builders, Ltd. (the Company or Plan Sponsor), and includes employees of companies under common control of the Company. Employees become eligible to participate in the Plan on the first day of the month coinciding with or next following their date of hire. All employees of the Company, other than non-resident aliens, college interns, leased employees, employees employed in a seasonal job classification, employees covered by a collective bargaining agreement, are eligible to participate in the Plan.

The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (IRC). Additionally, the Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant Accounts and Contributions: Participants may contribute an amount not less than 1% but not more than 90% of their compensation as pre-tax, after-tax and/or Roth contributions. Total participant contributions are subject to annual limits under the IRC. The Plan provides for automatic enrollments with initial deferral contributions equal to 6% of compensation (increasing each year by 1% until a deferral percentage of 10% is reached). Participants may elect a different percentage or elect not to make deferral contributions to the Plan. The maximum participant deferral limit was \$23,000 for the year ended December 31, 2024. Catch up contributions of \$7,500 were available to participants who had attained age 50 or older by December 31, 2024 and had not exceeded the contribution limit for the Plan year. Participants may also make rollover contributions from other qualified plans.

The Company may make annual discretionary profit-sharing contributions to the Plan, which are to be allocated to participants employed on the last day of the Plan year, on the basis of their relative compensation to the total compensation of all eligible participants. The Company made no discretionary profit-sharing contribution for the year ended December 31, 2024.

The Plan provides for Company Safe Harbor matching contributions. For the year ended December 31, 2024, the Company matched 100% of deferral contributions on the initial 1% of compensation, plus 50% of deferral contributions over 1% up to 6% of compensation. Safe harbor matching contributions were \$674,529. The Plan also has an annual true-up provision for matching contributions, which amounted to \$69,018 for the year ended December 31, 2024, all of which was funded by forfeitures.

Each participant's account is credited or charged with the participant's contributions, an allocation of the Company's Safe Harbor matching, profit sharing, and true-up contributions, investment income or losses and administrative expenses.

Vesting: Participants are immediately vested in their voluntary contributions and Company Safe Harbor matching contributions plus actual earnings thereon. Vesting in Company discretionary profit sharing contributions is based on years of continuous service. A participant is 20% vested in Company discretionary profit-sharing contributions after two years of service and continues to vest 20% per year thereafter and are fully vested after six years of service.

Notwithstanding the above, if a participant (1) attains the age of 65, (2) dies or (3) terminates employment by reason of permanent disability, the Company discretionary profit sharing contributions amounts become 100% vested without regard to years of service.

Benefit Payments: Distributions of a participant's account can be made upon termination of service, death, disability, or retirement. Distributions are made in a lump-sum payment. If a participant's vested account is greater than \$1,000 but less than \$5,000, and the participant does not elect to have the amount rolled over into a specific retirement account or to receive a distribution directly, such account will be rolled over to an Individual Retirement Account ("IRA") with a provider chosen by the Plan Administrator. An in-service distribution can also be made to participants who have attained the age of 59-1/2, upon disability or when experiencing financial hardship, subject to approval by the Plan Administrator.

Administrative Expenses: The Plan is responsible for payment of trustee expenses. However, the Company may also pay Plan expenses directly. Administrative expenses charged to the Plan consist of charges associated with trustee fees, investment transactions, benefit payments and loan processing.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Notes Receivable from Participants: Participants may borrow from their vested accounts up to a maximum amount equal to the lesser of \$50,000 or 50% of the participant's vested balance. The notes receivable from participants are secured by the vested balance in the participant's account and bear interest at the Prime rate, as published in the Wall Street Journal, plus 1%. Principal and interest are paid ratably through payroll deductions or participant's own personal funds over a term not to exceed five years, except for notes receivable used to purchase a participant's primary residence, which has a repayment term not to exceed 10 years.

Forfeitures: Forfeitures of terminated participants' unvested amounts may be used to reduce future Company contributions to the Plan or to pay administrative expenses. Forfeitures applied to Company contributions and administrative expenses for the year ended December 31, 2024 was approximately \$113,000. Forfeitures available for future use at December 31, 2024 were approximately \$12,000.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The accompanying financial statements have been prepared using the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Contribution Receivable: The employee and related employer contributions are recognized in the period the employee contribution is withheld.

Valuation of Investments and Income (Loss) Recognition: Investments are valued at quoted market prices. Realized and unrealized appreciation (depreciation) is based on the market value of the assets at the end of the Plan year compared to the market value of the assets at the beginning of the Plan year, or at the time the assets are purchased or exchanged during the Plan year.

Valuation of Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balances plus accrued but unpaid interest.

Benefit Payments: Benefits are recorded when paid.

NOTE 3. CERTIFIED INFORMATION

The Plan Administrator has elected the method of compliance permitted by Section 29 CFR 2520.103-8 of the Department of Labor (DOL)'s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the financial information included in the Plan's financial statements as it relates to investment assets, investment transactions, investment income, notes receivable from participants and the schedule of assets held at end of year have been derived from information certified as complete and accurate by Fidelity Management Trust Company (Fidelity), the trustee of the Plan, in accordance with Section 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 4. INCOME TAX STATUS

The Plan has received an opinion letter dated June 30, 2020 from the Internal Revenue Service (IRS), which stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan Administrator believes that the Plan is currently designed and is being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require the Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities.

NOTE 4. INCOME TAX STATUS (Continued)

The Plan Administrator has analyzed tax positions taken by the Plan and concluded that, as of December 31, 2024, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or that would require disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress. The Plan Administrator believes that the Plan is no longer subject to income tax examinations for years prior to December 31, 2021.

NOTE 5. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are invested in shares of mutual funds managed by Fidelity, the trustee of the Plan. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Fidelity amounted to \$26,465 for the year ended December 31, 2024.

NOTE 6. RISKS AND UNCERTAINTIES

The Plan invests in various investment funds, which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 7. FAIR VALUE MEASUREMENTS

Fair value is determined based on assumptions that a market participant would use in pricing an asset or liability. Measurements of fair value are classified within a hierarchy based upon valuation inputs that gives the highest priority to quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are as follows:

- Level 1* Observable quoted prices in active markets for identical assets and liabilities.
- Level 2* Observable quoted prices for similar assets and liabilities in active markets, quoted prices for identical or similar instruments in markets that are not active, and model-based valuation techniques for which all significant assumptions are observable in the market.
- Level 3* Model-based techniques that use at least one significant assumption not observable in the market. These unobservable assumptions reflect estimates of assumptions that market participants would use in pricing the asset or liability. Valuation techniques include use of option pricing models, discounted cash flow models and similar techniques.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net assets value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust: The unit value of each common collective investment trust is calculated by dividing the fund's net asset value (NAV) on the calculation date by the number of units that are outstanding on the calculation date. The NAV is used as a practical expedient to estimate fair value. The number of units of the common collective trusts that are outstanding on the calculation date is derived from the observable purchase and redemption activity in the collective trusts.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
