To the Participants and Plan Administrator of the Clayton Early Learning 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the accompanying financial statements of the Clayton Early Learning 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Notes to the Financial Statements

December 31, 2024 and 2023

(1) General Description of the Plan

The following description of the Clayton Early Learning 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution plan that covers all employees of Clayton Early Learning (Clayton). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

(b) Contributions

Eligible employees may begin to participate in the Plan with elective deferral contributions on the first day of the first month following 30 days of service and attaining the age of 18. Participants may elect to designate all or a portion of their elective deferral as Roth elective deferral contributions. Each year, participants may contribute to the Plan the maximum amount allowed by law. Participants who have attained age 50 during a calendar year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans as rollover contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers one pooled separate account, fourteen collective investment trusts, and fifteen mutual funds. The Plan includes an auto-enrollment provision whereby all newly eligible employees shall be automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate of 4% of eligible compensation. Each year on July 1, participant's elective deferral percentage will increase 1% until 10% is reached unless directed otherwise. Contributions are automatically invested in a default fund, which is their age-appropriate Principal LifeTime Hybrid Collective Investment Fund, until changed by the participant. An employee becomes eligible for employer contributions after one year of service totaling at least 1,000 service hours and attaining the age of 18. Clayton may make a matching contribution equal to a percentage of the participants' elective deferral contributions, not to exceed 5% of eligible compensation. The amount elected by Clayton for 2024 was 100% of the first 5% of eligible compensation. The amount elected by Clayton for 2023 was 75% of the first 5% of eligible compensation through July 27, 2023, and 100% of the first 5% of eligible compensation thereafter. The matching contribution is invested in the portfolio of investments as directed by the participant.

(c) Participant Accounts

Each participant's account is credited with the participant's, Clayton's, and rollover contributions and participant earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

If a participant terminates employment, the participant may elect to receive a distribution of some or all of the participant's vested account balance.

(1) General Description of the Plan, Continued

(d) Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the employer's contribution portion of their accounts is based on years of service. A participant is 100% vested after three years of credited service.

(e) Notes Receivable from Participant

Participants may borrow from their fund account a minimum of \$1,000 up to a maximum amount of the lesser of 50% of the participant's vested account balance or \$50,000 minus the highest total outstanding Plan loan balance in the twelve months immediately before the date of the participant's new loan. The loans are secured by the balance in the participant's account and bear interest rates between 5.00% and 9.50%, which are commensurate with local prevailing rates as determined quarterly by the Plan administrator. Loans must be repaid in substantially level, amortized payments over a period not exceeding five years, except in the purchase of a primary residence, in which case the term is ten years. Total loans outstanding at December 31, 2024 and 2023 were \$71,317 and \$33,852, respectively.

(f) Payment of Benefits

On termination of service due to death, a single lump-sum cash payment or annuity options will be made to the participant's designated beneficiary. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution, an annuity option, or a direct rollover to an individual retirement account or to another employer's tax qualified plan. For termination of service due to other reasons, a participant whose account balance is greater than \$5,000 can withdraw all or part of the vested account in a single sum, or can generally leave all or part of the vested account in the Plan and defer receipt of the benefit. If a participant's vested account balance is \$5,000 or less, the participant will receive a single-sum payment at termination of employment. Participants who are age 59½ and still employed by Clayton may withdraw all or a portion of their respective vested account balance.

(g) Forfeited Accounts

During 2024 and 2023, forfeited non-vested accounts totaled \$26,103 and \$29,375, respectively. Forfeitures are used to pay certain Plan expenses and to reduce Clayton's contributions to the Plan.

(h) Hardship Distributions

The Plan permits the withdrawal of a hardship distribution by a participant to satisfy immediate and heavy financial needs. A hardship distribution may be made only for certain needs, including medical expenses, costs related to the purchase of a principal residence, costs to prevent eviction from a principal residence, burial or funeral expenses, expenses for the repair of damage to a participant's personal residence, or certain education expenses for post-secondary education. Furthermore, the distribution cannot be in excess of the amount of the participant's immediate and heavy financial need. The distribution can be made only from the participant's salary deferrals and earnings thereon.

(1) General Description of the Plan, Continued

(i) Expenses

Plan administration fees are paid from the assets of the Plan to the extent permitted. Expenses may be allocated among all Plan participants or charged directly against individual account balances. Fees charged directly to individual account balances include general recordkeeping fees and expenses related to processing distributions or loans, qualified domestic relations orders, and directing the investment of the participants' account balance.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

(b) Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan's administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

(c) Investments

Investments are reported at fair value. Fair value is determined as more fully described in note 2(d). Investments in mutual funds with readily determinable market values are reported at fair value based on quoted prices in active markets. The market values for separate accounts and collective investment trusts represent the Plan's pro-rata interest in the net assets of each investment and are based on the fair value of the underlying assets. These investments are not publicly traded on national security market exchanges, and may be valued differently than if readily available markets existed for such investments. Management is responsible for the fair value measurement of investments reported in the financial statements and believes that the reported values are reasonable.

Investment return consists of the Plan's distributive share of any interest, dividends, capital gains and losses, generated from investments, as well as the change in fair value of the investments. Gains and losses attributable to investments are realized and reported upon a sales or disposition of the investments. Unrealized gains and losses are included in the change in net assets available for benefits.

(2) Summary of Significant Accounting Policies, Continued

(d) Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. US GAAP establishes a fair value hierarchy that prioritizes investments based on the assumptions market participants would use when pricing an asset. The fair value hierarchy gives the highest priority to quoted prices in active markets (observable inputs) and the lowest priority to an entity's assumptions (unobservable inputs). The Plan groups assets at fair value in three levels based on the markets in which the assets and liabilities are traded and the reliability of the assumptions used to determine fair value. In addition, the Plan reports certain investments using the "practical expedient" method. The practical expedient allows net asset value per share or its equivalent to represent fair value for reporting purposes when the criteria for using this method are met. Investments valued using net asset value per share or its equivalent are not categorized within the hierarchy.

These levels are:

- Level 1 Unadjusted quoted market prices for identical assets or liabilities in active markets as of the measurement date.

- Level 2 Other observable inputs, either directly or indirectly, including:
 - Quoted prices for similar assets/liabilities in active markets;
 - Quoted prices for identical or similar assets in non-active markets;
 - Inputs other than quoted prices that are observable for the asset/liability; and,
 - Inputs that are derived principally from or corroborated by other observable market data.

- Level 3 Unobservable inputs that cannot be corroborated by observable market data.

In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, an investment's level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. These classifications (Level 1, 2 and 3) are intended to reflect the observability of inputs used in the valuation of investments and are not necessarily an indication of risk or liquidity.

Market price is affected by a number of factors, including the type of instrument and the characteristics specific to the instrument, as well as the effects of market, interest and credit risk. Instruments with readily available active quoted prices or for which fair value can be measured from actively quoted prices generally will have a higher degree of market price observability and a lesser degree of judgment used in measuring fair value. It is reasonably possible that change in values of these instruments will occur in the near term and that such changes could materially affect amounts reported in the Plan's financial statements.

(e) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Participant loans are placed on nonaccrual status at the time a participant terminates employment and makes no further payments on the loan. A participant loan is considered delinquent when payments are ninety days past due, at which time the entire balance of principal and interest is due. A terminated employee is required to repay the entire balance of principal and interest within sixty days of termination. If unpaid these participant loans for terminated participants are reclassified as distributions based upon the terms of the Plan document; therefore there is no allowance for doubtful accounts.

At December 31, 2024 and 2023, all notes receivables from participants are current.

(f) Payment of Benefits

Benefits are recorded when paid.

(g) Participant Accounting Records

The Plan's custodian maintains individual participants' accounting records. Contributions and income are allocated by the custodian to the participants' accounts on a monthly basis, and statements are prepared and sent to all participants quarterly.

(h) Subsequent Events

Management has evaluated subsequent events through September 22, 2025, the date the financial statements were available to be issued.

(3) Plan Termination

Although it has not expressed any intent to do so, Clayton Early Learning has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

(4) Tax Status

The Plan has been informed by its contract administrator that the adopted regional prototype 401(k) plan is designed in accordance with applicable sections of the Internal Revenue Code. Clayton is of the opinion that the Plan fulfills the applicable requirements of a qualified plan. Accordingly, no provision for federal or state taxes has been provided.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan administrator has analyzed the tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements and determined there are none. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan files Form 5500, and the three previous tax years remain subject to examination.

(5) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The separate accounts and collective investment trusts are measured at the net asset value (NAV) per share as reported by the investment manager or sponsor as a practical expedient. Separate accounts and collective investment trusts are invested in underlying funds that primarily consist of equity securities, fixed-income instruments and other mutual funds and short-term instruments. Investments are valued daily and can be redeemed with a one-day notice period.

(7) Related Party Transactions

Investment products, custodial and trustee services are provided by Principal Life Insurance Company (Principal Life), Principal Global Investors, and Principal Trust Company (Principal Trust). Principal Life, Principal Global Investors and Principal Trust are members of Principal Financial Group. Principal Life is the third-party administrator and provides administrative services as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the administrative services were \$38,806 in 2024 and \$36,048 in 2023.

(8) Financial Data Certified by the Plan Trustee

The Plan administrator has elected the method of compliance permitted by Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan trustees have certified all financial data from which the Plan participant loan balances, investment balances and activities reported on the statements of net assets available for benefits, the statements of changes in net assets available for benefits and the supplemental schedule of assets held for investment purposes have been prepared.

(9) Prohibited Transactions

During 2023, the Plan sponsor failed to remit to the Plan's trustee certain employee contributions and participant loan repayments totaling approximately \$3,431 within the period prescribed by DOL regulations. The Plan sponsor restored lost earnings on participant accounts in 2024.
