Planned scope and timing of the audit

We conducted our audit consistent with the planned scope and timing we previously communicated to you in our engagement letter and during the course of the audit.

Qualitative aspects of accounting practices

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by the Plan are described in Note 2 to the financial statements. No new accounting policies were adopted and the application of existing policies was not changed during the year. No matters have come to our attention that would require us, under professional standards, to inform you about (1) the methods used to account for significant unusual transactions and (2) the effect of significant accounting policies in controversial or emerging areas for which there is a lack of authoritative guidance or consensus.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. We did not note any such sensitive accounting estimates during the course of our audit.

The financial statement disclosures are neutral, consistent, and clear.

Significant unusual transactions

A significant deficiency is a deficiency, or a combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance.

We consider the following deficiencies in the Plan's internal control to be significant deficiencies:

Finding:

During our audit inquiries of management, we noted there is minimal review and reconciliation of the Plan level trust statements and activity throughout the year, and that the Company appears to be relying on the Third-Party Administrator (TPA) to perform reconciliations for the Plan.

Recommendation:

We recommend that Company establish policies and procedures to ensure that Plan trust statements (including contributions, distributions, loans, and participant accounts) are being reviewed and reconciled with internal records on a periodic basis. A fiduciary under ERISA is any party who exercises any discretionary authority or control over the Plan's management; exercises any authority or control over the management or disposition of the Plan's assets; renders investment advice for a fee or other compensation with respect to Plan funds; or has any discretionary authority or responsibility in the Plan's administration. Under ERISA, the Plan's "named fiduciary," and generally the employer, has the primary responsibility for protecting Plan assets. For this reason, it is important to be aware that service provider errors may ultimately be deemed the responsibility of the Company. Care should be taken and procedures established for Plan management to periodically review and reconcile the records of the Plan.

Finding:

During our testing of participant accounts, we noted that two participants' deferrals ceased upon reaching the IRS compensation limit for matching contributions. However, deferrals resumed in the second half of the year and continued until the participants reached the IRS annual deferral limits. As a result of this delay, the participants experienced a loss of potential earnings.

Recommendation:

We recommend that management analyze, quantify and correct all such errors as soon as possible. We also recommend that management implement policies and procedures to ensure the employee deferral contribution calculations are accurate before amounts are remitted to the Plan.

Finding:

During our testing of participant accounts, we noted that one participant's match was calculated based on a bonus paycheck. The participant had elected a 0% deferral rate for the qualified plan and instead deferred 100% of the bonus to a non-qualified plan.

Recommendation:

We recommend that management analyze, quantify and correct all such errors as soon as possible. We also recommend that management implement policies and procedures to ensure the employer match contribution calculations are accurate before amounts are remitted to the Plan.

Disagreements with management

Other matters, findings or issues

The ERISA-required supplemental schedules were subjected to the audit procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. Our responsibility also includes communicating to you any information which we believe is a material misstatement of fact. Nothing came to our attention that caused us to believe that such information, or its manner of presentation, is materially inconsistent with the information, or manner of its presentation, appearing in the financial statements.

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Company's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements are free from material misstatement, whether due to fraud or error and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance. Therefore, it is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users made on the basis of these financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule of Schedule H, Line 4i - Schedule of Assets (Held at Year End) as of December 31, 2024, is presented for purposes of additional analysis and are not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or are derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO THE FINANCIAL STATEMENTS
DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of the Fracht FWO Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Fracht FWO Inc. (the "Sponsor") who have at least 3 months of qualified service and are age 21 or older. The Plan became effective on August 10, 2021, and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA") and the Internal Revenue Code (the "IRC").

Contributions

Employees eligible to participate in the Plan ("participants") may contribute, on a pre-tax and after-tax basis, a percentage of their compensation, as defined by the Plan, under a salary deferral arrangement, subject to IRC limitations. The Plan also allows participant rollover contributions, which represent distributions from other qualified plans. Eligible employees who do not elect otherwise will be automatically enrolled in the Plan with a salary deferral of 3% of compensation.

The Sponsor makes matching contributions on behalf of each participant in an amount equal to the participant's deferral contributions, up to a maximum of 6% of the participant's compensation, as defined.

Investment options

The Plan's investment assets are held by Voya Retirement Insurance and Annuity Company (the "Custodian"), the custodian of the Plan's assets. Under this arrangement with the Custodian and upon enrollment in the Plan, participants direct contributions in any whole percentage or dollar increment into any of the available funds. Participants may change their allocations among the various investment options at any time.

Participant account

Each participant's account is credited with (a) the participant's contributions, (b) the Sponsor's contributions on behalf of the participant, and (c) the earnings and losses of the participant's investments and is charged with any expenses incurred as a result of transactions initiated by the participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years, unless the loan qualifies as a home loan, for which the term may be extended beyond five years but not to exceed fifteen years. The loans are secured by the balance in the participant's account and bear interest at a fixed rate of prime plus 1% as per the date the loan is secured. Principal and interest are paid ratably through periodic payroll deductions. A participant can have no more than one loan outstanding at a time. The interest rates on outstanding loans ranged from 4.25% to 9.50% at both December 31, 2024 and 2023.

Payment of benefits

Upon termination of service, or for reasons of death, disability, or retirement, a participant may elect to receive either a lump-sum or partial withdrawal of his or her account or elect to have his or her account balance transferred to an Individual Retirement Account ("IRA") or to another qualified employer plan. In the event that a participant terminates employment with the Sponsor and has a vested account balance of \$1,000 or less, the participant will receive an automatic distribution of those funds. A participant whose account balance exceeds \$1,000 but does not exceed \$5,000 will have their balance automatically rolled over into an IRA outside of the Plan assets as soon as administratively feasible following termination. Active employees may withdraw from their accounts upon attainment of age 59½ or for reasons of financial hardship as defined by IRC regulations.

Administrative expenses

Administrative fees associated with certain participant-directed transactions are paid by the Plan. These fees are charged to the accounts of the participants who initiate the transactions.

Vesting and forfeitures

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Sponsor's matching contributions and actual earnings thereon is based on years of qualifying service.

A participant is vested according to the following schedule:

2 years	20%
3 years	40%
4 years	60%
5 years	80%
6 years	100%

Forfeitures of nonvested balances are used to pay administrative expenses or to reduce future Sponsor matching contributions. During the year ended December 31, 2024, forfeited amounts totaled \$133,447 and \$10,216 and \$38,154 was used to pay administrative expenses and reduce Sponsor matching contributions, respectively. Accumulated forfeitures totaled \$113,459 and \$25,822 at December 31, 2024 and 2023, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The accompanying financial statements are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America.

Payment of benefits

Benefits are recorded when paid.

Use of estimates in financial statement preparation

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements. Interest income is recorded when earned. Net appreciation / depreciation includes dividends and unrealized and realized gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are recorded as distributions based upon the Plan's provisions.

Expenses

Certain expenses incurred maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Investment-related expenses are included in net appreciation / depreciation of fair value of investments.

3. INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN (UNAUDITED)

The Sponsor has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's (the "DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Sponsor instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by the Custodian, except

for comparing such information certified by the Custodian to information included in the Plan's financial statements and supplemental schedule.

4. INVESTMENT CONTRACT WITH CUSTODIAN

The Plan has an investment contract with the Custodian, who maintains the contributions in a guaranteed account. The account is credited with earnings on the underlying investments and charged for Plan withdrawals.

The contract value of the Plan's investment in this contract represents contributions made under the contract, plus accrued interest, less Plan withdrawals. Transfers by participants from the guaranteed account to other funds at contract value are generally permitted at contract value. For a period of 90 days following a partial withdrawal of funds from the guaranteed account by a participant, additional withdrawals or transfers from the guaranteed account at contract value are not allowed. Since the Plan's ability to transact with the issuer at contract value may be limited by participant-directed transactions, the contract is not considered to be fully benefit-responsive. The contract value of this investment was \$799,311 and \$738,548 at December 31, 2024 and 2023, respectively.

Certain non-participant directed events could also limit the ability of the Plan to transact with the issuer at contract value. Such events include the following: (a) termination of the Plan, (b) merger of the Plan into another plan, or (c) premature termination of the contract by the Sponsor. The Sponsor does not believe that such events are probable of occurring.

The specified contract interest crediting rate is adjusted annually at the beginning of each year and is guaranteed to be at least 1.00%.

5. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used during the year ended December 31, 2024.

- Pooled separate accounts: Valued at the unit value of shares held by the Plan at year-end, as determined by the Custodian based on the net asset value ("NAV") of the underlying mutual funds. The NAV, as reported by the Custodian, is used as a practical expedient to estimate fair value. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.
- Collective trusts: Valued at the NAV of units of the collective trusts. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily.
- Guaranteed account: Valued at the net present value of the related cash flows of the underlying investments based on current yields of similar instruments with comparable durations.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Sponsor believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. TAX STATUS

The Plan utilizes a prototype plan document sponsored by Voya Retirement Insurance and Annuity Company, who received a letter from the Internal Revenue Service (the "IRS"), dated June 30, 2020, in which the IRS opined that the prototype plan is acceptable under the applicable sections of the IRC.

The Plan has not obtained a determination from the IRS on its adoption of the volume submitter prototype plan. In accordance with Revenue Procedure 2002-6, the Sponsor has chosen to rely on the opinion letter of the prototype plan. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Sponsor believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits for any tax periods in progress.

7. RELATED PARTY TRANSACTIONS

The Sponsor pays certain costs on behalf of the Plan for third party administration, insurance, and audit fees. The Sponsor also provides recordkeeping and administrative services to the Plan at no cost.

Investments held by the Plan are managed by the Custodian. Accordingly, these transactions qualify as party-in-interest transactions under ERISA.

8. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

9. PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants would become 100% vested in their accounts.

10. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

11. SUBSEQUENT EVENTS

The Sponsor has evaluated subsequent events through September 19, 2025, the date the financial statements were available to be issued.
