### **1. Description of Plan**

The following description of the Escuela Bilingue Internacional 403(b) Retirement Plan (the "Plan") is provided for general information purposes only. Participants should refer to the plan document and Summary Plan Description for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan covering all eligible employees of Escuela Bilingue Internacional (the "School" or "Employer"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). During December 2024 all participant accounts were transferred to Principal Trust Company. The remaining balance held by Voya Retirement Insurance Company ("VOYA") represents the Voya Fixed Account which the Plan Sponsor elected a spread pay option where the remaining balance plus interest will be transferred to Principal Trust Company in five installments over five years through 2029.

#### ***Eligibility***

An eligible employee becomes eligible to make elective deferrals, receive the discretionary employer matching contribution and discretionary employer non-elective contribution upon hire. Employees who normally work fewer than 20 hours per week are excluded from participating in the Plan.

#### ***Contributions***

Participants may make elective pre-tax and Roth salary deferral contributions to the Plan, as a percentage of eligible compensation, through payroll deductions. Participants who are age 50 or older by the end of the plan year can make catch-up contributions to the Plan. Participant contributions are subject to maximum limits as established by the Internal Revenue Service ("IRS"). Participants may change their contribution percentages each pay period or stop deferrals at any time. Participants may also contribute amounts representing rollover distributions from other qualified plans.

The Plan includes an auto enrollment provision whereby employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default rate set at 4% of their eligible compensation.

The Employer may make a discretionary matching contribution. During the 2024 plan year the School elected to make a discretionary matching contribution equal to 100% of participant salary deferrals not to exceed 4% of eligible compensation.

The Employer may make a discretionary non-elective contribution. During the 2024 plan year the School elected to make a discretionary non-elective contribution equal to 2% of each eligible employee's eligible compensation.

**1. Description of Plan (continued)**

***Vesting***

A participant is 100% vested in their salary deferrals including allocated earnings thereon at all times.

Effective January 1, 2024 all participants are 100% vested in their discretionary matching contribution and discretionary non-elective contribution including allocated earnings thereon at all times.

***Participant Accounts***

Each participant's account is credited with the participant's contribution and allocations of (a) the School's discretionary matching and discretionary non-elective contributions and (b) Plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. All investments are participant directed.

***Payment of Benefits***

Upon termination of service due to death, disability, retirement or other reason, a participant is entitled to receive a distribution in the amount equal to the value of the participant's interest in his or her account in the form of a lump sum, installments or an annuity. A participant may request an in-service distribution once they have reached age 59 ½. A hardship distribution may be made to satisfy certain immediate and heavy financial needs that a participant may have.

***Notes Receivable from Participants***

The Plan offers a loan feature whereby a participant (borrower) enrolled in the Plan may borrow a minimum amount of \$1,000 up to a maximum amount of 50% of their vested account balance or \$50,000 (whichever is less). The interest rate will be equal to the prime rate plus 1% as posted in the Wall Street Journal at the time the loan is processed. The maximum number of loans outstanding by a participant at any one time is one. Loans must be repaid within five years, unless the loan is used to purchase a participant's principal residence which may extend the maturity date of the loan beyond five years up to fifteen years.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting and Use of Estimates***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**2. Summary of Significant Accounting Policies (Continued)**

***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on Fair Value Measurements which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At December 31, 2024, all of the Plan's investments, that were valued at fair value, were valued using level 1 inputs. At December 31, 2023, all of the Plan's investments, that were valued at fair value, were valued using level 2 inputs.

***Investment Valuation and Income Recognition***

All of the Plan's investments are stated at fair value except for the Voya Fixed Account, which is stated at contract value. Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. Separate accounts are reported at the value reported to the Plan by the insurance company, which represents the fair value of the underlying investments comprising the accounts. The underlying investments comprising the separate accounts have observable inputs that are used to determine the unit values of the separate accounts. The Voya Fixed Account is reported at contract value, which represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the loan will be treated as taxable deemed distributed but will not offset against the participant account until a distributable event occurs, and interest will continue to accrue until repayment or offset.

***Payment of Benefits***

Benefits are recorded when paid.

***Expenses***

Some expenses of maintaining the Plan are paid directly by the School and are excluded from these financial statements. Investment related expenses are included in net appreciation in value of investments.

**2. Summary of Significant Accounting Policies (continued)**

***Forfeitures***

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$3,765. These accounts will be used to reduce future Employer contributions or administrative expenses. During 2024, Employer contributions were reduced by \$22,019 from the forfeited non-vested accounts, and no forfeitures were used to reduce administrative expenses.

***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is September 9, 2025.

**3. Information Certified (Unaudited)**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in value of investments, interest income on investments, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya, and Principal qualified institutions. Effective December 1, 2024 Principal was added as a qualified institution.

**4. Voya Fixed Account**

The Voya Fixed Account (the “Account”) is a fully benefit-responsive investment contract with Voya. The Account guarantees principal and a minimum guaranteed interest rate for the life of the contract, as well as featuring two declared interest rates: a current rate, determined at least monthly, and a guaranteed minimum floor rate declared for a defined period – currently one calendar year. The guaranteed minimum floor rate may change after the defined period, but it will never be lower than the minimum guaranteed interest rate that applies for the life of the contract. The current rate, the guaranteed minimum floor rate and the minimum guaranteed interest rate are expressed as annual effective yields. Taking the effect of compounding into account, the interest credited to a participant’s account daily yields the then current credited rate. Voya’s determination of credited interest rates reflects a number of factors, including mortality and expense risks, interest rate guarantees, the investment income earned on invested assets and the amortization of any capital gains and/or losses realized on the sale of invested assets. Under this option, Voya assumes the risk of investment gain or loss by guaranteeing the principal amount allocated to this option and promises a minimum interest rate during the accumulation period and also throughout the annuity payout period. Voya may impose limitations on the ability to transfer funds out of this investment option. Withdrawals from the Account for other than the payment of benefits to participants may be subject to a market value adjustment and a surrender charge.

**4. Voya Fixed Account (*continued*)**

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The Account is presented on the face of the statements of net assets available for benefits at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

Voya is contractually obligated to repay the principal and the specified interest rate that is guaranteed to the Plan. The credit risk of the issuer was evaluated by nationally recognized statistical rating agencies as follows: Moody's Investors Service (A2 as of September 2024), Standard and Poor's (A+ as of September 2024) and Fitch (A+ as of September 2024).

**5. Plan Termination**

Although it has not expressed any intent to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**6. Tax Status**

The School has adopted an IRS approved volume submitter plan that received an IRS opinion letter dated March 31, 2017. The Plan administrator believes that the Plan, as amended, is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

U.S. GAAP require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examination by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

**7. Party-in-Interest Transactions**

Certain investments are managed by Voya. Voya is the custodian as defined by the Plan document and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statement of net assets available for benefits.

**8. Non-exempt Party-in-Interest Transactions**

For the 2023 plan year, the Employer failed to transmit to the Plan contributions for participants and loan repayments totaling \$17,523 within the period prescribed by Department of Labor regulations. The Employer has corrected contributions totaling \$17,523 during the 2024 plan year.

**9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to December 31, 2024 are not reflected in these financial statements and future effects on the Plan's net assets available for benefits cannot be predicted.
