Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Finkl Steel Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Note 1 - Plan Description

The following description of Finkl Steel Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering office (nonunion) employees and union employees who are members of the International Brotherhood of Boilermakers, Iron Ship Builders, Blacksmiths, Forgers & Helpers (IBBB); International Association of Machinists (IAM); and International Brotherhood of Electrical Workers (IBEW) of A. Finkl & Sons Co. and certain affiliated employers (collectively, the "Company"). The Plan does not cover nonresident aliens, leased employees, or independent contractors. All nonunion employees are eligible to participate in the Plan upon the commencement of employment. All union employees must complete three consecutive months with at least one hour of service before being eligible to participate in the Company's contributions. Eligibility for the Company's contributions begins on the first day of the next payroll period following satisfaction of eligibility requirements. Service requirements are waived for union employees hired prior to February 1, 2017. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

A. Finkl & Sons Co. is the plan sponsor and administrator of the Plan.

Contributions

The Plan provides for employee salary 401(k) deferral contributions up to a maximum of 100 percent of their pretax annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code (IRC). Effective April 1, 2024, the Plan was amended to also allow Roth elective deferral contributions. Participants who have attained age 50 before the end of the year are also allowed to make catch-up contributions. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Company also makes discretionary employer contributions. For 2024, the Company made discretionary employer contributions as follows:

- Nonunion participants: 3 percent of participants' eligible compensation for the year without regard to whether the participant contributed to the Plan
- Nonunion participants: 4 percent of participants' eligible compensation for the year without regard to whether the participant contributed to the Plan
- Nonunion participants: Matching contribution of 100 percent of a participant's first 5 percent of contributions up to 2.5 percent of the employee's eligible compensation, as defined by the Plan
- IBBB and IAM union participants: Matching contribution of 50 percent of a participant's first 5 percent of contributions
- IBEW union participants: Matching contribution of 50 percent of a participant's first 6 percent of contributions

In addition, the Company provided for additional nondiscretionary contributions equal to 2 percent of each IBBB and IAM union participant's eligible compensation without regard to whether he or she contributed to the Plan.

The Company may also make other discretionary contributions allocated among eligible participants based on the eligible participant's annual pay divided by the total annual pay of all participants receiving the contribution. No such contributions were made in 2024.

December 31, 2024 and 2023**Note 1 - Plan Description (Continued)*****Participant Accounts***

Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of plan losses and administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and the Company's historical safe harbor contributions plus actual earnings thereon. Union employees hired prior to February 1, 2017 are immediately vested in all contributions. Vesting in the Company's discretionary and additional contributions for all other eligible participants is based on years of continuous service in accordance with the following schedule:

Participants also become fully vested in the company discretionary and additional contributions upon normal retirement age, death, or disability.

Forfeitures

Forfeited balances, if any, of terminated participants are used to reduce future company contributions.

Participant Notes Receivable

Participants may borrow from their accounts subject to a maximum of \$50,000 or 50 percent of their account balances, whichever is less, with a minimum amount of \$1,000. Notes receivable are collateralized by the participant's account balance, bear interest at a market rate, and are payable through payroll deductions under a repayment schedule not to exceed five years unless the loan is used to acquire a principal residence.

Benefit Payments

Distributions are payable upon retirement, death, disability, or termination of employment in the form of a lump-sum amount equal to the vested balance of a participant's account. Hardship withdrawals may be requested and must be authorized by the plan administrator. A hardship distribution is limited to the amount needed to meet the financial need and may not be recontributed to the Plan.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal Trust). Principal Trust is the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan document and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value except as noted in the paragraph below. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for further discussion of fair value measurements.

The Principal Guaranteed Option account is valued at contract value. Contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees. See Note 6 for further discussion on the insurance contract.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Administrative Expenses

Various administrative costs are paid by the Company.

Benefit Payments

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including September 29, 2025, which is the date the financial statements were available to be issued.

Note 3 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The Plan measures mutual funds at fair value on a recurring basis based on quoted market prices. The fair value of a mutual fund is based primarily on Level 1 inputs, as described above.

Note 4 - Certified Information

Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (the "Custodian") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Custodian.

Note 5 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 6 - Unallocated Contracts

The Plan has a benefit-responsive investment contract with Principal Life Insurance Company (Principal) as of December 31, 2024 and 2023. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates are reviewed on a quarterly basis for resetting but may not be less than 0.15 percent for the guaranteed account. When establishing interest crediting rates for this product, Principal considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account.

Note 6 - Unallocated Contracts (Continued)

Certain events limit the ability of the Plan to transact at contract value with the insurance company. Such events include the following: (i) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provision, (iii) bankruptcy of the plan sponsor or other plan sponsor events (e.g., divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (iv) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator believes that the occurrence of any such events, which would limit the Plan's ability to transact at contract value with participants, is not probable. There are no events that allow the issuer to terminate the contract and that require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time.
