Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

1. DESCRIPTION OF THE PLAN

The following description of Standard Fusee Corporation 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, which was established by Standard Fusee Corporation (the Company), effective December 26, 1988. Prior to January 1, 2022, all employees of the Company, other than certain union employees whose employment is governed by a collective bargaining agreement, were eligible to participate in the Plan upon attaining the age of 21 and completion of one year of service. One year of service was defined as a period of 12 consecutive months during which an employee completes at least 1,000 credited hours of service to the Company. Participants could enter the Plan on the first day of the Plan year quarter coinciding with or following the date the eligibility requirements were satisfied.

The Plan was amended and restated effective January 1, 2022 to remove the requirement that participants be at least 21 years of age, to allow participation in the Plan after completing three months of service, and to implement automatic escalation of participant contributions by 1% annually up to a maximum of 6% of compensation. Effective January 1, 2022, the Plan became a Qualified Automatic Contribution Arrangement (QACA) safe harbor plan, and qualified safe harbor contributions are subject to a vesting schedule. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

During 2024, the Plan elected to operate in accordance with SECURE Act and SECURE 2.0 and implement certain provisions effective January 1, 2025. These provisions include increasing the mandatory cash-out threshold for terminated employees from \$5,000 to \$7,000, increasing catch-up limits for participants ages 60-63, and allowing qualified declared disaster and qualified birth or adoption withdrawals. Although formal amendments have not yet been executed, the Plan is operating in compliance with these provisions and will adopt amendments by the statutory deadline.

Participant Contributions

Participants may contribute a specific percentage or dollar amount of their compensation, as defined by the Plan agreement, not to exceed the maximum allowable contribution under Section 402(g) of the Internal Revenue Code (the Code), which was \$23,000 for the year ended December 31, 2024. Participants who have attained age 50 before the end of the Plan year may make additional catch-up contributions, subject to limitations imposed by the Code, which totaled \$7,500 for the year ended December 31, 2024. Roth contributions are permitted by the Plan. The participants' Roth elective contributions are allocated to a separate account maintained for such contributions. Roth elective contributions are treated as elective contributions for all purposes under the Plan.

Participant Contributions – cont'd.

The Plan has an automatic enrollment provision whereby an eligible employee who does not elect to contribute a specific percentage of their compensation will be automatically enrolled to contribute to the Plan at the rate of 3% of current compensation, unless the employee elects not to contribute or elects to contribute a different percentage. Automatic enrollment contributions are contributed to an appropriate target date fund, unless the participant elects a different fund within the Plan.

Participants are permitted to make rollover contributions to the Plan.

QACA Safe Harbor Matching Contributions

Effective January 1, 2022, the Plan is referred to as a qualified automatic contribution arrangement 401(k) plan. Each payroll period, for eligible participants, the Company contributes an amount equal to the sum of 100% of participants' elective deferrals that do not exceed 3% of participants' compensation plus 50% of participants' elective deferrals that exceed 3% of participants' compensation but do not exceed 5%. All participants eligible to participate in the Plan are eligible for the QACA matching contributions. The Company made QACA matching contributions of \$199,552 for the year ended December 31, 2024.

Company Matching Contribution

The Company may make a discretionary matching contribution equal to a uniform percentage of a participant's salary deferrals. This discretionary matching contribution is determined each year by the Company. The Company did not make any discretionary matching contributions for the year ended December 31, 2024.

Company Profit Sharing Contributions

The Company may also make a discretionary profit sharing contribution to the Plan on behalf of eligible participants, as defined by the Plan agreement. The discretionary profit sharing contribution is to be allocated to each participant's account based on a ratio of each participant's eligible compensation to total eligible compensation for the period. The Company made discretionary profit sharing contributions of \$25,080 for the year ended December 31, 2024. These contributions are calculated and paid after year end, therefore, Company contributions receivable totaling \$25,080 and \$27,883 as of December 31, 2024 and 2023, respectively, are recorded on the statements of net assets available for benefits. Forfeitures of \$4,086 were applied to discretionary profit sharing contributions paid during the year ended December 31, 2024.

Participant Accounts

Each participant's account is participant-directed and is credited with the participant's contributions and allocations of Company contributions, Plan earnings or losses, and administrative expenses in accordance with the investment options selected by each participant. Any earnings, losses and administrative expenses are allocated to participant accounts based upon the balance in each account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. DESCRIPTION OF THE PLAN – cont'd.

Notes Receivable from Participants

Participants may borrow up to 50% of their vested account balance, not to exceed \$50,000 without regard to the intended use of the funds. The minimum note amount is \$1,000 and a participant may have no more than one note outstanding at any time. Notes are collateralized by the participant's vested account balance. Note repayments are made through payroll deductions and bear interest at a rate commensurate with local prevailing rates at the time of loan origination as determined by the Plan administrator. Generally, the term of a note may not exceed 5 years. However, if the note is for the purchase of the participant's principal residence, the Plan administrator may permit a longer repayment term. Notes become due immediately upon termination of a participant's employment.

Payment of Benefits

Upon termination of service, death, disability, retirement, or attainment of age 59 ½, a participant is entitled to a distribution of their vested account balance. Distributions may be made in either a lump-sum equal to the value of the participant's vested interest in their account, substantially equal installments, or a single sum distribution of a portion of their vested balance. Effective January 1, 2025, if the vested account balance of a terminated employee is less than \$7,000, the total balance will be paid in a lump-sum without participant consent as soon as administratively feasible following a participant's termination. Prior to January 1, 2025, the threshold for such distributions was \$5,000.

Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, amounts contributed by the participant may be withdrawn for a hardship purpose. Distributions are subject to the applicable provisions of the Plan agreement. Certain income taxes and penalties may apply to withdrawals or distributions prior to age 59 ½. As of December 31, 2024 and 2023, there were no net assets of the Plan allocated to participants who had elected to withdraw from the Plan but had not received the funds as of year-end.

Vesting

Participants are immediately vested in their contributions, Company safe harbor contributions (prior to January 1, 2022) and Company discretionary matching contributions plus earnings thereon. Vesting in the Company's discretionary profit sharing contributions is based on years of service according to the following schedule:

Vesting – cont’d.

Effective January 1, 2022, Company QACA safe harbor matching contributions are vested 0% with less than two years of service and 100% after two years of service.

Upon death, disability, or upon reaching early retirement age or normal retirement age, a participant becomes 100% vested in their Company discretionary profit sharing contributions and the QACA safe harbor matching contributions.

Forfeitures

All forfeitures resulting from the termination of participants prior to vesting are retained in the Plan. Forfeitures may be used to pay administrative expenses or to reduce future Company contributions. A forfeiture will occur in the Plan year that a participant receives a distribution of their entire vested balance or, if they do not receive a distribution, after five consecutive one-year breaks in service. Forfeitures of \$7,425 and \$4,086 were available for such reductions as of December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, no forfeitures were used for administrative expenses.

Plan Expenses

All administrative expenses are paid with the assets of the Plan, unless paid by the Company, at its discretion. During the year ended December 31, 2024, the Company elected to pay substantially all of the Plan’s administrative expenses. Expenses paid by the Company are excluded from the Plan’s financial statements. Loan and distribution fees are paid by the Plan and its participants. Investment related expenses are included in net appreciation in fair value of investments.

The Company utilizes a revenue sharing account to offset recordkeeping fees due from the Company. The revenue sharing funds were used to pay recordkeeping fees during the year ended December 31, 2024. Plan expenses are shown net of revenue sharing on the accompanying statement of changes in net assets available for benefits.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are presented using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides for investments in assets that are exposed to risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities may occur and materially affect participant account balances and the amounts reported in the accompanying statements of net assets available for benefits.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses bought and sold as well as held during the year.

Fair Value Measurement

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, defines fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investments measured at fair value:

Interests in pooled separate accounts: Valued using the net asset value (NAV) practical expedient of the shares held at year end. The NAV practical expedient is based on the value of the underlying assets owned by the fund, less its liabilities, and divided by the number of units outstanding.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balances plus accrued but unpaid interest. Delinquent loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Subsequent Events

The Plan evaluated for disclosure any subsequent events through September 25, 2025, the date on which the financial statements were available to be issued, and determined there were no material events that warrant disclosure.

3. INVESTMENTS

All investment information as of December 31, 2024 disclosed in the accompanying financial statements and supplemental schedule, including assets held as of December 31, 2024, and interest and dividend income and net realized and unrealized appreciation in fair value of investments for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Standard Insurance Company.

All investment information as of December 31, 2023 disclosed in the accompanying financial statements, including assets held as of December 31, 2023, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the Custodian, Minnesota Life Insurance Company.

4. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan holds a traditional investment contract. This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The following represents the disaggregation of traditional contract values held by the Plan as of December 31,:

With traditional investment contracts, the Plan owns only the contract itself, and not the underlying investments. Traditional investment contracts are designed to accrue interest based on crediting rates established by the contract issuers.

4. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT – cont'd.

The traditional investment contract held by the Plan is a guaranteed return account. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(k) of the Code.
2. Premature termination of the contracts.
3. Plan termination or merger.
4. Changes to the Plan's prohibition on competing investment options.
5. Bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

The Plan administrator does not believe that any events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines.
2. A breach of material obligation under the contract.
3. A material misrepresentation.
4. A material amendment to the agreements without the consent of the issuer.

The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

5. PARTY-IN-INTEREST TRANSACTIONS

Plan investments are managed by Standard Insurance Company, the Plan's recordkeeper following its acquisition of Securian Financial's retirement plan recordkeeping business. Minnesota Life Insurance Company, an affiliate of Securian Financial, serves as the Plan's custodian. The Plan loans funds to its participants according to the applicable provisions of the Plan agreement. The Company provides the Plan with certain accounting and administrative services for which no fees are charged. All such transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

6. INCOME TAX STATUS

The Plan had adopted a non-standardized pre-approved 401(k) profit sharing plan agreement, which received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020. Although the agreement has been amended since receiving the letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

ASC 740, *Income Taxes*, prescribes a recognition threshold and a measurement attribute for the financial statement recognition and measurement of tax positions taken or expected to be taken in a tax return as well as guidance on de-recognition, classification, interest and penalties and financial statement reporting disclosures. For these benefits to be recognized, a tax position must be more-likely-than-not to be sustained upon examination by taxing authorities. As the Plan is tax exempt and has no unrelated business income, the provisions of ASC 740 do not have an impact on the Plan's financial statements.

The Plan recognizes interest and penalties accrued on any unrecognized tax exposures as a component of income tax expense. The Plan does not have any amounts accrued relating to interest and penalties as of December 31, 2024 and 2023.

The Plan is subject to routine audits by the Internal Revenue Service and Department of Labor, however, there are currently no audits in progress.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Company terminates the Plan, all contributions would cease and all participants would become 100% vested in their accounts.
