## **INDEPENDENT AUDITOR'S REPORT**

To the Plan Sponsor  
Commercial Holdings, LLC 401(k) Plan  
Charleston, West Virginia

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the financial statements of Commercial Holdings, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### 1 – DESCRIPTION OF PLAN AND SIGNIFICANT ACCOUNTING POLICIES

#### Plan Description

The following description of the Commercial Holdings, LLC 401(k) Plan (the Plan), provides only general information. Participants should refer to the Plan documents for more complete information.

#### General

The Plan is a defined contribution 401(k) plan established on January 1, 1991, for the benefit of the employees of AMFM, LLC and affiliated entities (the Company, the Plan Sponsor) who have attained one year of service and age 21. The Plan is intended to satisfy all the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (IRC) and similar state tax laws. The Plan is subject to the provision of the Employee Retirement Income Security Act of 1974 (ERISA) and was last amended on January 2, 2021, to allow participation of employees of Pro Lab, LLC.

An affiliate of the Company has been designated by the Plan Sponsor to administer the Plan in accordance with its terms and in accordance with the documents and instruments governing the Plan insofar as such documents and instruments are consistent with the provisions of ERISA.

#### Contributions

Participants may elect to defer a percentage of their compensation, as defined in the Plan document, limited to the maximum percentage allowable under the Internal Revenue Code for such Plan year. The Plan allows for participant Roth elective deferrals and rollover contributions from other qualified plans. The Plan Sponsor makes discretionary employer matching contributions, and the employer elected to match 20% of the participants' 2023 contributions. Participants must be employed on the last day of the Plan year to be eligible for the employer matching contributions. There were no contributions made during 2024 to be matched.

#### Participant accounts

Each participant account is credited with the participant's elective deferrals, participant rollover contributions, and any employer contributions. In addition, each participant's account is credited with their share of appreciation/depreciation in the value of investments and charged with an allocation of administrative expenses paid from Plan assets. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

#### Participant investment options

Each participant has the right to direct contributions and earnings of their account amount alternative investment funds provided under the Plan. Participants may transfer funds between investment options at any time.

### Vesting

The Plan provides for immediate vesting of salary reduction contributions and earnings thereon as well as employer matching contributions.

### Payment of benefits

Upon retirement (normal retirement age is 65), death, disability, other termination of employment, or in-service distribution (after age 59 ½) as defined in the Plan document, participants, or their spouses and/or beneficiaries may elect to receive their account as lump sum cash payment. Further, upon termination of employment, the participant may elect to transfer his or her account balances to another qualified plan or individual retirement account. If vested balances are less than \$1,000, the Plan administrator may elect to distribute the account without consent.

The Plan allows for hardship withdrawals for certain participant needs as defined in the Plan document. Hardships may be taken from participant elective contributions and related earnings.

### Significant accounting policies

The accounting and reporting policies of the Plan conforms to accounting principles generally accepted in the United States of America and to general practices within the employee benefit plan industry. The preparation of financial statements in conformity with the Plan's basis of accounting requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates. The principles and policies which significantly affect the determination of net assets and the changes in net assets are summarized below.

### Basis of accounting

The financial statements have been prepared on the accrual basis of accounting.

### Investment valuation and income recognition

The Plan's investments are stated at fair value, which equals the quoted market price as of the last day of the Plan year.

The Plan does not require collateral to secure investment instruments.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded as earned on the accrual basis. Dividends are recorded on the ex-dividend date.

### Payment of benefits

Benefit payments are recorded upon distribution.

### Operating expenses

Expenses of maintaining the Plan may be paid by the Plan Sponsor, or by the Plan.

### Subsequent events

The Plan has evaluated subsequent events through September 24, 2025, the date the financial statements were available to be issued.

## **2 – INCOME TAX STATUS**

Effective July 2012, the Plan adopted the Fidelity Volume Submitter Defined Contribution Plan. Fidelity Management & Research Co. has received a determination letter dated March 31, 2014, that the prototype plan and related amendments qualify as tax exempt under Internal Revenue Code Section 401(a). The Plan has been restated and amended on January 2, 2021 to allow participation of employees of Pro Lab, LLC. However, the Plan Administrator believes that the Plan has been operating in compliance with the aforementioned prototype plans and applicable provisions of the Internal Revenue Code.

Plan management evaluates tax positions taken by the Plan to determine if any uncertain tax positions exist that compromise the Plan's tax-exempt status that could result in tax obligations requiring recognition and disclosure in the Plan's financial statements. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain positions that require recognition and disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state, or local tax authorities for years before 2021.

## **3 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

## **4 – PARTIES-IN-INTEREST AND RELATED PARTY TRANSACTIONS**

Parties – in – interest are defined under United States Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employers, and certain others. Administrative functions performed by Fidelity Management Trust Company include participant account maintenance, and custodial services. During the year ended December 31, 2024, fees for these services amounted to \$7,747. Certain other administrative expenses for legal, auditing, and other professional services are paid directly by the Plan Sponsor and certain administrative functions are performed by officers or employees of the Plan Sponsor at no cost to the Plan.

### 5 – ASSETS CERTIFIED

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under the ERISA for 2024 and 2023. Accordingly, Fidelity Management Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments including notes receivable from participants reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) – schedule of assets held at end of year as of December 31, 2024, and the related investment activity reported in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

### 6 – FAIR VALUE MEASUREMENT

Authoritative guidance regarding fair value measurements provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the authoritative guidance are described as follows:

Level 1: Input to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the assets or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds: Valued at the net asset value (NAV) of shares at market exchange price held by the Plan at year end.

Common Collective Trust: The Putnam Stable Value Fund (“PSVF”), a common collective trust, invests directly or indirectly in fully benefit-responsive investment contracts. Valued at the NAV as provided by the trustee, which is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the PSVF, the issuer reserves the right to temporarily delay withdrawal from the PSVF in order to ensure that securities liquidations will be carried out in an orderly business manner. The PSVF, included in the fair value hierarchy table below, files a U.S. Department of Labor Form 5500, Annual Return/Report of Employee Benefit Plan, as a direct filing entity. Accordingly, certain disclosure requirements under FASB ASU 2015-12 with respect to investment strategies for investments measured using the net asset value practical expedient are not required in this report.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 7 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
