Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of the Retirement Savings Plan of O.K. Foods, Inc. (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audits"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). 1. Summary of Significant Plan Provisions

The following description of the Retirement Savings Plan of O.K. Foods, Inc. (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

- a. **General** – The Plan is a defined contribution plan for the benefit of employees of O.K. Foods, Inc. (the “Employer”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.
- b. **Eligibility** – Each employee, who is not a nonresident alien or leased employee, is eligible to participate in the Plan upon the latter of obtaining age 21 or completion of one year of service. Plan entry dates are the first of the month following the date the eligibility requirements are met.
- c. **Contributions** – Participants may contribute through payroll deductions and eligible rollovers. Employees who are eligible to participate in the Plan will automatically enter the Plan at a deferral rate of 6% of eligible compensation. An employee can elect to either increase this deferral percentage or decline to have any contributions withheld from their compensation. The Employer makes qualified automatic contribution arrangement (“QACA”) safe harbor matching contributions equal to 100% of a participant’s elective deferral contributions that do not exceed 1% of the participant’s compensation, plus 50% of the participant’s elective deferral contributions that exceed 1% of the participant’s compensation but do not exceed 6% of the participant’s compensation. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.
- d. **Participant accounts** – Each participant’s account is credited with the participant’s and Employer contributions and allocations of Plan earnings/losses, and is charged with applicable withdrawals and an allocation of administrative expenses. Allocations are based on participants’ earnings, contributions, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- e. **Vesting** – Participants are, at all times, fully vested with respect to their own contributions, plus earnings/losses thereon. With respect to Employer contributions, the benefits attributable to a participant shall be fully vested and nonforfeitable upon attainment of age 65, death or disability. If a participant terminates employment for reasons other than death, retirement, or disability, they are entitled to the vested portion of contributions made by the Employer, plus earnings/losses thereon. The vested portion of Employer discretionary contributions is calculated according to the following schedule:

- f. **Investment options** – Upon enrollment in the Plan, a participant may direct contributions in any of the accounts offered under the Plan. Participants may change their investment selections at any time.
- g. **Notes receivable from participants** – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of the vested account balance or \$50,000 reduced in accordance with the Plan agreement. Note terms cannot exceed five years unless the note is for the purchase of a primary residence. The note is secured by the participant's vested account balance and bears interest at a rate commensurate with local prevailing borrowing rates. Principal and interest are paid through payroll deductions.
- h. **Forfeitures** – The portion of a participant's account to which they are not entitled as a result of being less than fully vested shall be forfeited by the participant. Forfeitures shall be used to offset Employer matching contributions or to pay Plan administrative expenses. Forfeitures of approximately \$0 and \$57,000 were used to reduce the Employer matching contributions for the years ended December 31, 2024 and 2023, respectively. Forfeitures of approximately \$21,000 and \$1,000 were used to pay Plan administrative expenses for the years ended December 31, 2024 and 2023, respectively. Forfeitures of approximately \$35,000 and \$20,000 were available for future use as of December 31, 2024 and 2023, respectively.
- i. **Payment of benefits** – Upon termination of service, a participant may elect to receive a lump sum payment, substantially equal installments, or partial withdrawals of their vested account balance. Participants may elect to defer payment of their account balance if it exceeds \$7,000. If a participant's account balance is equal to or less than \$7,000, the account will be automatically distributed and rolled over to an individual retirement account designated by the Plan administrator. In-service withdrawals are allowed if the participant has attained age 59½ or qualifies for a hardship withdrawal.
- j. **Termination of the Plan** – Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer accounts.

Notes to Financial Statements**December 31, 2024 and 2023****2. Summary of Significant Accounting Policies**

- a. **Basis of accounting** – The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).
- b. **Estimates** – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
- c. **Investment valuation and income recognition** – Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value as disclosed in Note 3. See Note 5 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Net change in value of investments includes the Plan’s gains and losses on investments bought and sold, as well as held during the year.

- d. **Notes receivable from participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan documents.
- e. **Payment of benefits** – Benefits are recorded when paid.
- f. **Administrative expenses** – Administrative expenses charged to the Plan are allocated to participants’ accounts. Fees for loans and distributions are charged directly to the participants’ account. Other plan expenses paid by the Employer are excluded from these financial statements.

3. Fully Benefit-Responsive Investment Contract

The Plan has entered into a fully benefit-responsive guaranteed investment contract (“GIC”) with Standard Insurance Company (“SIC”). SIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. SIC is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by SIC, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all, or a portion of, their investment at contract value.

3. **Fully Benefit-Responsive Investment Contract (cont.)**

There are no reserves against the contract value for credit risk of SIC or otherwise. The contract guarantees a periodic minimum rate of interest not less frequently than annually. The interest rate is guaranteed to be not less than 1%. The crediting rate is determined monthly and is based on a formula agreed upon with the issuer.

There are no events that limit the ability of the Plan to transact at contract value with the issuer. In addition, there are no events that would permit issuers to terminate the contract and settle at amounts that differ from contract value.

4. **Investments**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by SIC, the custodian of the Plan, and was not subjected to any audit procedures, except for comparing the information with the related information included in the financial statements and supplemental schedule:

- a. Total investments as shown on the accompanying statement of net assets available for benefits totaling \$40,606,820 and \$37,504,940 as of December 31, 2024 and 2023, respectively.
- b. Interest from investments as shown on the accompanying statement of changes in net assets available for benefits of \$43,494 and \$38,587 for the years ended December 31, 2024 and 2023, respectively.
- c. Net change in value of investments as shown on the accompanying statement of changes in net assets available for benefits of \$4,528,376 and \$4,769,751 for the years ended December 31, 2024 and 2023, respectively.
- d. All investment transactions that occurred during the years ended December 31, 2024 and 2023.
- e. All the information included in the supplemental schedule, excluding participant loans.

The Plan provides for investments in various investment securities which, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Further, due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

5. Fair Value Measurements

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 or 2023.

Pooled separate accounts: These investments are valued based on the net asset value (“NAV”) of the pooled separate account multiplied by the number of shares held by the Plan at year-end. The NAV is determined based on the fair value of the underlying investments, adjusted for expenses. The NAV is used as a practical expedient to estimate fair value.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Tax Status

The Plan is utilizing a volume submitter plan document (the “Plan Document”), which received an opinion letter dated June 30, 2020, in which the IRS stated the Plan Document is designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). As allowed by the IRS, the Plan is relying on the opinion letter of the Plan Document for its own qualification. Although the Plan Document has been amended since receiving the opinion letter, the Plan administrator believes the Plan is designed and currently being operated in compliance with the applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process.

Notes to Financial Statements**December 31, 2024 and 2023****7. Parties-in-Interest Transactions**

Standard Retirement Services (“SRS”) is the third-party administrator for the Plan. The Plan pays SRS for its services. The Plan has investments in pooled separate accounts and a GIC with SIC. The Plan pays SIC for its services. SRS and SIC are, therefore, by definition, parties-in-interest and, as a result, the Plan’s investment transactions pertaining to these investments were with parties-in-interest. Sowell Financial Services, LLC (“Sowell”) serves as investment advisors to the Plan and is therefore, by definition, a party-in-interest. The Plan pays Sowell for its services. The Plan also holds notes receivable from participants. As a result, these notes receivable and all related transactions were with parties-in-interest. All of these transactions were exempt from being prohibited transactions under ERISA.

8. Subsequent Events Evaluation Date

Management of the Plan evaluated the events and transactions subsequent to its December 31, 2024 financial statement date and determined there were no significant events necessary for disclosure through September 26, 2025, which is the financial statement issuance date.
