## NOTES TO FINANCIAL STATEMENTS for Years Ended December 31, 2024 and 2023

---

### NOTE A - DESCRIPTION OF PLAN

The following description of MicroSystems Automation Group (the Company) Retirement Plan (the Plan) provides only general information. Readers of these financial statements should refer to the Plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all eligible employees, who are at least 21 years of age. Employees are eligible for the Plan one month after the date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

Participants may elect to defer up to 100% of pre-tax and post-tax compensation, not to exceed the maximum allowable amount defined by the Internal Revenue Service. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Company provides discretionary matching contributions and discretionary nonelective contributions. Matching contributions are calculated based on participants' elective deferral contributions and participant compensation. The discretionary matching contribution 50% of participant contributions, up to 6% of compensation. Employer contributions are invested in funds, as directed by participants. The Company made contributions of \$106,802 and \$127,970 for the year ended December 31, 2024 and 2023, respectively.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's discretionary contribution, Plan earnings, losses, and Plan expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the vested balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50% and mature through February 2029. Loan terms range from one to five years except for the purchase of a primary residence. Principal and interest are paid ratably through semi-monthly payroll deductions.

#### **Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on eligible years of service. A participant is 100% vested after five years of credited service. In addition, participants become 100% vested in the case of death, permanent disability or upon attaining the age of 65.

### NOTE A - DESCRIPTION OF PLAN (continued)

#### ***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$29 and \$27,067 for each year, respectively. The forfeited non-vested accounts may be used at the discretion of the Company to reduce Company contributions or to pay administrative fees incurred by the plan. During the year ended December 31, 2024 and 2023, forfeitures in the amount of \$43,722 and \$59,456 were applied to employer contributions and administrative fees.

During the year ended December 31, 2024, forfeited accounts of \$31,411 were used to reinstate accounts of affected participants as a result of the partial plan termination. The Plan had a partial plan termination and affected participants that were not fully vested were not properly distributed funds from the Plan. The Plan reinstated these funds to participants through the forfeiture accounts.

#### ***Payment of Benefits***

On termination of service, death, or retirement, a participant is entitled to receive a distribution of the full amount in that participant's salary reduction and rollover contributions as well as his vested interest in the Company's contribution.

### NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### ***Basis of Accounting***

The financial statements of the Plan have been prepared using the accrual basis of accounting where revenues are recognized when earned and expenses are recognized when incurred. The accrual basis of accounting conforms to accounting principles generally accepted in the United States.

#### ***Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### ***Investment Valuation and Income Recognition***

At December 31, 2024, all of the Plan's invested assets are held at Charles Schwab Trust Bank, which invests funds based on the recommendations of each fund's manager. Investments are reported at fair value. Fair value is the sale price that would be received to sell an asset or price paid to transfer a liability in a typical transaction between market participants at the date of measurement. Plan management assesses and establishes the Plan's valuation policies using information provided by the custodians of the investments. See Note I for discussion of fair value measurements. Investment assets, transactions, and income as presented in the financial statements and supplemental schedule were certified by the trustees to be complete and accurate.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's realized and unrealized gains and losses on investments bought and sold, as well as held, during the year.

#### **Participant Loans**

Participant loans in the Plan are recognized when granted to eligible plan participants. The Plan recognizes these loans as assets on its balance sheet. Participant loans are initially measured at the principal amount disbursed to the participant and are subsequently measured based on the amortization of the loan balance. Interest is recognized using the effective interest rate method over the life of the loan.

#### **Plan Expenses**

Either the Plan or the Plan sponsor, as provided in the Plan document, pays administrative expenses of the Plan.

#### **Payment of Benefits**

Benefits are recorded when paid.

### NOTE C - INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank has certified that the following data included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate. Investments certified by the trustee totaled \$9,215,464 and \$9,721,097 as of December 31, 2024 and 2023, respectively. Investment gain totaled \$928,375 for the year ended 2024.

### NOTE D - RELATED PARTY TRANSACTIONS

Certain Plan investments are managed by Charles Schwab Trust Bank. USI Consulting Group is the Plan recordkeeper and third-party administrator (TPA) as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan totaled \$21,630 and \$19,986 for the years ended December 31, 2024 and 2023, respectively.

### NOTE E - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan in whole or in part subject to the provisions of ERISA. In the event of complete or partial Plan termination, the Plan assets shall be distributed in accordance with the terms of the Plan.

### NOTE F - PARTIAL PLAN TERMINATION

As a result of a reduction of the Plan Sponsor's workforce in 2024, the Plan experienced a partial plan termination as defined by ERISA in 2024. Under ERISA, a partial plan termination may occur if a twenty percentage or more of the Plan participants are terminated because of an action taken by the Plan Sponsor. If a partial plan termination occurs, full vesting in the employer's contribution is required for the affected participants, but the remaining participants' vesting continues to be determined per the plan provisions.

### NOTE G - TAX STATUS

The Internal Revenue Service has determined and informed the Company by letter that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

The Plan adopted the provisions of Statement of Financial Accounting Standard ASC Topic 740, *Income Taxes* (ASC 740). ASC 740 prescribes a comprehensive model for recognizing, measuring, presenting, and disclosing in the financial statements tax positions taken or expected to be taken on a tax return, including positions that the Plan took since issuance of ASC 740. The adoption of ASC 740 resulted in no changes to the Plan's beginning balances and net assets available for benefits.

With few exceptions, the Plan is no longer subject to income tax examination by the U.S. Federal, state, or local tax authorities beyond the last three years.

### NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### NOTE I - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### ***Money Market Funds***

The Plan's investments in money market funds are valued at the NAV of shares held by the Plan at year end based upon quoted market prices.

#### ***Mutual Funds***

These funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are generally open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

##### *Investment Contract*

This fund is valued at fair value by Standard Insurance Company (Standard) by discounting the related cash flows based on current yields of similar instruments with comparable duration considering the creditworthiness of the issuer. Since the participants transact at contract value, fair value is determined annually for financial statement reporting purposes only. In determining the reasonableness of the methodology, Plan management evaluates the methodology used by Standard in developing estimated fair value.

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefit as of December 31, 2024.

Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the end of the reporting period.

The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no significant transfers into or out of Levels 1, 2 or 3.

Unrealized gains and losses from the guaranteed investment contract are not included in the statement of changes in net assets available for benefits as the contract is recorded at contract value for purposes of the net assets available for benefits.

In deriving the fair value of the investments in Level 3 included in the financial statements, management relies on the third-party valuation provided by Standard Insurance Company. Management assesses the reasonableness of the general methodology used for such valuations and considers the reasonableness of the fair value balances provided considering prior year amounts, current year transactions, changes in overall economic conditions, and market developments.

### NOTE J - INVESTMENT CONTRACT WITH STANDARD INSURANCE COMPANY

The Plan has a benefit-responsive investment contract with Standard Insurance Company (Standard). Standard maintains the contributions in a general account, the Stable Asset Fund III, which is a Guaranteed Investment Contract (GIC). The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

For investment contracts that are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. This contract is included in the financial statements at contract value, as reported to the Plan by Standard. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Plan management has determined that contract value of \$181,235 and \$139,428 approximates fair value for this contract as of December 31, 2024 and 2023, respectively.

The GIC is a single group annuity contract with a fixed rate of interest. As a result, the average yield was 2.60% for the year ended December 31, 2024, and crediting interest rates were 2.60% and 2.45% as of December 31, 2024 and 2023, respectively.

### NOTE J - INVESTMENT CONTRACT WITH STANDARD INSURANCE COMPANY (continued)

There are no reserves against contract value for credit risk of the contract issuer or otherwise. Under the terms of the existing contract, the crediting interest rate is based on a formula agreed upon with the issuer.

The crediting rate is currently reset on a quarterly basis and will not be less than the guaranteed minimum interest rate of 1.00%.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events, which would limit the Plan's ability to transact at contract value with participants, are probable of occurring.

### NOTE K - SUBSEQUENT EVENTS

The Plan adopted Statement of Financial Accounting Standard ASC Topic 855, *Subsequent Events* (ASC 855). ASC 855 establishes general standards of accounting for and disclosure of events that occur after the balance sheet date but before the financial statements are issued or are available to be issued.

The Plan has evaluated subsequent events through September 24, 2025, the date the financial statements were available to be issued.
