Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Wildlife Gallery 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (an *ERISA Section 103(a)(3)(C) audit*). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Wildlife Gallery 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from *Capital Bank and Trust Company*, a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of The Wildlife Gallery 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about The Wildlife Gallery 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



NOTE 1 - Plan Description

The following description of The Wildlife Gallery 401(k) Plan (the "Plan") is sponsored by members of The Wildlife Gallery, as defined in the plan documents for the benefit of the participants. This information is provided for their eligible employees' purposes only. Participants should refer to the Plan agreement for more complete information.

- a) General – The Plan is a defined contribution plan covering full-time employees of The Wildlife Gallery and its affiliated companies (the "Company") and are age 18 or older and have completed three months of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- b) Contributions – Participants may contribute up to \$23,000 for 2024 and \$22,500 for 2023 of pretax annual compensation and for those aged 50 or older, catch-up contributions of an additional \$7,500 for 2024 and \$7,500 for 2023 may be made. Participants may also contribute rollover amounts, representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Employer contributions are discretionary. Employer matching and profit-sharing contributions are made at the discretion of the Plan sponsor.
- c) Participant Accounts – Each participant's account is credited with the participant's contribution and the Sponsor's matching contribution as well as allocations of the Sponsor's profit-sharing contribution and Plan earnings. Participant's accounts are charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- d) Payment of Benefits – Benefit payments of the plan are normally provided in the form of a lump sum payment. A participant is entitled to receive the balance held in his or her account upon reaching normal retirement age (65). Under certain conditions, early withdrawal may be made, with or without penalty depending on the circumstances. Upon death of a participant, the full value of his or her account shall automatically become 100% vested and is payable to his or her spouse and/or beneficiary.
- e) Vesting –
 1. Employee Contributions – A participant will always have 100 percent vested and non-forfeitable interest in his or her own contributions plus actual earnings thereon.
 2. Employer Contributions and Matching Contributions – after 1 year of service 33.33%, after 2 years of service 66.66%, and after 3 years of service 100% vested.
- f) Forfeitures – Any balance in the account of a participant, who has separated from service, to which he or she has no vested interest will be forfeited and will be used to reduce sponsors contributions to the Plan or pay administrative fees.

NOTE 1 - Plan Description (continued)

g) Note Receivable from Participants – Participants may borrow from their fund accounts subject to a minimum amount of \$1,000 as prescribed in the Plan and in the Internal Revenue Code. The maximum amount that can be borrowed is the lesser of:

- 50% of the vested balance of their account or
- \$50,000 (reduced by the highest prior 12-month outstanding loan balance)

In addition the total amount that may be outstanding as a loan during any 12-month period may not exceed \$50,000. Only two loans may be outstanding at one time. Loans bear interest at 2 percentage points above the prime rate and the rate is set for the duration of the loan. Repayment of the loan is normally made through payroll deduction in a level amortized amount within 5 years. The loans are secured by the vested balance of the participant's account.

h) Termination - The Company has the right to terminate the Plan. If the Plan is terminated, partially terminated or if there is a complete discontinuance of contributions under the Plan, all amounts credited to the accounts of participants shall become 100% vested and become non-forfeitable. In the event of termination, the employer shall direct the trustee to distribute accounts to or for the exclusive benefit of participants or their beneficiaries. The employer has no intentions to terminate the plan.

NOTE 2 - Summary of Significant Accounting Policies

The following is a summary of significant accounting policies followed by the Plan:

- a) Basis of Accounting - The financial statements of the plan are prepared on the accrual method of accounting.
- b) Investment Valuation and Income Recognition – The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Gains and losses (realized and unrealized) are included in net appreciation (depreciation) in the statement of changes in net assets available for benefits.

See Note 5 for additional information on fair value measurements.

- c) Administrative Expenses – Administrative expenses of the Plan paid by the Plan are related to the third-party administrator's fees, which are paid first out of forfeitures and trustee credits. The greater majority of plan costs and administrative fees are borne and paid by the Plan sponsor.
- d) Use of Estimates – The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

NOTE 2 - Summary of Significant Accounting Policies (continued)

- e) Participant Notes Receivable – Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible. If a participant leaves the Plan, any loan balance will be deducted from the distribution and considered a deemed distribution. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.
- f) Payment of Benefits - Benefits are recorded when paid.

NOTE 3 - Tax Status

The Plan is a prototype plan and relies on an opinion letter issued to the prototype sponsor which has obtained a favorable determination letter from the Internal Revenue Service, dated March 31, 2014, that the prototype plan is designed in accordance with applicable sections of the Internal Revenue Code.

NOTE 4 - Certification of Investment Information

Capital Bank and Trust Company, as Trustee and custodian of the Plan, have supplied the Plan administrator with certifications as to the completeness and accuracy of all the investments reflected in the accompanying *Statements of Net Assets Available for Benefits* at December 31, 2024 and 2023, the information in the December 31, 2024 *Schedule of Assets (Held at End of Year)*, and the related investment activity and interest income from participant notes receivable reflected in the *Statement of Changes in Net Assets Available for Benefits* for the year ended December 31, 2024.

NOTE 5 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows.

Level 1 Fair Value Measurements

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Fair Value Measurements

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in active markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Fair Value Measurements

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE 5 - Fair Value Measurements (continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily Net Asset Value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 6 - Related Party Transactions and Party-In-Interest

Certain Plan investments are shares of mutual funds managed by Capital Bank and Trust Company. Capital Bank and Trust Company is the trustee and, therefore, these transactions qualify as party-in-interest transactions. The Plan also pays fees to a third party administrator that qualify as party-in-interest transactions. The sponsor of the Plan pays costs of the Plan which are not included in these financial statements.

NOTE 7 - Forfeitures

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures may first be used to pay administrative expenses and then to reduce future Employer contributions. As of December 31, 2024, forfeited non-vested accounts total \$6,638.

NOTE 8 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 9 - Subsequent Events

The financial statements and related disclosures include evaluation of events up through August 11, 2025, the date of the auditor's report, which is the date the financial statements were available to be issued.
