Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of TLC, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of TLC, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the TLC, Inc. 401(k) plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution salary reduction and profit-sharing plan covering all eligible employees of the Company. The Plan has elected to be a Safe Harbor plan, under which the Company makes certain matching contributions to the Plan. The Company may also make other matching and discretionary profit-sharing contributions at the election of the Company’s board of directors. Other eligibility requirements apply to the employer non-safe harbor matching and discretionary profit-sharing contributions. The Plan is subject to the provisions of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (“ERISA”).

Three Lower Counties Community Services, Inc. (the “Company”) is the Plan administrator. Reliance Trust Company (“Reliance”) is the asset trustee. Automatic Data Processing, Inc. is the record keeper of the Plan. The Plan trustees are Brian Holland, Dana Malone, and Jennifer Swanton as of December 31, 2024.

Eligibility

All employees, except for mental health summer counselors, who are at least 18 years of age and have completed three months of service are eligible to participate in the plan. An employee’s entry date will be the first day that they meet the eligibility requirements.

Contributions

Each year participants may contribute up to 90% of annual compensation, as defined in the Plan, subject to the statutory limitations established by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers forty-six mutual funds and a self-directed brokerage fund option.

The Plan allows for employer non-safe harbor matching and profit-sharing contributions at the option of the Company’s Board of Directors. Non-safe harbor matching contributions may only be made in a year that the Company does not elect the Safe Harbor provision. Profit sharing amounts may be contributed at the option of the Company’s Board of Directors and are determined annually. For the Plan years ended December 31, 2024 and 2023 the Company did not make any non-safe harbor matching or profit sharing discretionary contributions to the Plan.

Contributions from Plan participants and the associated Company contributions are recorded in the year in which the employee contributions are withheld from compensation.

NOTE 1 – DESCRIPTION OF THE PLAN (Continued)

Participants' Accounts

Each participant's account is credited with the participant's contribution and allocations of a) the Company's contribution, and b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, and in all employer Safe Harbor contributions, plus actual earnings thereon. Vesting of the Company's non-Safe Harbor contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant becomes 20 percent vested in such contributions after two years of credited service, and an additional 20 percent vested for each additional year, with 100 vesting occurring on completion of the sixth year of service as defined by the Plan. A participant will also become fully vested upon attainment of normal retirement age, early retirement age, upon retirement due to disability, upon death, or upon termination of the Plan.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or fifty percent of their vested account balance. A Participant may have only one loan outstanding at any given time. The loans, which are evidenced by notes receivable, are secured by the balance in the Participant's account and bear interest at the prime rate plus 1%. Loan terms may not exceed five years unless the proceeds are used to buy a personal residence. Principal and interest is paid ratably through payroll deductions and all interest paid is credited to the Participant's account. Interest rates on outstanding loans as of December 31, 2024 and 2023 ranged from 4.25% to 9.50%.

Payment of Benefits

Upon termination of service due to death, full and permanent disability or retirement, participants may elect to receive either a single lump-sum amount equal to the value of their account, installments over a period of not more than the participants assumed life expectancy, or partial withdrawals of at least \$500. The Plan allows in-service withdrawals at age 59 ½ and hardship withdrawals under certain conditions as defined in the Plan document.

Forfeited Accounts

Forfeited non-vested amounts are to be used by the Company first to offset plan expenses and then to reduce any future employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0, for each of the years then ended.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting standards generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted within the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value as reported by Reliance Trust Company as of December 31, 2024. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (also see Note 3). Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the cash basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative costs not absorbed by the Company are absorbed by the Plan. Expenses that are paid by the Company are excluded from these financial statements. The Plan is not required to reimburse the Company for expenses the Company pays on behalf of the Plan. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan agreement.

NOTE 3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- * Quoted prices for similar assets or liabilities in active markets;
- * Quoted prices for identical or similar assets or liabilities in inactive markets;
- * Inputs other than quoted prices that are observable for the asset or liability;
- * Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Mutual funds represent investments with various investment managers. The mutual funds are valued at the daily closing net asset value (NAV) as reported by the fund. Mutual funds held by the Plan are registered with the Securities and Exchange Commission and are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed Brokerage Funds: Self-directed brokerage accounts may include mutual funds, equities, or certain fixed-income securities. These investments are valued by the administrator of the fund based on quoted market prices and are classified within Level 1 of the valuation hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan has no assets whose fair values are measured using Level 2 or Level 3 inputs, nor does it have any assets or liabilities valued on a non-recurring basis.

NOTE 4 - RELATED PARTIES AND PARTY-IN-INTEREST TRANSACTIONS

The Plan's investments include a self-directed brokerage fund and mutual funds managed by the Plan's trustee. Therefore, the transactions in these funds qualify as party-in-interest transactions. Personnel and facilities of the Company have been used to perform administrative functions for the Plan at no charge to the Plan. There were no financial transactions recorded between the Company and the Plan other than contributions made. Notes receivable from participants also qualify as party-in-interest transactions.

Fees paid by the Plan for investment advisory services totaled **\$54,796** and \$47,021 for the years ended December 31, 2024 and 2023, respectively. Fees paid by the Plan for the account services provided by the record keeper, Automatic Data Processing, Inc. ("ADP") totaled **\$11,073** and \$6,925 for the years ended December 31, 2024 and 2023, respectively.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 5 - INCOME TAX STATUS

The Plan utilizes the Non-standardized Profit-Sharing Plan with CODA as provided by ADP, LLC, which obtained its latest opinion letter on October 6, 2020, whereby the IRS stated that the Non-standardized Profit-Sharing Plan with CODA, as then designed, was in compliance with the applicable requirement of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter, however, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

NOTE 5 - INCOME TAX STATUS (Continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination. The plan administrator has analyzed tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; open years for filed returns: 2021 through 2023, returned to be filed in 2025: 2024.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, the net value of each participant's account shall become fully vested and no portion of the Plan's assets may be used for any purpose other than the exclusive benefit of the participants and their beneficiaries.

NOTE 7 - RISKS AND UNCERTAINTIES

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Assets Available for Benefits.

NOTE 8 - INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable held at December 31, 2024 and 2023, and net appreciation in the fair value of investments, interest, and dividends for the year ended December 31, 2024 was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company at December 31, 2024.
