### **NOTE A -- Description of the Plan and significant accounting policies**

The following description of the Hausmann Group, Inc. 401(k) Plan ("the Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. Hausmann Group, Inc. (the "employer") has adopted the CCH Incorporated, DBA ftwilliam.com Pre-Approved Profit Sharing Plan, originally effective January 1, 1999, with the most recent restatement effective January 1, 2021.

Effective July 1, 2023, the directors of Hausmann Group, Inc. approved the merger of the Ingenium Prime 401(k) Plan - BSG into the Hausmann Group, Inc. 401(k) Plan. As a result, all investments from the Ingenium Prime 401(k) Plan - BSG were transferred into the Hausmann Group, Inc. 401(k) Plan.

#### **General**

The Plan is a defined contribution Plan covering all eligible employees of Hausmann Group, Inc. who have 1 month of service and are age 21 or older. Enrollment in the Plan occurs on the first day of the month following, or coinciding with, the date a participant becomes eligible. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The 401(k) Retirement Plan Committee oversees governance of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

The Plan's federal identification number is 39-1090217 and the Plan's number is 002.

#### **Contributions**

Each year, participants may contribute up to 100% of annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution Plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Plan is a safe harbor plan and is intended to meet the 401(k) discrimination limits. The employer will make a safe harbor matching contribution equal to 100% of participant elective deferrals not exceeding 6% of compensation. The employer may also make a discretionary employer matching contribution and a qualified non-elective employer contribution. No discretionary employer matching or qualified non-elective employer contributions were made for 2024. Annual contributions from all sources are subject to certain limitations defined by the Internal Revenue Service (IRS).

### **NOTE A -- Description of the Plan and significant accounting policies (Continued)**

#### **Participant accounts and “rollovers”**

Each participant’s account is credited with the participant’s contribution and allocations of (a) the employer’s safe harbor and discretionary contribution, (b) Plan earnings and (c) charged with an allocation of administrative expenses. Allocations of Plan earnings are based on participant account balances, as defined, and allocation of employer contributions are based on participant compensation, as provided in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. The Plan permits the transfer of funds from other qualified Plans to a separate participant’s rollover account.

#### **Vesting**

Participants are immediately vested in their contributions, rollovers, qualified non-elective contributions, employer matching contributions, and non-elective contributions plus actual earnings thereon. Vesting in the employer’s safe harbor matching contribution is based on years of continuous service. A participant is 100% vested after 2 years of credited service. Participants who leave the Plan because of death, disability, or reach normal retirement age (59 ½), as defined in the Plan, are considered 100% vested in all amounts.

#### **Notes receivable from participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant’s account and bear interest a fixed rate that is determined as 1% over the Prime Rate (7.50% at December 31, 2024). Principal and interest is paid ratably through payroll deductions.

#### **Benefits**

On termination of service due to death, disability, or retirement (age 59 ½), or termination, participants may elect to receive either a lump-sum amount or substantially equal installments, payable at least annually, over periods specified in the Plan document. The Plan permits hardship distributions and qualified birth or adoption distributions if certain criteria are met. The Plan permits in-service distributions at normal retirement age. A participant with an inactive account valued at less than \$1,000 shall receive a lump-sum distribution. For inactive accounts between \$1,000 and \$5,000, the participant will receive an automatic distribution to an individual retirement account.

#### **Forfeited accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$3,318 and \$3,185, respectively. These accounts will be used to reduce future employer contributions or pay Plan expenses. No forfeited accounts were used to reduce employer contributions or Plan expenses in 2024.

A summary of significant accounting policies follows:

#### **Basis of accounting**

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) under the accrual method of accounting.

Investments held by a defined contribution Plan are required to be reported at fair value, except for benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits or a defined contribution Plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

#### **Use of estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment valuation and income recognition**

The Plan's investments (except for fully benefit-responsive investment contracts, which are reported at contract value) are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The 401(k) Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Payment of benefits**

Benefits are recorded when paid.

#### **Administrative fees**

The employer pays certain expenses on behalf of the Plan which are excluded from these financial statements. The major administrative expenses are payroll and related expenses.

#### **Notes receivable from participants**

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and December 31, 2023, no allowance for credit losses has been recorded.

U.S. GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Self-directed brokerage account. Self-directed brokerage account primarily includes equity securities. Equity securities are valued at the closing price reported on the active market on which individual securities are traded.
- Common collective trust fund. The common collective trust is composed primarily of fully-benefit responsive investment contracts that are valued at the net asset value of units of the collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the funds will sell the investment for an amount different from the reported net asset value.
- Pooled separate accounts. The pooled separate accounts are invested in investments such as stocks, mutual funds, short-term investments, bonds, etc. Voya owns the underlying investments in the separate accounts. The underlying measurements for the separate key prices for similar assets in active or non-active markets. While the underlying asset values are quoted prices, the net asset value of the separate account is not public quoted.

Gains and losses (realized and unrealized) included in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, are reported in net appreciation in fair value of investments. Unrealized gains (losses) from the guaranteed investment contract are not reported in the statement of changes in net assets available for benefits as the contract is recorded at contract value for presentation in the net assets available for benefits.

**NOTE D -- Guaranteed investment contract with insurance company**

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Voya. Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the Statements of Net Assets Available for Benefits at contract value. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$1,425,685 and \$1,272,108, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1%. Such interest rates are reviewed on a monthly basis.

Certain events limit the Plan's ability to transact at contract value with Voya. Such events include the following: (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**NOTE E -- Party-in-interest transactions**

Voya is the asset custodian of the Plan and is therefore designated as a fiduciary and party-in-interest. These party-in-interest transactions occur in the course of ordinary business and are exempt transactions. The Plan also pays Voya certain transaction fees in the course of providing recordkeeping services to the Plan. These fees are generally charged directly to the participant account balance for which the transactions relate.

### **NOTE E -- Party-in-interest transactions (Continued)**

Fees were also paid by the Plan during the year for advisory and administrative services rendered to Park Capital Management and Peak Retirement Group, respectively. These transactions also qualify as party-in-interest transactions.

### **NOTE F -- Concentration of market risks**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

### **NOTE G -- Tax status**

The CCH Incorporated, DBA ftwilliam.com Pre-Approved Profit Sharing Plan that the Plan adopted effective January 1, 2021, obtained its latest opinion letter on June 30, 2020, in which the IRS stated that the prototype Plan, as then designed, was acceptable under Section 401 of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. The Plan has been amended since the date of the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

### **NOTE H -- Plan termination**

Although it has not expressed any intent to do so, the employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer safe harbor matching contributions.

### **NOTE I -- Plan amendments**

Effective January 1, 2023, the Plan was amended to (1) change the service requirement for Plan participation to 1 month of service; (2) add an auto-enrollment provision whereby all eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate; (3) change from a safe harbor match to a qualified automatic contribution arrangement (QACA) safe harbor match; (4) add a 2-year vesting period for all QACA contributions; and (5) allow participants who terminated services to elect either a lump-sum, substantially equal installment payments, or partial distributions.

Effective July 1, 2023, the Plan was amended to (1) change the Plan name to Hausmann Group, Inc. 401(k) Plan; (2) merge with the IngeniumPrime, Inc. 401(k) Plan - BSG; and (3) include years of service with the Benefit Services Group Inc. for eligibility and vesting purposes.

**Note J -- Subsequent event**

Effective January 1, 2025, the Plan was amended to change the period for determining the safe harbor matching contribution to the end of the Plan year.
