The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following brief description of the Section 403(b) Retirement Plan for Employees of Odyssey House, Inc. of New York (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan, which is intended to qualify under Section 403(b) of the Internal Revenue Code (“IRC”). The Plan was established effective July 1, 1991. Effective June 1, 2020 the Plan was restated to adopt Lincoln Financial Group Volume Submitter 403(b) Plan for Internal Revenue Service (“IRS”) Code Section 501(c)(3) Tax-Exempt Organizations. The Plan is sponsored by the Odyssey House, Inc. (the “Organization”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

On March 19, 2019, Lincoln Financial Group Trust Company, Inc. (“Lincoln” or “Custodian”) became the custodian of the Plan.

Eligibility – All employees are eligible to participate in the Plan beginning on the first day of calendar month of employment. To be eligible to receive the Organization’s contributions to the Plan (as described below), the employee must have two years of service (a year of service means the completion of at least 1,000 hours of service) without an intervening break of service.

Contributions – Each year, participants may contribute up to the maximum percentage of pre-tax annual compensation, as defined by the Plan, allowable under the IRC. From time to time the pretax contributions of certain employees, designated as highly compensated employees under IRC rules, may be limited so that the Plan may satisfy various nondiscrimination tests required under applicable Federal regulations. Also, in accordance with IRS guidelines, participants could not make contributions exceeding \$23,000 for 2024. Eligible employees may make an additional employee contribution known as a “catch-up” contribution in accordance with the Economic Growth and Tax Relief Reconciliation Act of 2001 (“EGTRRA”). Catch-up contributions were limited to \$7,500 for 2024. Participants direct investments of their contributions into various investment options offered by the Plan.

Each year, in addition to depositing participant elective deferrals, the Organization may contribute non-elective contributions to the Plan based upon a percentage of each participant’s eligible wages. A non-elective contribution is a contribution the Organization makes to the Plan which is unrelated to whether a participant makes any elective deferrals in that year. A participant employed during the Plan year may share in the Employer’s non-elective contribution for that Plan year regardless of the amount of service during the Plan year. Student employees and employees who normally work less than 20 hours per week are excluded from the non-elective contributions. The employer basic contribution percentage is based on years of service (more than 2 years, but less than 5 years contribution is 3.5%; 5 or more years but, less than 10 years contribution is 6%; 10 or more years contribution is 10%) on behalf of eligible participants. For the year ended December 31, 2024 the non-elective contribution was \$896,030.

Eligible wages are defined as W-2 wages, less fringe benefits, bonuses, disability compensation and overtime.

Rollovers – Rollover contributions are permitted into the Plan in accordance with IRS regulations and plan provisions.

1. DESCRIPTION OF THE PLAN (continued)

Participant Accounts – A separate account is maintained for each participant. Each participant's account is credited with his or her contribution, the Organization's contribution and Plan earnings (losses). Allocations of earnings or losses are based upon the investment performance of the individual funds in which each participant's account balance is invested. Participant accounts are charged with an allocation of administrative expenses which are paid by the participants. Participants may change their investment elections at any time through the Plan's administrator. The benefit to which a participant is entitled is the benefit that can be provided from a participant's vested account.

Vesting – Plan participants are fully vested in their rollover contribution, salary deferral contributions, the Organization's contribution, plus actual earnings thereon. Participants are 100% vested at all times in all accounts.

Forfeited Accounts – Forfeited balances of participants' non-vested accounts are used to reduce future employer contributions and may be used to pay Plan expenses. For the years ended December 31, 2024 and 2023, unallocated forfeitures totaled \$686 and \$2,212, respectively. For the year ended December 31, 2024, \$2,234 was utilized to reduce employer contributions.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of 50% of their vested account balance not to exceed \$50,000. Primarily, loan terms range from 1 to 5 years or up to 15 years for the purchase of a primary residence. Participant loans are secured by the remaining vested balance in the participant's account and bear interest at a reasonable rate as determined by the Plan administrator based upon prevailing interest rates at the time the loan is entered into. Notes receivable outstanding have interest rates ranging from 4.25% to 9.5% and have maturity dates through December 2032. Upon termination of employment, the participant may either repay any outstanding balance in full or incur a tax liability on the unpaid balance. Principal and interest is paid ratably through biweekly payroll deductions.

Distributions – Benefits will normally be distributed to a participant, or his or her beneficiary upon death, disability, or retirement. Benefits are distributed out as a single lump-sum payment, partial payment, installment payment or an annuity contract. Participants are permitted to process in-service withdrawals, in accordance with Plan provisions upon attaining age 59 ½ or for hardship in certain circumstances as defined in the Plan agreement.

Hardship Withdrawals – Participants may withdraw their employee pre-tax contributions and rollover contributions, if applicable, to satisfy immediate and heavy financial needs. In accordance with IRS regulations, participants must first exhaust all other assets available before obtaining a hardship withdrawal.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment

contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Valuation of Investments and Income Recognition – Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Notes 4 and 5 for descriptions of fair value measurements and fully benefit-responsive investment contracts.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Use of Estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect reported amounts of assets and liabilities and changes there in, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included as administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based upon the terms of the Plan agreement.

Administrative Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants' accounts and are included in administrative expenses. Expenses attributable to the administration or operation of the Plan are allocated pro rata on the basis of account balances to the account balances of all participants. Investment related expenses are included in the net appreciation/depreciation of fair value of investments.

Payment of Benefits – Benefit payments to participants are recorded when paid.

3. INFORMATION CERTIFIED BY CUSTODIAN (UNAUDITED)

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan's management instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Lincoln, except for comparing such information certified by the Custodian with information included in the Plan's financial statements and the supplemental schedule of Form 5500, Schedule H, Part IV, Line 4i – Schedule of Assets (Held At End of Year).

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 — Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 — Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 — Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

5. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan invests in the Lincoln Financial Stable Value Account. The Lincoln Financial Group Stable Value Account is a fully benefit-responsive guaranteed fixed annuity contract available as an investment option to Plan participants. The fixed annuity contract is issued by Lincoln National Life Insurance Company (“Lincoln Life”). Lincoln Life maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals. The fixed annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the fixed annuity contract is fully benefit-responsive, contract value is the relevant measurement attributable for that portion of the net assets available for benefits of a defined-contribution plan attributable to the fixed annuity contract. Contract value, as reported to the Plan by Lincoln, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct withdrawals or transfers of all or a portion of their investment at contract value.

The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1.70%. Such interest rates are reviewed on a quarterly basis for resetting. In 2024 and 2023, the crediting interest rate and the yield for the fixed annuity contract was 2.30% and 2.10%, respectively. The contract value was \$3,875,532 and \$4,473,392 at December 31, 2024 and 2023, respectively.

Certain events may limit the Plan’s ability to transact at contract value with Lincoln Life. Such events include the following (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the Plan’s ability to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

6. FEDERAL INCOME TAX STATUS

The Plan's sponsor adopted Lincoln Volume Submitter 403(b) plan for Code Section 501 (c) (3) Tax-Exempt Organizations. The Plan is required to operate in accordance with the IRC to maintain its tax exemption. The Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the federal or state taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

7. PLAN TERMINATION

Although the Organization has not expressed any intention to do so, the Organization reserves the right to modify, suspend, amend or terminate the Plan in whole or in part at any time subject to the provisions of ERISA. If the Plan is terminated, the amounts credited to the employer contribution accounts of all participants become fully vested.

8. RELATED PARTY AND TRANSACTIONS WITH PARTIES-IN-INTEREST

Certain Plan investments are mutual funds and stable value fund with Lincoln Life. Lincoln serves as the Custodian. Loans to participants are secured by the balances in respective participant accounts. Those transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules. Administrative fees paid to Lincoln totaled \$43,754 for the year ended December 31, 2024.

9. SECURE ACT 2.0

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included the Setting Every Community Up for Retirement Enhancement ("SECURE") Act 2.0. The SECURE Act 2.0 contains over ninety new retirement provisions, with varying effective dates through 2027. Since the SECURE Act 2.0 provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. Applicable provisions outlined in the SECURE Act 2.0 will be adopted if elected and/or required. The Plan Administrator did not adopt any of the optional provisions for 2024 and accordingly, there was no material impact to the Plan's 2024 financial statements.

10. RISK AND UNCERTAINTIES

The Plan invests in various securities including mutual funds and stable value fund. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and, that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
