### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Fort Wayne Metals Research Products, LLC Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ## **Note 1. Plan Description**

The Fort Wayne Metals Research Products, LLC Retirement Savings Plan (the "Plan") is a defined contribution plan sponsored by Fort Wayne Metals Research Products, LLC (the "Employer"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, (ERISA). The provisions of the Plan are included in the official Plan document which legally governs the operations of the Plan and is available for more detailed information.

### Eligibility

To be eligible to participate in the Plan, employees must be 18 years of age or older, have completed 30 days of service and may not be a union employee or a seasonal employee scheduled for less than 1,000 hours of service. Employees may enter the Plan on the first day of the month following the completion of all eligibility requirements.

### Employee Contributions

Participants may elect to contribute up to 100% of eligible compensation up to the statutory dollar limit established by the Internal Revenue Code. Participants who have attained age 50, before the end of the Plan year, are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

### Employer Contributions

The Employer contributes a match contribution equal to 50% of the participant's elective deferral up to 7% of the participant's compensation, calculated annually. The Employer may also make discretionary profit sharing contributions, determined annually. For 2024, the Employer discretionary profit sharing contribution was 1.00% of eligible compensation. Profit sharing contributions are allocated to each eligible participant's account in the ratio that each eligible participant's compensation bears to the total of all eligible participants' compensation. To be eligible for the profit sharing contribution, participants must be employed on the last day of the Plan year, unless the participant terminated during the Plan year due to retirement, death or disability.

### Participant Accounts

Each participant's account is credited with the participant's contribution, employer match contribution, an allocation of the Employer's profit sharing contribution and Plan earnings and is charged with an allocation of expenses. Allocations of the Plan earnings and expenses are based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## **Note 1. Plan Description (Continued)**

### Vesting

Participants are immediately vested in their elective (voluntary) contributions and income or loss thereon. Vesting in the Employer's contributions is based on years of service. A participant becomes fully vested after three years of credited service (1,000 hours of service in a calendar year). Participants also become fully vested upon attainment of normal retirement age, disability, death and termination of the Plan.

### Forfeitures

Participants who terminate employment prior to becoming fully vested must forfeit their Employer contributions. These forfeitures are used to reduce future Employer contributions or pay Plan expenses. At December 31, 2024 and 2023, unallocated forfeitures were approximately \$1,000 and \$17,000, respectively. Forfeitures totaling approximately \$182,000 were used to reduce Employer contributions and pay Plan expenses during the Plan year ended December 31, 2024.

### Notes Receivable from Participants

The Plan allows participants to borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of employee contributions and rollovers. Loans are typically for terms up to 5 years, but may be for a longer period if the purpose of the loan is for a principal residence. The loans are secured by the balance in the participant's account and bear a reasonable fixed rate of interest, which is determined by the Plan administrator at origination. At December 31, 2024, rates on outstanding loans ranged from 5.25% to 10.50% and the loans mature through May 2053.

### Benefit Payments

Benefit payments are payable as a single lump-sum payment, installments, or partial withdrawals. The full value of a participant's account is payable upon retirement, death or disability. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump-sum payment.

### Termination of the Plan

Although the Employer has not expressed any intent to terminate the Plan, it may do so at any time, subject to the provisions set forth in ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

## **Note 2. Significant Accounting Policies**

### Basis of Financial Statements

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Stable value funds held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive stable value funds, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. However, these funds qualify for measuring fair value using the net asset value (NAV) practical expedient. This NAV represents the Plan's fair value since this is the NAV at which the Plan transacts with the fund.

### Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's custodian determines the Plan's valuation policies utilizing information provided by the investment advisers and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### Payment of Benefits

Payment of benefits to participants are recorded when paid.

### Investment Expenses

Investment related expenses are included in net appreciation of fair value of investments.

### Subsequent Events

The Plan administrator has evaluated events and transactions for possible recognition or disclosure through September 23, 2025, the date the financial statements were available to be issued.

## **Note 3. Information Certified by the Plan's Custodian**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by Empower Trust Company, LLC (the custodian), and was not subjected to any auditing procedures performed by the independent public accountants.

- a. Total investments and notes receivable from participants as shown in the accompanying statements of net assets available for benefits.
- b. Net investment income, as shown in the accompanying statement of changes in net assets available for benefits, including interest and dividend income, net realized and unrealized appreciation in fair value of investments and interest income on notes receivable from participants.
- c. The supplemental schedule of assets (held at end of year).

## **Note 4. Fair Value Measurements**

Fair value measurements are based upon the exit price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants, and are determined by either the principal market or the most advantageous market.

Inputs used in the valuation techniques to derive fair values are classified based on a three-level hierarchy to prioritize the inputs used in the valuation techniques to derive fair values. The basis for fair value measurements for each level within the hierarchy is described below with Level 1 measurements having the highest priority and Level 3 measurements having the lowest priority.

Level 1: Fair value is based on unadjusted quoted prices for identical assets or liabilities in an active market that the Plan has the ability to access at the measurement date.

Level 2: Fair value is based on quoted prices in markets that are not active, quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Fair value is based on prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable.

The asset's or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques and inputs used for each major class of assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Stable value fund:* A stable fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value of units of the fund. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the fund, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Mutual funds:* Valued at quoted market prices, which represent the net asset values (NAV) of shares held by the Plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## **Note 6. Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

Certain Plan investments at December 31, 2023, were shares of an investment contract managed by the custodian as defined by the Plan and, therefore, those transactions qualify as party-in-interest transactions. Notes receivable from participant transactions are also party-in interest transactions. Certain administrative expenses may be paid by the Employer on behalf of the Plan from time to time. The Employer also provides certain administrative services at no cost to the Plan.

## **Note 7. Income Tax Status**

On November 14, 2022, the Internal Revenue Service stated that the prototype adopted by the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

## **Note 8. Risks and Uncertainties**

The Plan may invest in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
