Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Redwood Living, Inc. 401(k) Plan Employee Benefit Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Redwood Living, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

Note 1 - Description of Plan

The following description of the Redwood Living, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution retirement plan that was established effective April 1, 2014, and restated January 1, 2022. The Plan covers all employees of Redwood Living, Inc. (the Company), excluding interns, temporary employees, and seasonal employees. Employees who have attained the age of 18 and have 60 days of service are eligible to participate in the Plan on the first day of the subsequent month when eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Company is responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance.

Contributions

Participants may contribute, through payroll deductions, up to 100% of pretax annual compensation as defined in the Plan document, subject to limitations under the Internal Revenue Code (IRC). Active participants who are age 50 or older are eligible to make catch-up contributions, subject to limitations under the IRC. For the years ended December 31, 2024 and 2023, maximum contributions allowed by the IRC were \$23,000 (\$30,500 for active employees age 50 or older) and \$22,500 (\$30,000 for active employees age 50 or older), respectively. Participants may also make rollover contributions to the Plan from other qualified defined benefit or defined contribution plans.

The Company can make employer matching contributions and safe harbor matching contributions to the Plan. The Company's safe harbor matching contribution is 100% of the participant's elective deferrals that do not exceed 3% of the participant's compensation, plus 50% of the amount of the participant's elective deferrals that exceed 3% of the participant's compensation, not to exceed 5% of the participant's compensation. For the years ended December 31, 2024 and 2023, there were no employer matching contributions to the Plan. For the years ended December 31, 2024 and 2023, safe harbor matching contributions were \$1,490,354 and \$1,311,130, respectively.

Effective August 31, 2023, the Plan was amended. As a result of the amendment, the safe harbor matching contributions were based on the Plan year instead of each payroll period.

The Company may, at its sole discretion, make profit sharing and non-elective contributions to the Plan. For the years ended December 31, 2024 and 2023, there were no profit sharing or non-elective contributions to the Plan.

The plan includes an automatic-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan. Automatically enrolled participants will have their deferral rate set at 3% of eligible compensation. Employees maintain the right to decline participation in the Plan but must complete and submit the appropriate forms to suspend their account within 90 days of the first automatic deferral.

Investment Options

Participants are able to direct their contributions into a variety of investment options offered by the Plan. Participants may change their investment options at any time.

Note 1 - Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the Company's safe harbor matching contributions, and allocations of the Plan's earnings. Allocation of the Plan's earnings is based on each participant's relative account balance. The benefit to which a participant is entitled is the amount that can be provided from the participant's vested account. Participant accounts are charged with an allocation of administrative expenses.

Vesting

Participants are immediately vested in their elective deferrals, rollover contributions, and the Company's safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's matching contributions, profit sharing contributions, and non-elective contributions plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after 4 years of credited service. The vesting schedule for the Company's matching contributions, profit sharing contributions, and non-elective contributions is as follows: less than one year of service - 0%, 1 year - 25%, 2 years - 50%, 3 years - 75%, 4 or more - 100%. Participants also become 100% vested in their accounts upon attainment of normal retirement age of 65 or separation of service due to disability or death.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The maximum number of loans outstanding at any given time shall not exceed one loan. The loans are secured by the balances in the participants' account and bear interest at the Prime rate plus 2.00%, which is determined on the loan origination date and based on the rates available for similar loans from commercial lending institutions. Principal and interest are paid through payroll deductions over a period not to exceed 5 years, except in the case of a loan for the purchase of a principal residence which shall be paid over a period not to exceed 15 years.

Financial Hardship Withdrawals

Participants may receive a hardship distribution of their vested account balance resulting from elective deferral contributions in the event of undue financial hardship. A participant who receives a hardship distribution of elective deferral contributions will not be prohibited from making elective deferrals after receipt of distribution.

Payment of Benefits

Upon reaching normal retirement age of 65, termination of service due to death, disability, or separation, a participant may elect to receive a distribution in the form of a lump-sum payment or substantially equal installments to the value of the participant's vested interest in his or her account. A participant may also receive an in-service distribution upon attainment of age 59 ½. Upon termination, a participant with an account balance under \$5,000 will automatically receive a payout equal to the value of the participant's vested interest in a lump-sum payment.

Participants who took a Coronavirus-related distribution could spread the income over a three-year period for income tax purposes or avoid income taxes if the distribution is repaid within the three-year period following the distribution. During the years ended December 31, 2024 and 2023, there were no distribution repayments related to Coronavirus-related distributions.

Forfeited Accounts

Forfeitures are created when participants terminate employment prior to becoming entitled to full benefits. Forfeitures can be used to offset administrative expenses or reduce future employer contributions. At December 31, 2024 and 2023, forfeited accounts totaled \$11 and \$14,875, respectively. During the years ended December 31, 2024 and 2023, forfeitures used to offset administrative expenses or reduce future employer contributions were \$15,052 and \$0, respectively.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, except for the Plan's fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisor and trustee, as applicable. See Note 3 for discussion of fair value measurements and Note 4 for discussion on the fully benefit-responsive investment contract.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in the fair value of investments includes the Plan's realized gains and the unrealized appreciation on investments bought and sold as well as held during the year. Dividend income is recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Administrative expenses are paid by the Plan or the Company, at the discretion of the Company. Expenses that are paid by the Company are excluded from these financial statements.

Note 3 – Fair Value Measurements

Fair Value Hierarchy

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology are observable inputs, other than Level 1 prices, such as quoted prices for similar assets or liabilities in active markets, quoted prices in markets that were not sufficiently active to qualify as Level 1, other observable inputs, or inputs that can be corroborated by observable market data for substantially the full term of the assets or liabilities. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are significant to the fair value measurement and unobservable (for example, supported by little or no market activity).

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023:

- Pooled Separate Accounts – Stated at fair value as determined by the issuers of the pooled separate accounts based on the net asset value (NAV) of the underlying investments. The NAV as provided by Voya Retirement Insurance and Annuity Company is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the funds less its liabilities. This practical expedient is not used when it is determined to be probable that the funds will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the pooled separate accounts, the investment advisor reserves the right to temporarily delay withdrawal from the funds in order to ensure that securities liquidations will be carried out in an orderly business manner.

Note 4 – Investments in Fully Benefit-Responsive Investment Contract

The Plan holds a traditional fully benefit-responsive guaranteed investment contract, for which contributions are maintained in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and interest at the specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer that is subject to a minimum interest rate. The crediting rate is reviewed on an annual basis for resetting. The contract cannot be terminated before the scheduled maturity date. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value.

The Voya Fixed Account investment objective is to maintain stability of principal through underlying assets which maintain an average S&P credit quality. Participant transactions (purchases and sales) may occur daily. All other withdrawals of assets may be delayed for up to twelve months at the sole discretion of the trustee.

As of December 31, 2024 and 2023, the contract value of the fully benefit-responsive investment contract was \$51,729 and \$71,282, respectively.

Note 4 – Investments in Fully Benefit-Responsive Investment Contract (Continued)

Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya Retirement Insurance and Annuity Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the Plan to transact at contract value with the issuer.

Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

Note 5 – Information Prepared and Certified by the Trustee

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. All investment and notes receivable from participants information disclosed in the accompanying financial statements and supplemental schedule, Schedule H, Line 4i – Schedule of Assets (Held at End of Year), including investments and notes receivable held as of December 31, 2024 and 2023, net appreciation in fair value of share of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Voya Retirement Insurance and Annuity Company. As elected by the Plan administrator, no auditing procedures have been performed on this information except to compare such information to the information included in the accompanying financial statements.

Note 6 – Parties-in-Interest

Transactions that qualify as parties-in-interest consist of purchases and sales of pooled separate accounts and the fully benefit-responsive investment contract of Voya Retirement Insurance and Annuity Company, the trustee of the Plan, for the years ended December 31, 2024 and 2023. Loans to participants are also considered party-in-interest transactions as such participants are employed by the Company. These party-in-interest transactions are exempt for the prohibited rules under ERISA.

The Plan was under contract with Voya Retirement Insurance and Annuity Company for the years ended December 31, 2024 and 2023 to provide various administrative services. Fees paid by the Plan for those services for the years ended December 31, 2024 and 2023 were \$39,175 and \$60,123, respectively.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

Note 8 – Tax Status

The Plan adopted a Non-Standardized Pre-Approved Profit Sharing Plan with a cash or deferral arrangement offered by CBIZ Benefits & Insurance Services, Inc. The Non-Standardized Pre-Approved Plan received an IRS opinion letter dated June 30, 2020, stating that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9 – Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10 – Subsequent Events
