We have performed an audit of the financial statements of Ammonoosuc Community Health Services 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion on the 2024 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section:

- The amounts and disclosures in the accompanying 2024 financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with U.S. generally accepted accounting principles (U.S. GAAP).
- The information in the accompanying 2024 financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion on the 2024 Financial Statements**

We conducted our audit in accordance with U.S. generally accepted auditing standards (U.S. GAAS). Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with U.S. GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the 2024 financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Other Matters**

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Their report dated September 26, 2024 indicated that in their opinion (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with U.S. GAAP, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). ### 1. Description of Plan

The following description of Ammonoosuc Community Health Services 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan that covers all employees of Ammonoosuc Community Health Services, Inc. (the Organization). The Plan was adopted on August 1, 2008 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Standard Retirement Services, Inc. (Standard) is the recordkeeper of the Plan, Reliance Trust Company (Reliance) is the trustee and a custodian, Empower Trust Company, LLC (Empower) is a custodian, and Talcott Resolution Life Insurance Company (Talcott) is a custodian.

#### Eligibility

The Plan is available to all Company employees.

#### Vesting

Participants are immediately vested in their elected deferral contributions and actual earnings thereon. Participants earn vesting in the Organization's contributions based on years of service. A participant's vested interest in their account derived from the Organization's contributions and actual earnings thereon vests ratably over five years.

Participants are fully vested in their account derived from the Organization's contributions and actual earnings thereon upon attaining normal retirement age (age 65), death, or becoming permanently and totally disabled.

#### Contributions

Each year, eligible participants may make contributions to the Plan through salary deferrals on a pre-tax and Roth basis up to 100% of eligible compensation, as defined in the Plan. The maximum amount that a participant may contribute is limited by provisions of the Internal Revenue Code (IRC).

The Plan may provide, at its discretion, employer matching and non-elective contributions to eligible participants. To receive a discretionary non-elective contribution, the participant must be employed with the Organization on the last day of the Plan year. Employer contributions vest ratably over five years of service. An employee must complete 1,000 hours of service during the Plan year to receive credit for a year of service. Per diem employees and employees who normally work less than 20 hours per week are not eligible for employer contributions.

The Organization approved a 50% matching contribution up to 6% of salary deferrals for the year ended December 31, 2024.

### **Participant Accounts**

Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's contributions and an allocation of plan earnings and losses. A participant's account shall be reduced by any distributions and certain administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Investments**

Upon enrollment in the Plan, a participant may direct his or her account balance amount in the various investments offered by the Plan and may change between investments at any time. The Plan currently offers investments in shares of mutual funds, pooled separate accounts, and fixed income accounts.

### **Notes Receivable from Participants**

Participants may borrow from their accounts up to the lesser of \$50,000 or 50% of their account balance. Loan terms may not exceed five years unless the purpose of the loan is for the purchase of a principal residence. The loans are secured by the balance of the participant's account and bear interest at a rate commensurate with local prevailing rates, as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions. Participants may have only one loan outstanding at a time, unless one loan is a principal residence loan.

### **Payment of Benefits**

Participants shall become eligible to withdraw their vested account balances upon retirement (normal retirement age is 65), death, disability or termination of employment. In-service benefit payments may be taken upon reaching age 59-1/2. Participants may receive their benefit payments in a single lump sum, installment, or monthly annuity.

### **Forfeited Accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$5,109 and \$813, respectively. These accounts will be used to reduce future Company contributions or pay administrative expenses. In 2024, \$2,000 of forfeited nonvested accounts were used to pay administrative expenses.

## 2. **Summary of Significant Accounting Policies**

### **Use of Estimates**

The preparation of financial statements in conformity with the U.S. generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value, except for the fixed income accounts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for a discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

### **Notes Receivable from Participants**

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan agreement.

### **Administrative Expenses**

The Plan allows for payment of any expenses incurred in administering the Plan to be paid by either the Organization or the Plan. For the year ended December 31, 2024, the Plan paid for \$47,906 of the administrative expenses related to Plan administration, with remaining expenses paid by the Organization. Expenses paid by the Organization are not reflected in these financial statements.

### **Payment of Benefits**

Benefit payments to participants are recorded upon distribution.

### **Subsequent Events**

Management has considered transactions or events occurring through September 24, 2025, the date the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

### **3. Income Tax Status**

The Organization has adopted the Standard Volume Submitter 403(b) Plan, which received a favorable advisory letter dated March 31, 2017, from the Internal Revenue Service stating that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the advisory letter. However, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

### 4. Information Prepared and Certified by Trustee and Custodians

Certain investments, investment transactions, net appreciation in fair value of investments, and interest and dividends were obtained by management and agreed to or derived from the information certified by Reliance, Empower, and Talcott as complete and accurate. This information is included in the following:

- Statements of Net Assets Available for Benefits
- Statement of Changes in Net Assets Available for Benefits
- Schedule H, line 4i - Schedule of Assets (Held at End of Year)

### 5. Parties-in-Interest Transactions

Certain Plan investments are managed by the Standard and Talcott; therefore, these transactions qualify as party-in-interest transactions. Administrative expenses paid by the Plan and notes receivable from participants are also party-in-interest transactions.

### 6. Fair Value Measurement

U.S. GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Topic 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Mutual funds were valued at the published amounts of shares held by the Plan at year end.

Pooled separate accounts are valued using the market approach based on the underlying net asset value of units held by the Plan at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 7. Fixed Income Accounts

At December 31, 2024 and 2023, \$378,163 and \$672,836, respectively, of Plan assets were invested in a deposit administration contract held by the Standard, which was determined to be fully benefit-responsive. Contract value, as reported to the Plan by the Standard, represents contributions made under the contract plus earnings, less participant withdrawals and administrative expenses. Participants were able to direct the withdrawal or transfer all or a portion of their investments at contract value. There were no reserves against contract value for credit risk of the contract issuer or otherwise. Nominal interest rates are adjusted quarterly. The plan administrator did not believe there were any events that would limit the Plan's ability to transact at contract value at December 31, 2024 and 2023.

At December 31, 2024 and 2023, \$148,267 and \$288,482, respectively, was invested in a general account at Talcott. Contract value, as reported to the Plan by Talcott, represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. These assets are held by participants who are no longer employed by the Organization. The participants, but not the Organization, can direct the withdrawal or transfer of the investment at contract value. There were no reserves against contract value for credit risk of the contract issuer or otherwise. The plan administrator did not believe there were any events that would limit the participant's ability to transact at contract value at December 31, 2024 and 2023.

### 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 9. Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan document to terminate the Plan at any time subject to the provisions of ERISA.
