## INDEPENDENT AUDITOR'S REPORT

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about PMI Resource, LLC Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the PMI Resource, LLC Retirement Plan (the “Plan”), provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

**GENERAL**

The Plan was established on January 1, 1998, as a multiple employer defined contribution plan covering eligible employees of PMI Resource, LLC (the “Sponsor” or the “Sponsoring Employer”) and Adopting Employers. Employees are eligible to participate in the Plan based on elections made by the Adopting Employers (“Participating Employers”). The Sponsor is a Professional Employer Organization (“PEO”) and provides payroll processing and human resources services to its clients. Each client of the Sponsor has the option of adopting this Plan for the benefit of its employees. An Adopting Employer establishes its eligibility requirements related to age and length of service for its employees in accordance with the Plan document and the Internal Revenue Code (“IRC”). An Adopting Employer may elect to waive or change the service eligibility requirement for individuals who are performing services for the Adopting Employer as of the date the Plan is adopted. The provisions of the Plan, as applicable to the Adopting Employer and its employees, are based on the selections of the Adopting Employer with respect to the variable features provided by the Plan document and the Adoption Agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan Administrator is responsible for oversight of the Plan, determining the appropriateness of the Plan’s investment offerings and monitoring investment performance.

The Plan contracts with Equitable Life Insurance Company (the “Custodian”) which holds the Plan’s investments and executes investment transactions of the Plan.

**CONTRIBUTIONS**

Each year, participants may contribute an amount of annual compensation as elected by their Adopting Employer, subject to Internal Revenue Service (“IRS”) limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Roth 401(k) deferrals are allowed under the Plan, if elected by Adopting Employers.

Each Adopting Employer elects the level of safe harbor, matching and/or profit-sharing contributions. Adopting Employer contributions, if any, are recorded in the year for which the contributions apply. Aggregate Adopting Employer contributions for the year ended December 31, 2024 amounted to \$250,939. Adopting Employer contributions are invested in funds in accordance with the participant’s direction and the Plan’s provisions.

Contributions are subject to certain IRS limitations.

**PARTICIPANT ACCOUNTS**

Each participant’s account is credited with the participant’s contribution, and an allocation of: (a) their Adopting Employer contributions, if any, and (b) Plan earnings or losses. Participants are charged with his or her withdrawals and an allocation of Plan administrative expenses. Allocations are based on participant earnings or losses, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

**VESTING**

Participants are immediately vested in their individual voluntary contributions, plus actual earnings or losses thereon, and their Adopting Employer’s safe harbor contributions, if any, plus actual earnings or losses thereon. Vesting in the remainder of the accounts is based on years of continuous service, based on elections made in the Adopting Employer’s Adoption Agreement. Vesting schedules vary based on the Adopting Employer’s elections. Participants become fully vested upon reaching normal retirement age of sixty-five (65), death, becoming disabled, or termination of the Plan.

**NOTE 1 - DESCRIPTION OF PLAN - CONTINUED**

**NOTES RECEIVABLE FROM PARTICIPANTS**

Participants may borrow amounts from the Plan subject to the provisions of the Plan. The notes are secured by the balance in the participant's account and bear interest at 2% above the prime rate, as defined. Principal and interest is paid ratably through payroll deductions.

**PAYMENT OF BENEFITS**

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive their vested benefit either in a lump sum payment or as a partial withdrawal. Further, participants may elect to receive said benefit either in cash or as a direct rollover to a qualified IRA or another tax-qualified plan. A participant may, while still employed by the Company, withdraw all or any part of the vested interest in their account, subject to the restrictions defined in the Plan document.

**ADMINISTRATIVE EXPENSES**

The Plan allows certain administrative expenses to be paid from Plan investment assets. Certain administrative expenses are paid by the Principal Employer and Adopting Employers and are not reflected in these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

**FORFEITURED ACCOUNTS**

Under the provisions of the Plan, a participant who terminates employment before becoming vested in the employer's contributions forfeits these amounts. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$21,726 and \$7,401, respectively. Forfeitures may be used to pay plan expenses and reduce employer contributions. During the plan year ending December 31, 2024, the Plan received \$14,325 in new forfeitures and earnings and did not use any forfeitures.

**PLAN ADMINISTRATION**

The Sponsoring Employer is the Plan Administrator, and as such, controls and manages the operations of the Plan.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**BASIS OF ACCOUNTING**

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles ("GAAP").

**USE OF ESTIMATES**

The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**INVESTMENT VALUATION AND INCOME RECOGNITION**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED**

**NOTES RECEIVABLE FROM PARTICIPANTS**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

**PAYMENT OF BENEFITS**

Benefit payments are recorded when paid.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	<p>Inputs to the valuation methodology include:</p> <ul style="list-style-type: none"> <li>• Quoted prices for similar assets or liabilities in active markets;</li> <li>• Quoted prices for identical or similar assets or liabilities in inactive markets;</li> <li>• Inputs other than quoted prices that are observable for the asset or liability;</li> <li>• Inputs that are derived principally from or corroborated by observable market data by correlation or other means.</li> </ul> <p>If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.</p>
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Guaranteed interest option:*

The fair value of the guaranteed interest option is reported to the Plan by Equitable Life Insurance Company and represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

*Pooled separate accounts:*

The fair value of pooled separate accounts is based on their net asset value (“NAV”). The separate accounts are valued daily as the number of accumulation units held multiplied by the NAV. The NAV is established when a new fund starts and is determined daily based on the NAV of shares of the underlying fund. The pooled separate accounts are invested in open-ended mutual funds that are deemed to be openly traded.

**NOTE 4 - INFORMATION CERTIFIED BY CUSTODIAN**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the United States Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained from data that has been prepared and certified as complete and accurate by Equitable Life Insurance Company, the Custodian.

**NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employers, participants, and certain others. Plan investments are managed by Equitable Life Insurance Company, the Custodian of the Plan, which qualify as party-in-interest transactions. Fees paid by the Plan totaled \$68,997 for the year ended December 31, 2024.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 7 - TAX STATUS**

The Plan has adopted a volume submitter plan which received a favorable opinion letter from the Internal Revenue Service (“IRS”) that the form of the plan is acceptable under Section 401(a) of the IRC. The Plan had been amended and restated. However, the Plan Administrator and tax counsel believe that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC and, therefore, believe the Plan is qualified, and the related trust is tax-exempt.

U.S. generally accepted accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions.

**NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan invests in a variety of investment funds. Investment securities are exposed to various risks, such as interest rate, credit, and overall volatility risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9 - DELINQUENT AND OUTSTANDING EMPLOYEE CONTRIBUTIONS AND LOAN REPAYMENTS**

From January 1, 2018, to December 31, 2023, the Plan withheld employee contribution and participant loan repayments from employee paychecks but did not remit them to the Plan for investment timely. During this period, the total amount of money remitted late was \$220,227 for employee contributions and \$32,212 for loan repayments. Of those amounts, \$8,845 of employee contributions, \$7 of employee Roth contributions and \$143 of loan repayments were not corrected until the 2024 Plan year. These employee contributions and participant loan repayments were investigated by the Department of Labor, and the investigation has closed. No remittances of contributions or repayments were reported late for the Plan year ended December 31, 2024.

**NOTE 10 - SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through September 15, 2025, which is the date the financial statements were available to be issued.
