### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Electrical Contractors, Inc. Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

Notes to Financial Statements

**1. Description of Plan**

The following description of the Electrical Contractors, Inc. Retirement Savings Plan (the Plan), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a contributory profit-sharing plan under Sections 401(a) and 401(k) of the Internal Revenue Code (IRC). The Plan covers substantially all employees of Electrical Contractors, Inc. (the Employer and the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Eligibility**

Employees regardless of age or service, who perform services for the Employer under a contract covered by a prevailing wage law are eligible to receive prevailing wage contributions. Employees are eligible to make salary deferrals and receive Employer matching or profit-sharing contributions on the first day of January or July upon the completion of one year of service (1,000 hours) and attainment of age 21. Employees must be employed on the last day of the Plan year to receive an Employer profit sharing contribution. Employees covered by collective bargaining agreements, leased employees, and non-resident aliens are not eligible to participate in the Plan.

**Contributions**

Participants may elect to contribute, on a tax-deferred basis, up to 90% of compensation, not to exceed the maximum deferral limit per Section 402(g)(1) of the IRC. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

The Company makes prevailing wage contributions based on the hourly contribution rate required under the applicable prevailing wage law. Prevailing wage contributions funded for the years ended December 31, 2024 and 2023 total \$193,667 and \$76,477, respectively. In addition, the Company may make discretionary matching and/or profit-sharing contributions. There were \$42,628 and \$38,060 employer discretionary matching contributions and no profit-sharing contributions during the years ended December 31, 2024 and 2023, respectively.

**1. Description of Plan (continued)**

**Investment Options**

Upon enrollment in the Plan, participants may direct participant contributions, their rollover contributions, and any Employer contributions in a variety of investment options offered by Charles Schwab Trust Bank, the trustee. Participants may change their investment options daily.

**Notes Receivable from Participants**

The Plan does not allow participant loans.

**Participant Accounts**

Each participant's account is credited with participant contributions, prevailing wage contributions, and Employer discretionary matching contributions and allocations of Employer discretionary profit-sharing contributions, and plan earnings. Participants are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Benefit Payments**

Upon termination of service, participants are entitled to receive a lump sum payment equal to their vested account balance. When a participant's service terminates due to incurring total and permanent disability, attainment of normal or early retirement age, or death, the participant or his or her beneficiary is entitled to 100% of the participant's account balance. Hardship and in-service distributions are permitted if certain criteria are met.

**Vesting**

Prevailing wage contributions, participant contributions, and actual earnings thereon are fully vested at all times. Employer discretionary matching and profit-sharing contributions, plus actual earnings thereon, are vested at 20% after two years of service, 20% per year of service thereafter, and are fully vested after six years of service.

**1. Description of Plan (continued)**

**Forfeitures**

Forfeitures of terminated participants' non-vested accounts may be used towards administrative expenses of the Plan or to reduce future employer contributions. Unallocated forfeiture balances at December 31, 2024 and 2023 were not material.

**Administrative Expenses**

Administrative expenses, including legal and accounting services are paid by the Company. However, to extent such administrative expenses are not paid by the Company, they are paid by the Plan, including investment management, recordkeeping, and advisory fees.

**2. Significant Accounting Policies**

**Basis of Accounting**

The accompanying financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make significant estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**2. Significant Accounting Policies (continued)**

**Risks and Uncertainties**

The Plan invests primarily in various mutual funds and stable value funds. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities in the near term could materially affect participants' account balances and the amounts reported in the accompanying financial statements.

**Payments of Benefits**

Benefits are recorded when they have been approved for payment and paid by the Plan.

**Investment Income Recognition**

Purchases and sales of securities are reflected on a trade-date basis. The change in market value from one period to the next is recognized as net appreciation/(depreciation) in fair value of investments in the accompanying statements of changes in net assets available for benefits. Interest and dividend income is recorded on accrual basis. Dividends are recorded on the ex-dividend date.

**Fair Value of Financial Instruments**

Investments of the Plan are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for additional information related to fair value measurements.

The Plan follows Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, for all financial assets and liabilities and nonfinancial assets and liabilities that are recognized or disclosed at fair value in the financial statements on a recurring basis. ASC 820 defines fair value, establishes a fair value hierarchy, and expands disclosures about fair value measurements.

**Fair Value of Financial Instruments (continued)**

ASC 820 defines fair value as the price that would be received upon sale of an asset or paid upon the transfer of a liability in an orderly transaction between market participants at the measurement date and in the principal or most advantageous market for that asset or liability.

The fair value should be calculated based on assumptions that market participants would use in pricing the asset or liability, not on assumptions specific to the entity. In addition, the fair value of liabilities should include consideration of non-performance risk including the Plan's own credit risk.

**3. Information Prepared and Certified by Trustee**

All investment information disclosed in the accompanying financial statements, including investments held at December 31, 2024 and 2023, net appreciation (depreciation) in fair value of investments, interest and dividend income earned on investments was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the Charles Schwab Trust Bank, the Trustee.

**4. Fair Value Measurements**

Under US GAAP, a framework for measuring fair values has been established to clarify the definition of those fair values and expand disclosures about assets and liabilities measured at fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy described under US GAAP are as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**4. Fair Value Measurements (continued)**

Level 3 - Inputs to the valuation methodology are unobservable and significant to fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value: Shares of mutual funds are valued at quoted market prices which represent the fair value of shares held by the Plan at year-end. The mutual funds held by the Plan are deemed to be actively traded. The Plan's investment in a stable value fund, Galliard Stable Value Fund is reported at fair value. The fund calculates fair value using the net asset value per share (NAV) or its equivalent in a manner consistent with the measurement principles of Topic 946, *Financial Services – Investment Companies*. As such, the fund qualifies for the NAV practical expedient, which permits the fund to be omitted from the fair value hierarchy under ASU 2015-07, *Fair Value Measurement and Disclosures* (FASB ASC 820). Participants may transfer from the fund noted below to a non-competing fund but must wait at least 90 days before transferring to a competing fund. There are no other participant redemption restrictions for these investments; the redemption notice period is applicable only to this fund.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time or to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, no further contributions could be made.

**6. Party-in-Interest Transactions**

Plan investments are managed by the Plan's trustees and custodians. Pension Corporation of America (PCA) is the Plan's recordkeeper and third-party administrator. Therefore, these transactions with these entities qualify as party-in-interest transactions.

PCA receives compensation from certain investments in the Plan's fund line up, which are used to offset certain Plan expenses.

**7. Income Tax Status**

The Employer adopted a volume submitted profit sharing plan (volume submitter plan), which received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the Plan is qualified under Section 401(a) of the Internal Revenue Code (the Code) and, therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualifications. The Plan has been amended since receiving the advisory opinion letter. The Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

**7. Income Tax Status (continued)**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**8. Subsequent Events**

The Plan has evaluated events occurring between December 31, 2024 and September 22, 2025, the date the financial statements were available to be issued.
