Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Cloverdale 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter – Supplemental Schedule Required by ERISA**

The supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 1 PLAN DESCRIPTION**

The following description of the Cloverdale 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

**General**

Cloverdale Foods Company (Company) established the Plan effective October 1, 1993. The Plan is a defined contribution plan and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan covers employees of the Company.

The Plan is sponsored by the employer, Cloverdale Foods Company. A third-party administrator, Bravera Wealth, serves as the trustee of the Plan, maintains the records of the participant data, and holds the Plan assets.

**Eligibility**

Employees of the Company are generally eligible to make deferral contributions and receive employer safe harbor matching contributions in the Plan after three months of consecutive service and attainment of age 18. Plan entrance dates are the first day of each Plan year quarter.

Employees are eligible to receive employer profit sharing contributions if they complete 1,000 hours of service during the plan year and are employed by the Company on the last day of the plan year. Employees are also eligible for employer matching contributions as long as they are making deferrals. The hours of service and last day requirements are waived if a participant reaches the normal retirement age during the plan year or if employment is terminated during the plan year due to death or disability.

**Contributions**

Participants may contribute a minimum of 1% and maximum of 100% of their eligible compensation. However, each respective participant's total deferrals in any taxable year may not exceed the maximum dollar amount allowed under federal regulations for the Plan year. Participants who have attained age 50 before the end of the Plan year are eligible to make additional catch-up contributions. The Plan allows participants to allocate contributions between pretax and after tax (Roth 401(k)) deferrals.

This plan is a "safe harbor 401(k) plan." A safe harbor 401(k) plan is a plan design in which the employer commits to making certain contributions to simplify the administration of the Plan by ensuring that nondiscrimination regulations are met. The Plan allows for employer safe harbor matching contributions of 100% of the participant's elective deferrals up to 3% of the participant's compensation for the Plan year, plus 50% of the amount of the participant's elective deferrals between 3% and 5%.

The Plan also allows for a discretionary profit-sharing contribution. The amount of the profit-sharing contribution is determined by the Company and is to be allocated on a pro-rata basis among all eligible participants based on compensation. No profit-sharing contribution was made during the years ended December 31, 2024 and 2023.

Participants may roll over amounts representing distributions from other qualified defined benefit plans, defined contribution plans, or individual retirement accounts.

**Payment of Benefits**

Upon termination of employment, death, disability or retirement, the participant will receive a lump sum amount, installment distributions or ad-hoc distributions equal to the value of the participant's vested interest. Terminated participants with account balances of \$7,000 or less are required to take a lump sum distribution upon termination. In-service retirement distributions are allowed upon the attainment of age 59 ½ or if the participant becomes disabled. Generally, certain minimum distributions are required for participants who have separated from service and have reached required minimum distribution age.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and any employer contributions, as applicable. Plan earnings are allocated based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The value of each participant's account is determined daily.

**Participants' Investment Options**

Participants must direct their salary deferral contributions and any Company contributions to selected investments as made available and determined by the Plan Administrators. Participants may change their investment options throughout the year by contacting Bravera Wealth.

**Vesting**

Participants are immediately vested in deferral contributions, employer safe-harbor matching contributions, and earnings thereon. Employer profit sharing contributions follow a six-year graded vesting schedule. A year of service is deemed to be earned if an employee works 1,000 hours during a plan year.

**Forfeitures**

Forfeitures may be used to reduce future employer contributions, pay reasonable plan expenses, or to restore forfeitures to participant accounts. There were no forfeitures used or available to be used during the years ended December 31, 2024 and 2023.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to the maximum of the lesser of \$50,000 or 50% of their vested account balance and may only have one outstanding loan. The loans are secured by the balance in the participant's account and bear interest rates comparable to those charged by financial institutions for similar loans. The term of the loan cannot exceed five years, unless it qualifies as a home loan at which the term cannot exceed 15 years. Principal and interest are paid ratably through payroll deductions.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting.

**Basis of Presentation**

The accompanying financial statements are presented in accordance with accounting principles generally accepted in the United States of America, ("GAAP"), as codified by the Financial Accounting Standards Board.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrators to make estimates and assumptions that affect the certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year and is reflected in the statements of changes in net assets available for benefits.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. Participant loans are considered delinquent if payment is not made by the end of the 'cure period', which cannot extend past the last day of the calendar quarter following the calendar quarter in which final payment was due.

**Contributions**

Contributions from Plan participants and matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

**Payment of Benefits**

Benefit payments to participants are recorded when paid.

**Administrative Expenses**

Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's investment performance and thus are not separately disclosed in the accompanying financial statements. Participant loan accounts are assessed a separate fee for the administration of the loan. Fees are paid by the participants of the Plan pro-rata based on participant investment balances. Certain administrative expenses that are paid by the Company are not reflected in the accompanying financial statements.

**Income Taxes**

The Plan's policy is to evaluate the likelihood that its uncertain tax positions will prevail upon examination based on the extent to which those positions have substantial support within the Internal Revenue Code and Regulations, Revenue Rulings, court decisions, and other evidence.

**NOTE 4 FAIR VALUE MEASUREMENT**

FASB ASC Topic 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under Topic 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means;

If the asset or liability has a specified (contractual) term the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2024 and 2023.

Mutual Funds (including money market mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 INCOME TAX STATUS**

The Plan adopted a non-standardized pre-approved profit sharing plan sponsored by Bravera Wealth. The non-standardized pre-approved profit sharing plan has received a favorable opinion letter dated June 30, 2020, from the Internal Revenue Service as to the plan's qualification status. This opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken a significant uncertain tax position that more likely than not would be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

**NOTE 6 EXEMPT TRANSACTIONS WITH PARTIES-IN-INTEREST**

Bravera Wealth serves as the trustee of the Plan, maintains the records of the participant data, and holds the Plan's assets. For the years ended December 31, 2024 and 2023, the Plan paid fees to Bravera Wealth for services provided in the amounts of \$89,631 and \$75,028, respectively.

PlanningTeam, Inc. serves as the investment advisor of the Plan. For the years ended December 31, 2024 and 2023, the Plan paid fees to PlanningTeam, Inc. for services provided in the amounts of \$30,715 and \$24,682, respectively.

The Plan issues notes receivable to participants which are secured by the balances in the participants accounts.

**NOTE 7 AMENDMENT AND TERMINATION**

Although it has not expressed any intent to do so, the Company reserves the right at any time to amend or terminate the Plan subject to the provisions of the Plan and ERISA. If the Company terminates contributions or the Plan is terminated, all participants become fully vested.

**NOTE 8 RISKS AND UNCERTAINTIES**

Participants direct the investment of their accounts into various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9 SUBSEQUENT EVENTS**
