### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We were engaged to perform audits of the financial statements of Defender Association of Philadelphia Tax Deferred Annuity Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Disclaimer of Opinion***

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

### ***Basis for Disclaimer of Opinion***

As described in Note 3, the Plan has excluded from investments in the accompanying statements of net assets available for benefits certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-2, Annual Reporting Requirements for 403(b) Plans. If the identified contracts, as reported by the custodians, were included, net assets available for benefits would increase by approximately \$5,205,000 as of December 31, 2024. Further, investment income of approximately \$525,000 and distributions of approximately \$1,016,000 related to such accounts, as identified by the custodians, have also been excluded from the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024. Accounting principles generally accepted in the United States of America require that these accounts and the related income and distributions be included in the accompanying financial statements.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditors' Responsibilities for the Audit of the Financial Statements***

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditors' report. However, because of the matter described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

#### (1) Description of Plan

The following description of the Defender Association of Philadelphia Tax Deferred Annuity Plan (the Plan) provides only general information. Participants should refer to the plan documents for a more complete description of the Plan's provisions.

##### **General**

The Plan is a defined contribution plan covering employees of Defender Association of Philadelphia (the Association). Employees become eligible to participate in the Plan immediately upon commencement of employment. The Plan includes a non-elective contribution provision which covers employees of the Federal Court Division, a division of the Association, who are classified as permanent employees and who are not highly compensated employees. The Federal Court Division agreement requires the employee to have completed one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Board of Directors is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to management, who reports to the Plan's Board of Trustees.

##### **Contributions**

Each year, participants may contribute a portion of their annual compensation, as defined in the Plan, up to the Internal Revenue Service (IRS) limitation. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions up to the IRS limitation. Participants may elect to have their deferrals be Roth contributions. Participants may also roll over amounts representing distributions from other qualified defined benefit and defined contribution plans, as defined by the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Under the automatic contribution arrangement provisions, 3% of new participants' compensation will be deferred and invested in a designated fund.

The Association contributes 50% of the first 6% of compensation that a participant contributes to the Plan once participants have completed one year of service. In addition, two types of basic contributions may be made at the option of the Plan's Board of Trustees; a) to non-highly compensated employees (and former employees for a period of 5 years) of the Federal Court Division, and b) to employees who are not employees of the Federal Court Division. Matching and basic contributions for the year ended December 31, 2024 were \$4,024,109.

### (1) Description of Plan, Continued

#### *Participant Accounts*

Each participant's account is credited with the participant's contributions, the Association's contributions and an allocation of plan earnings or losses. Participant accounts may also be charged with an allocation of certain administrative expenses. Allocations are based on participant earnings or losses, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### *Vesting*

Participants are fully vested in their account balances at all times.

#### *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 (reduced by the highest outstanding loan balance incurred by the participant during the 12 month period ending on the day before the loan date) or 50% of their vested account balance. The number of outstanding loans permitted at one time is two. Loan terms range from one to five years or longer for a loan used to acquire a principal residence (up to 20 years). The loans are secured by the vested balance in the participant's account and bear interest at rates that range from 4.25% to 9.50%, which are commensurate with local prevailing rates determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

#### *Payment of Benefits*

On termination of service due to death, disability, retirement, or other reasons, a participant or survivor may elect to receive a lump-sum amount equal to the value of the participant's interest in his or her account, partial distributions or annual installment payments not to exceed the life expectancy of the participant or the joint and last survivor expectancy of the participant and their designated beneficiary. In-service withdrawals may be made by participants who are age 59½ or over, or by participants under this age who have incurred a hardship, as defined by the Plan.

### (2) Summary of Significant Accounting Policies

#### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### (2) Summary of Significant Accounting Policies, Continued

##### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### *Contributions*

Contributions from plan participants and the matching contributions from the Association are recorded in the year in which the employee contributions are withheld from compensation.

##### *Investment Valuation and Income Recognition*

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent loans are treated as distributions based upon the terms of the plan document.

##### *Payment of Benefits*

Benefits are recorded when paid.

##### *Expenses*

Certain expenses of maintaining the Plan are paid by the Plan as permitted in the plan document while other expenses are paid by the Association. Fees related to the administration of notes receivable from participants are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

##### *Subsequent Events*

The Association has evaluated subsequent events through September 30, 2025, the date the financial statements were available to be issued.

#### (3) Certified Investment Information

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, other income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from the information certified as complete and accurate by State Street Bank and Trust Company, as agent for Transamerica Retirement Solutions, LLC, and FASCore, LLC, as agent for Metropolitan Life Insurance Company (Met Life), qualified institutions.

The Plan was established January 1, 1979 and, since that date, has permitted numerous annuity issuing service providers and asset custodians. The Plan has been amended since that date, resulting in the removal of certain service providers and addition of new service providers. The Plan was not required to and has not maintained sufficient accounting records and supporting documentation issued by certain providers to current and former employees relating to those contracts issued prior to January 1, 2009. As such, the plan administrator is uncertain as to the completeness of the net assets available for benefits as of December 31, 2024 and 2023 and the changes in net assets available for benefits for the year ended December 31, 2024. Additionally, as permitted by the DOL's Field Assistance Bulletin No. 2009-2, *Annual Reporting Requirements for 403(b) Plans* (Bulletin), the plan administrator has elected to exclude certain annuity and custodial accounts that meet the criteria for exclusion under the Bulletin which were certified by the custodians from the Plan's financial statements and supplemental schedule. As a result, information certified that has been excluded is as follows: investments of \$5,180,233 and \$6,298,848 as of December 31, 2024 and 2023, respectively, notes receivable from participants of \$24,678 and \$31,380 as of December 31, 2024 and 2023, respectively, and investment income of \$524,866 for the year ended December 31, 2024.

#### (4) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered investment companies and brokerage accounts:* Valued at the daily closing price as reported by the fund. Registered investment companies and brokerage accounts held by the Plan are open end registered investment companies that are registered with the Securities and Exchange Commission. These funds are required to publish their net asset value (NAV) and to transact at that price. The shares of registered investment companies and brokerage accounts held by the Plan are deemed to be actively traded.

*Guaranteed pooled separate accounts:* Valued based on the value of underlying securities, which is obtained primarily from independent pricing services, and the value of the annuity contract, which is based on the replacement cost methodology that is the present value of the difference between the replacement contract fee and the current contract fee.

#### (5) Investment Contract with Insurance Company

The Plan invests in a benefit-responsive investment contract with Met Life. The fund contains investment contracts with insurance companies and comprises primarily of benefit-responsive investment contracts. The contributions are maintained in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuers are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting rate is based on a formula agreed upon with the issuers. Such interest rates are reviewed on a quarterly basis for resetting.

The guaranteed investment contracts do not permit the insurance companies to terminate the agreement prior to the scheduled maturity dates.

#### (6) Related Party Transactions and Party-In-Interest Transactions

The Plan invests in guaranteed pooled separate accounts managed by Transamerica Financial Life Insurance Company (TFLIC) and Met Life. Transactions in the accounts qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

Under an agreement negotiated with TFLIC, the Plan is a beneficiary of a reduction of a portion of the Plan's mutual fund management fees, which are rebated to the Plan. The allowance is deposited in an Expense Budget Account maintained by the Plan. The rebate income received by the Plan amounted to \$88,193 for the year ended December 31, 2024. The rebate income was used to pay plan administrative expenses as permitted by the plan document.

#### (7) Plan Termination

Although it has not expressed any intent to do so, the Association has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will remain 100% vested in their employer contributions.

#### (8) Tax Status

The Plan uses a Volume Submitter plan document sponsored by Transamerica Retirement Solutions LLC (TRS). The IRS has determined and informed TRS by a letter dated March 31, 2017, that the Volume Submitter plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

#### **(8) Tax Status, Continued**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **(9) Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
