Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Stanion Wholesale Electric Co., Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Notes to Financial Statements

December 31, 2024 and 2023

1. Description of the Plan

The following description of the Stanion Wholesale Electric Co., Inc. 401(k) Plan (“Plan”) provides only general information. Participants should refer to the *Summary Plan Description* for a more complete description of the Plan’s provisions, which is available from the Plan Administrator. The Plan Administrator is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees.

General

The Plan is a defined contribution plan covering all employees of the following Plan sponsor companies (Companies) under common control who have six months of service and are age eighteen or older, with quarterly entry dates:

Stanion Wholesale Electric Co., Inc.
Stanion Wholesale Electric Co. of Wichita, Inc.

The Plan was originally effective on January 1, 1987 and has been amended and restated since that date. Under the amended and restated provisions, the Plan is a safe harbor 401(k) plan.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan provides that active participants may make voluntary contributions to the Plan of up to 75% of pre-tax, after-tax or a combination of both, of annual eligible compensation, up to the maximum allowed by the Internal Revenue Code as adjusted for applicable percentages of compensation. Participants may also contribute rollover amounts representing distributions from other qualified defined benefit or contribution plans.

1. Description of the Plan (Continued)

Contributions (continued)

The Companies will make a safe harbor matching contribution equal to 100% of participant salary deferrals that do not exceed 3% of compensation plus 50% of salary deferrals between 3% and 5% of compensation. In addition, the Companies may make a discretionary qualified non-elective contribution (QNEC) to the Plan. For the years ended December 31, 2024 and 2023, the Companies contributed \$0 of QNEC to the Plan. Participants direct the investment of both the participant and Company contributions into various investment options offered by the Plan.

Investment Elections

The participant contributions and the Companies' matching and QNEC contributions are allocated to the various investment options offered by the Plan as directed by participants.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's matching contribution and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective contributions and rollover contributions, plus (minus) actual earnings (losses) thereon. The Companies' safe harbor match and QNEC contribution portion of their accounts is 100% vested. Any non-qualified NEC or additional matching contributions are vested using a three year cliff.

Payment of Benefits

Distributions are not allowed before the employee reaches age 59 1/2, except in the event of death, financial hardship, disability, or termination of employment. Upon termination of employment, the employer, with the consent of the participant, may elect to pay a lump-sum distribution. Otherwise, the benefits will not be paid until the terminated participant reaches normal retirement age.

Forfeited Accounts

Forfeitures of nonvested amounts are first used to pay administrative expenses of the Plan. Any remaining forfeitures attributable to non-qualified NEC or matching contributions will be allocated to participant accounts. At December 31, 2024 and 2023, unallocated forfeiture balances totaled \$12,512 and \$689, respectively. During 2024, forfeited nonvested accounts of \$563 were used to reduce the Companies' contributions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

The Stable Value Fund is stated at contract value, as the investment contracts are fully benefit-responsive. Contract value, as reported to the Plan by Empower Annuity Insurance Company of America (the asset custodian and recordkeeper), represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily withdraw or transfer all or a portion of their investment at contract value. Refer to Note 5 for further detail on the Stable Value Fund.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative expenses

Certain expenses of the Plan may be paid directly by the Companies and are therefore excluded from the financial statements. Expenses paid by the Plan include, but are not limited to, investment advisement fees, contract administration fees and audit fees. Some investment related expenses may be included in the net change in fair value of investments.

3. Information Certified by Plan Custodians (Unaudited)

The following is a summary of the investment information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and supplemental schedule, that was prepared by or derived from information provided by Empower Annuity Insurance Company of America (Empower) (the asset custodians and recordkeepers) and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from Empower that information provided to the Plan Administrator by Empower related to the following assets is complete and accurate.

Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information below, the fair values in Note 4, and the values in the supplemental schedule related to the following:

4. Investments/Fair Value

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

<i>Level 1</i>	Quoted market prices in active markets for identical assets or liabilities.
<i>Level 2</i>	Inputs other than level 1 inputs that are either directly or indirectly observable.
<i>Level 3</i>	Unobservable inputs developed using the Plan's estimates and assumptions, which reflect those that market participants would use.

The determination of where an asset or liability falls in the hierarchy requires significant judgment. The Plan evaluates its hierarchy disclosures each year and based on various factors, it is possible that an asset or liability may be classified differently from year to year. However, the Plan expects that changes in classifications between different levels will be rare.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds and money market funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price.

Variable annuities: Valued daily by the annuity provider according to the methods described in the annuity contract.

The fair value at December 31, 2024 and 2023, of the Plan's financial instruments that are valued on a recurring basis in accordance with the above fair value hierarchy, as provided by Empower, is as follows:

In general, the Plan's investments are exposed to various risks, such as credit and overall market volatility risk. Due to these risks, it is possible that changes in the values of investments could occur in the near term and that such changes could materially affect the net assets recorded in the accompanying financial statements.

5. Investment at Contract Value

Morley Stable Value Fund (SVF) Collective Investment Trust (CIT) was formed for the purpose of allowing participating plan sponsors, who maintained defined contribution plans qualified under Section 501(a) of the IRC, to invest in an investment fund offered by the Principal Global Investors Trust Company (the Trust Company). The fund primarily consists of stable value investment contracts issued by life insurance companies, banks, and other financial institutions. The Trust Company has retained Morley Capital Management (Morley) to serve as investment manager with respect to the fund. Morley is part of Principal Global Investors, LLC (the Advisor). The Trust Company and the Advisor are under common control of Principal Financial Group. Units are issued and redeemed daily at contract value. Contract value represents contributions, plus interest, less participant-initiated withdrawals or transfers. As of December 31, 2024 and 2023, contract value approximated estimated fair value.

The stable value fund (SVF) is stated at contract value and invests primarily in a variety of high quality stable value investment contracts, as well as cash and cash equivalents. The contract value of the underlying contracts is determined by the trustee based on various factors.

Circumstances that impact the SVF

The SVF invests in various Stable Value Investment Contracts issued by life insurance companies, banks, and other financial institutions managed by Morley. Investment contracts are stated at contract value primarily because participants are able to transact at contract value when initiating benefit-responsive withdrawals and transfers. The SVF generally contains certain provisions that limit the ability of the SVF to transact at contract value upon occurrence of certain events. These events include, but are not limited to, termination of the plan, a material adverse change to the provisions of the plan, or the employer elects to switch to a different investment provider.

5. Investment at Contract Value (Continued)

While it is possible that some of the Plans participating in the SVF may experience plan terminations or other events that would trigger fair value payouts under the SVF agreement, based on prior experience, management believes it is not probable that such events would be of sufficient magnitude to limit the ability of the SVF to transact at contract value with the participants in the SVF. Given that such events are beyond the control of the SVF, however, there can be no guarantee that this will be the case. In addition, investment contracts have elements of risk due to lack of a secondary market. Investment contracts may be subject to credit risk based on the ability of the wrap provider to meet its obligations under the terms of the contract. Plan management believes that the occurrence of events that would cause the SVF to transact at less than contract value is not probable.

6. Plan Termination

Although they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

7. Tax Status

The IRS has determined and informed the plan sponsor by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or any states having jurisdiction over the Plan. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

9. Subsequent Events

Management has evaluated events through September 24, 2025, the date the financial statements were available to be issued.
