1. DESCRIPTION OF PLAN

The following brief description of the Tri-County Family Medicine, Inc. Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more information and a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established to provide retirement benefits to employees of Tri-County Family Medicine Program, Inc. (Tri-County), who meet certain eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

Tri-County is the sponsor of the Plan. The plan administrator is a committee appointed by the Plan Sponsor. Empower Trust Company, LLC serves as the trustee and custodian of the Plan's assets and Empower Retirement, LLC provides recordkeeping functions for the Plan.

Eligibility

An employee must complete one hour of service to be eligible to make elective deferrals into the Plan. Plan entry dates are as soon as administratively feasible following satisfaction of eligibility requirements.

An employee must complete one year of service based on elapsed time to become eligible for employer contributions. Plan entry dates for employer contributions are the first day of each payroll period following satisfaction of eligibility requirements.

Contributions

Participants may make pre-tax and/or roth contributions in the form of salary reductions at a maximum contribution of the lesser of 100% of the participant's total compensation for the plan year or the maximum amount permitted by Section 415(d) of the Internal Revenue Code (IRC). Participants, who attain the age of 50 before the end of the Plan year, are eligible to make catch-up contributions, subject to certain limitations of the Plan and the IRC.

Tri-County provides safe harbor matching contributions equal to 100% of participants' salary deferrals, up to 3% of a participant's compensation, plus 50% of the amount of the participants' salary deferrals between 3%-5% of a participant's compensation.

Tri-County may also make discretionary non-safe harbor matching and profit-sharing contributions to the Plan. Tri-County did not elect to make any discretionary contributions in 2024 and 2023.

Participants direct the investment of their contributions and Tri-County contributions into various investment options offered by the Plan.

Rollover Contributions

The Plan will accept direct rollover contributions from a qualified plan, as defined by the Plan.

1. DESCRIPTION OF PLAN (Continued)

Participant Accounts

Each participant's account is credited with the participant's contribution, Tri-County contributions, allocations of Plan earnings/losses, and charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately fully vested in their voluntary contributions, rollover contributions, and Tri-County safe harbor matching contributions plus actual earnings or losses thereon. Participants become 100% vested in Tri-County's non-safe harbor matching contributions and profit-sharing contributions plus earnings or losses thereon after six years of credited service.

Notes Receivable from Participants

Notes receivable from participants are not permitted under the Plan.

Payment of Benefits

The Plan provides for normal retirement benefits upon reaching age 65 and has provisions for in-service, disability, death and termination benefits for those participants or beneficiaries who are eligible to receive such benefits. Participants can elect to receive a distribution in the form of a qualified rollover, a lump-sum distribution or a series of substantially equal periodic installments of their vested account balance, not to exceed the participant's life expectancy, as defined in the Plan document. Effective April 1, 2024, participants whose vested account balance is \$7,000 or less at the time of termination are subject to the involuntary cash-out provisions of the Plan. Prior to April 1, 2024, participants whose vested account balance was \$5,000 or less at the time of termination were subject to the involuntary cash-out provisions of the Plan.

Hardship Withdrawals

Hardship withdrawals are not permitted under the Plan.

Forfeitures

Forfeitures of non-vested account balances can be used to reduce future employer contributions, pay plan expenses, or can be reallocated to all plan participants at the discretion of the plan administrator. The amount of forfeitures used to reduce employer contributions was \$25 and \$311 for the years ended December 31, 2024 and 2023, respectively. There were no unallocated forfeitures at December 31, 2024 and 2023.

Plan Administration Costs

Administrative expenses of the Plan are to be paid from Plan assets or by Tri-County.

Plan Termination

Although Tri-County has not expressed any intent to do so, it has the right to terminate the Plan subject to provisions set forth by ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investments

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Changes in the current value of investments held during the year, including realized gains and losses on assets bought and sold during the year, are reflected in the statement of changes in net assets available for benefits as net appreciation or depreciation in the fair value of investments. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest is recorded on the accrual basis.

Fair Value Measurements

The Plan uses various valuation techniques in determining fair value. Observable inputs are inputs that market participants would use in pricing the asset or liability developed based on market data obtained from sources independent of the Plan. Unobservable inputs are inputs that reflect the Plan's estimate about the assumptions market participants would use in pricing the asset or liability, developed based on the best information available in the circumstances.

GAAP establishes a fair value hierarchy. The hierarchy is broken down into three levels based on the reliability of inputs as follows:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation does not entail a significant degree of judgment.

Money market and mutual funds: Valued at fair value based on quoted market prices in active markets.

- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date. There have been no changes in valuation methodologies in 2024 and 2023.

Risks and Uncertainties

The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Payment of Benefits

Benefits are recorded when paid.

Estimates

The preparation of financial statements in accordance with GAAP requires the Plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and notes. Actual results could differ from these estimates.

4. TAX STATUS

The Plan has received an opinion letter from the Internal Revenue Service, dated July 16, 2024, as to the prototype plan's qualified status. The prototype Plan opinion letter has been relied upon by this Plan. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

5. PARTY-IN-INTEREST TRANSACTIONS

Empower Trust Company, LLC serves as the trustee and custodian of the Plan's investment assets and Empower Retirement, LLC is the Plan's recordkeeper. Tri-County serves as the Plan Sponsor. Consequently, transactions between Empower Trust Company, LLC, Empower Retirement, LLC, Tri-County, and the Plan qualify as party-in-interest transactions.

6. RECONCILIATION TO FORM 5500

Certain items have been classified differently between the financial statements and Form 5500. Net assets available for benefits and changes in net assets available for benefits per the financial statements agreed to Form 5500 in total as of and for the years ended December 31, 2024 and 2023.

7. SUBSEQUENT EVENTS

Subsequent events have been evaluated through September 26, 2025, which is the date the financial statements were available to be issued.
