## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of

### **Report on the Financial Statements**

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Black Hills Regional Eye Institute 401(k) Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

#### ***Opinion***

**NOTES TO FINANCIAL STATEMENTS  
DECEMBER 31, 2024 AND 2023**

**(1) Summary of Significant Accounting Policies**

**Nature of Business of Plan Sponsor**

Black Hills Regional Eye Institute, LLP (the Plan Sponsor, the Company, and the Plan Administrator), formed in 1983, operates a specialized clinic in Rapid City, South Dakota. The Plan Sponsor performs vision related surgeries, treatments, education and research. Black Hills Regional Eye Institute 401(k) Plan and Trust (the Plan) also allows certain entities related through common control to participate in the Plan.

**Method of Accounting**

The financial statements of Black Hills Regional Eye Institute 401(k) Plan and Trust are prepared using the accrual method of accounting.

**Use of Estimates and Basis of Accounting**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the amounts and disclosures reported in the financial statements. Actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value on a recurring basis, as determined by Minnesota Life Insurance Company (the Trustee) (Notes 4 and 7). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of pooled separate accounts are recorded on a trade-date basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Risks and Uncertainties**

The Plan provides for various investment options. Investments are exposed to various risks, such as interest, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**Participant Notes Receivable**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

**(1) Summary of Significant Accounting Policies**

**Payment of Benefits**

Benefits are recorded when paid.

**Contributions**

Contributions from Plan participants and the related Company contributions are recorded in the year in which the employee contributions are withheld from compensation.

**Subsequent Events**

The Plan has evaluated subsequent events through September 17, 2025, the date which the financial statements were available for issue.

**(2) Description of the Plan**

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan originated on January 1, 2002. The Plan was most recently restated on August 23, 2021.

**General and Eligibility**

The Plan is a standardized defined-contribution plan covering all employees of the Plan Sponsor and those of participating employers. To be eligible to make salary deferrals to the Plan, a participant must have attained 18 years of age. To be eligible for all employer contributions an employee must also complete one year of service. A year of service is defined as working 1,000 hours within one year of their hire date or anniversary date for periods following the initial period. Plan entry is offered monthly. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Each year, participants may contribute up to certain limits as established by the IRS and Plan Administrator. The Plan Sponsor may elect to make a safe harbor matching contribution prior to the beginning of each plan year. For the year ended December 31, 2024, the safe harbor match is equal to 100 percent of participant deferrals up to 3 percent of compensation.

The Plan Sponsor may elect to make discretionary matching and profit sharing contributions. All eligible participants receive a share of the discretionary matching and profit sharing contributions. Profit sharing contributions are received regardless of if any salary deferrals have been made during the plan year. For the year ended December 31, 2024 discretionary matching contributions were 3 percent of compensation. For the year ended December 31, 2024 the base percentage for profit sharing contributions was 7 percent of compensation up to the social security taxable wage base.

Participants may receive additional nonelective contributions if eligible compensation exceeds the social security taxable wage base.

**(2) Description of the Plan**

**Contributions**

The Plan allows Roth elective deferrals. Contributions to Roth 401(k) accounts are made on an after-tax basis and contributions to a Roth 401(k) account are included in the participant's gross income. Future distributions of Roth elected contributions and earnings thereon will not be taxed, if certain criteria are met. Roth elective deferrals to the Plan are permanently designated as Roth elective deferrals in participant accounts. The participants' Roth deferrals and gains and losses attributable to such deferrals are accounted for separately.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, the Plan Sponsor's matching and profit sharing contributions, Plan earnings or losses, and charged administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Forfeited Accounts**

Non-vested account balances are forfeited, unless participants return to employment and contribute the distribution received at termination within a specified time. Plan forfeitures are used to reduce employer contributions. At December 31, 2024 and 2023, Plan investments included forfeitures of \$44,961 and \$9,922, respectively. Forfeitures of \$34,933 were used to reduce employer contributions during the year ended December 31, 2024.

**Vesting**

Participants are immediately vested in their contributions and employer safe harbor contributions plus actual earnings thereon. The portion of the participant's account attributable to the Company's discretionary match and profit-sharing contributions becomes 100 percent vested over six years of credited service at a rate of 20 percent after two years of credited service and for each successive year of service, or if less than six years, upon reaching normal retirement age, disability, death, or upon termination of the Plan.

**Hardship Withdrawals**

Should a plan participant experience a hardship, they may elect to withdraw all or part of their vested account from the Plan. All cases of hardship must be presented in writing to, and approved by, the Trustee. The Trustee may request additional supporting documentation from plan participants to substantiate any case of hardship. The Trustee may, at their discretion, approve all or part of the withdrawal request. Hardship withdrawals are recorded as distributions in the period in which they are paid.

**Participants' Investment Options**

Upon enrollment in the Plan, a participant may direct employee and employer contributions into the investment funds as listed on the Schedule of Assets Held at End of Year. Participants may change the investment allocation of employee and employer contributions on a daily basis. Participants may elect to discontinue contributions at any time.

**Participant Notes Receivable**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan terms range from one to five years for general purpose loans and up to 30 years for the purchase of a personal residence. The loans are secured by the balance in the participant's account and bear interest at market rates at the time of application. Principal and interest is paid ratably through direct withdrawals from the participant's personal bank account. Only one loan is permitted per participant.

**(2) Description of the Plan**

**Assets Held for Investment Purposes**

The Plan investments are held by the Trustee under agreement with the Plan. All investment decisions are made by participants from a selected list of financial instruments selected by the Plan Administrator. The Plan currently offers various pooled separate accounts as investment options for participants. Participants may change their allocation elections at any time.

**Payment of Benefits**

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or one of various annuities. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Vested benefits less than \$1,000 are distributed as soon as administratively feasible after the participant's termination of employment. Vested benefits greater than \$1,000 but less than \$5,000 are rolled over to an individual retirement account.

**Administrative Expenses**

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. The Company has, at its discretion, absorbed certain other administrative expenses pertaining to the Plan. If not paid by the Company, these administrative expenses become the responsibility of the Plan. Investment management fees are included in administrative expenses on the Statement of Changes in Net Assets. Fees for recordkeeping as well as the administration of notes receivable and distributions to participants are included in administrative expenses and charged directly to the participants' accounts.

**(3) Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their account balance.

**(4) Investments -- Information Certified by Trustee**

The Plan's investments are held by the Minnesota Life Insurance Company (the Trustee), who performs all accounting functions associated with the Plan's investments. The fair value of investments at December 31, 2024 and 2023 is determined by the Trustee (Note 7).

In accordance with Section 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, the Plan Administrator has received certification from the Trustee as to the accuracy and completeness of certain financial information of the Plan.

**(4) Investments -- Information Certified by Trustees**

Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the fair values of investments securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

**(5) Income Tax Status**

A determination letter dated June 30, 2020 was obtained for the prototype plan document, in which the IRS stated that the Plan document, as then designed, was in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter; however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor (DOL) or IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**(6) Participant Withdrawals**

Vested, undistributed account balances of separated Plan participants total approximately \$3,764,000 and \$4,211,000 at December 31, 2024 and 2023, respectively.

**(7) Fair Value Measurement**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level One: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access
- Level Two: Inputs include
  1. quoted prices for similar assets or liabilities in active markets;
  2. quoted prices for identical or similar assets or liabilities in inactive markets;
  3. inputs other than quoted prices that are observable for the asset or liability;
  4. inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability
- Level Three: Inputs to the valuation methodology are unobservable and significant to the fair value measurement

**(7) Fair Value Measurement**

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets carried at fair value as of December 31, 2024 and 2023, in the accompanying Statements of Net Assets Available for Benefits by fair value hierarchy, as described above. *Pooled Separate Accounts:* Fair value represents the value of the fund shares, which is calculated daily based on the valuation of the funds' underlying investments at fair value. The pooled separate accounts invest mainly in mutual funds.

**(8) Related-Party Transactions and Party in Interest Transactions**

Fees for legal and professional services rendered to the Plan may be paid by the Company at its discretion. The Plan allows participants to take out loans against their account balances.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**(9) Delinquent Participant Contributions**

During the plan years ended December 31, 2024 and 2023, \$-0- and \$9,197, respectively, of participant contributions were not remitted to the Plan within the time frame required by DOL regulations. The Plan has made corrective contributions, including lost earnings, for the affected participants.
