Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of CAP 1 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the CAP 1 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS FOR THE YEARS ENDED DECEMBER 31, 2024 AND 2023

1. PLAN DESCRIPTION

The following is a brief description of the CAP 1 401(k) Plan (the “Plan”) provided for general information purposes. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

CAP 1 401(k) Plan, established in 2003, and subsequently amended, is a defined contribution plan as permitted under Section 401(k) of the Internal Revenue Code (“IRC”). The Plan is funded by employee contributions and covers all employees who are twenty-one years of age or older and have completed three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Consilium Company, LLC is the Plan Sponsor for the Plan.

Adopting Employers – In addition to the Plan Sponsor, the adopting employers of the Plan include: AP Professionals of Phoenix LLC, consilium1, LLC, AP Professionals of WNY, LLC, c1search, LLC DBA iWorld Professionals, LLC, Cloud Resources Staffing, LLC and c1secure, LLC. AP Professionals of Rochester, LLC was previously an adopting employer of the Plan. Effective March 19, 2024, the assets of these participants amounting to \$626,900 were transferred out of the Plan.

Contributions – Participants may elect to contribute up to 100% of their compensation, subject to Internal Revenue Service (“IRS”) limitations. The Company may also make a discretionary contribution and the amount may vary from year to year to provide the necessary top-heavy minimum contribution. No discretionary contributions were made for the years ended December 31, 2024 or 2023.

Contributions received from participants for 2024 and 2023, are net of payments of approximately \$18,000 and \$44,900, respectively. They were made in March 2025 and March 2024, respectively, to certain active participants to return excess contributions to satisfy the relevant nondiscrimination provisions of the Plan. These amounts are also included in the accompanying statements of net assets available for benefits as excess contributions payable at December 31, 2024 and 2023.

Vesting – Participants are immediately vested in their voluntary contributions and earnings thereon.

Participant Accounts – Each participant’s account is credited with the participant’s contributions and an allocation of the Plan earnings. Allocation of earnings is based on participant compensation or participant account balances, as defined.

Forfeitures – Forfeited accounts are applied to reduce employer contributions. Forfeitures available to reduce future administrative expenses amounted to \$3,782 and \$3,556, as of December 31, 2024 and 2023, respectively.

Plan Termination – Although it has not expressed any intent to do so, the Plan Sponsor has the right to terminate the Plan subject to the provisions of ERISA.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 or up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A note receivable is secured by the balance in the participant’s account and bears interest at rates commensurate with local prevailing rates, as determined by the plan administrator. Interest rates ranged from 5.50% to 10.50% at December 31, 2024 with maturity dates through March 2029. Principal and interest are paid ratably through regular payroll deductions.

1. PLAN DESCRIPTION (continued)

Payment of Benefits – Benefits are determined by the final value of the participant’s account at the time of retirement, termination, disablement or death and are paid as lump-sum distributions. Distributions are also permitted in the event of financial hardship, as defined by the Plan.

Administrative Expenses – Costs of administering the Plan were primarily paid by the Plan Sponsor for the years ended December 31, 2024 and 2023.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting – The accompanying financial statements have been prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition – The Plan establishes a fair value based on a hierarchy which identifies three levels of input. Level 1 inputs are generally quoted market prices for identical assets or liabilities, which are actively traded on an exchange. Level 2 inputs generally consist of market prices for identical assets which are not actively traded or market prices of similar assets or liabilities which are actively traded, on an exchange. Level 3 inputs are referred to as unobservable inputs and consist primarily of information derived by management where Level 1 and Level 2 inputs are not available. These may include such things as present value of expected future cash flows or other valuation methodologies. Under the hierarchy, Level 1 inputs are the most preferred, followed by Level 2, and Level 3 are to be used only where neither Level 1 nor Level 2 inputs are available.

An investment’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value as of December 31, 2024 and 2023:

Money market account: Valued based on quoted market price of shares held by the Plan at year end.

Pooled separate accounts: Valued based on the net asset value (“NAV”) of units held by the Plan at year end, and generally have no redemption restrictions or unfunded capital commitments.

Included in pooled separate accounts are the VOYA Index Solution Index Portfolio Z Fund, VOYA Index Solution 2040 Portfolio Z Fund, VOYA Index Solution 2060 Portfolio Z Fund, Vanguard 500 Index Fund, VOYA Intermediate Bond Fund, American Funds Washington Mutual Investors Fund, VOYA Large Cap Growth Portfolio Fund, Eaton Vance Atlanta Capital SMID-Cap Fund, American Funds EuroPacific Growth Fund, American Funds Capital Income Builder Fund, Carillon Eagle Small Cap Growth Fund, VOYA Index Solution 2035 Portfolio Fund, DFA Emerging Markets Portfolio Fund, Vanguard Mid-Cap Index Fund, Vanguard Small-Cap Index Fund, AB Global Bond Fund, VY T. Rowe Price Capital Appreciation Fund, DFA Real Estate Securities Portfolio Fund, Voya Index Solution 2030 Portfolio Fund, PIMCO Real Return Fund, PIMCO Income Fund, DFA Commodity Strategy Portfolio Fund, DFA US Targeted Value Portfolio Fund, VOYA Index Solution 2045 Portfolio Fund, VOYA Index Solution 2050 Portfolio Fund, VOYA Index Solution 2055 Portfolio Fund, PGIM High Yield Fund, Virtus Crdx MC VI Equity Fund, VOYA Index Solution 2025 Portfolio Fund, and VOYA Index Solution 2065 Portfolio Fund. The objective of these funds’ is to provide long-term growth of capital.

Fixed account: The fund primarily holds guaranteed and other similar investment contracts, that are fully-benefit responsive. The fund is valued based on the NAV of the shares held by the Plan at year-end using NAV contract value.

2. SUMMARY OF ACCOUNTING POLICIES (continued)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting date.

The Plan presents in the statements of changes in net assets available for benefits the net appreciation in fair value of investments, which includes unrealized and realized gains and losses on investments that were held or sold during the year.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits – Benefit payments to participants are recorded when paid.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of net assets at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties – The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events – Management has evaluated the effects of all subsequent events through August 28, 2025, the date the financial statements were available to be issued, to determine if events or transactions occurring through that date require potential adjustment or disclosure in the financial statements.

3. FAIR VALUE MEASUREMENTS

The Plan uses fair value measurements to record fair value adjustments to certain assets and to determine fair value disclosures (as discussed in Note 2). The following table sets forth, by level within the fair value hierarchy, the Plan's assets that are measured at fair value as of December 31, 2024 and 2023, with the exception of the pooled separate accounts and the fixed account, which are measured at fair value using the NAV practical expedient. The fair value for the pooled separate accounts and the fixed accounts are provided below to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits.

4. TRANSACTIONS WITH PARTIES IN INTEREST

The Plan's investments include shares of mutual funds managed by VOYA Retirement Insurance and Annuity Company ("VOYA"). As VOYA is the Plan trustee, as defined in the Plan document, these transactions qualify as party in interest transactions.

5. INCOME TAX STATUS

The Plan is utilizing a prototype plan developed by PPS Pension & Financial Services Inc., which received a favorable determination letter from the IRS stating the Plan is qualified under Section 401(a) of the IRC, and, therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualifications. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and therefore, believes that the Plan is qualified and the related trust is tax exempt.

6. CERTIFIED INVESTMENT INFORMATION

The following is a summary of the unaudited information regarding the Plan as of December 31, 2024 and 2023, and for the years then ended, included in the Plan's financial statements and supplemental schedule.
