INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees
Plumbers and Gasfitters Local Union No. 5
Retirement Savings Plan

Opinion

We have audited the accompanying financial statements of Plumbers and Gasfitters Local Union No. 5 Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in net assets available for benefits for the years then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion


We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.





Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. NOTES TO FINANCIAL STATEMENTS

YEARS ENDED DECEMBER 31, 2024 AND 2023

NOTE 1. DESCRIPTION OF THE PLAN

The following description of the Plumbers and Gasfitters Local Union No. 5 Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General - The Plan was established by an Agreement and Declaration of Trust which was entered into September 1, 1998, by the Joint Board of Trustees (Trustees) of the Plan. The Plan is a defined contribution profit sharing plan covering all eligible members of the Plumbers Local Union No. 5, U.A. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is officially administered by the Trustees consisting of an equal number of union and employer representatives in accordance with an agreement and declaration of trust entered into effective September 1, 1998.

Contributions - Contributions are made to the Plan on the participants' behalf under the terms of the collective bargaining agreement between Plumbers Local Union No. 5, U.A. and signatory employers or pursuant to some other written agreement that requires an employer to make contributions to the Plan on the participants' behalf.

Participant Accounts - Each participant's account is credited with the employers' contributions and allocations of the Plan's earnings and charged with an allocation of administrative expenses. The Trust has the discretion to charge: quarterly administrative fees - a) flat dollar per participant fee and b) an investment custodian fee. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested amount.

Administrative Expenses - The Plan pays certain investment and administrative fees directly to service providers, including John Hancock, the recordkeeper for the Plan all other administrative expenses are paid by the Plan

Vesting - Participants are immediately vested in the contributions plus actual earnings thereon.

Investment Options - Participants direct the investment of their contributions into a menu of 24 various separate accounts (underlying investments are mutual funds or common collective trusts) maintained by John Hancock.



NOTE 1. DESCRIPTION OF THE PLAN (CONTINUED)

Payment of Benefits - On termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in their account. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution, upon two consecutive years break in service.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements have been prepared using the accrual basis of accounting. Under this basis, additions are recognized when earned and deductions are recognized when incurred.

Estimates - The preparation of financial statements in accordance with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for a discussion of fair value measurements.

Purchases and sales of securities are reported on a trade-date basis. Interest income is reported on the accrual basis. Dividends are reported on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefits Paid - Benefits paid are recorded when disbursements are made.

Contributions Receivable - This amount represents contributions received shortly after the close of the Plan year. Therefore, an allowance for doubtful accounts is deemed unnecessary.

NOTE 3. INCOME TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Trustees by a letter dated May 29, 2015, that the Plan qualifies under Section 401 (a) of the Internal Revenue Code (IRC) and is, therefore not subject to the tax under Section 501 (a) of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.



NOTE 4. PLAN TERMINATION

The Trustees has the right to discontinue or terminate the Plan and, accordingly, the Trust provided by the Plan, in accordance with the Trust Agreement and Declaration of Trust and in accordance with the Plan. In addition, the Trustees have complete discretion to amend or modify the Plan and any of its provisions, in whole or in part, at any time.

The Plan may be terminated by a document in writing adopted by a majority of the Trustees. The Plan may be terminated if, in the opinion of the Trustees, it is not adequate to carry out the intent and purpose of the Plan as stated in its Trust Agreement, or it is not adequate to meet the payments due to which may become due under the Plan. The Plan may also be terminated if there are no individuals living who can qualify as employees or beneficiaries under the Trust Agreement. The Plan may also be terminated if there are no longer any collective bargaining agreements requiring contributions to the Plan. The Trustees have complete discretion to determine when and if the Plan should be terminated.

If the Plan is terminated, any assets remaining after payment of any approved accumulated shares and after payment of the administrative expenses of the Plan shall be distributed among the participants. Each participant will receive that part of the total remaining assets in the same ratio as his accumulated share bears to the aggregate amount of the accumulated shares of all participants. No part of the assets or income of the Plan will be used for purposes other than the exclusive benefit of the participants and beneficiaries of the Plan or for the administrative expenses of the Plan.

NOTE 5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Effective from the Plan's inception, a policy was adopted to reimburse the Plumbers Local Union No. 5, U.A., a related party. A pro rata share of Plan expense was reimbursed in 2024 and 2023 as follows:

The amounts owed to Plumbers Local Union No. 5, U.A. for the years ended December 31, 2024 and 2023 were \$13,052 and \$11,839, respectively, and are recognized as a liabilities in the statements of net assets available for benefits.

As disclosed in Note 1, the Plan pays certain investment and administrative fees directly to service providers, including John Hancock, the recordkeeper for the Plan. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.



NOTE 6. FAIR VALUE MEASUREMENTS

Accounting standards provide the framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Short-term investments: Valued at amortized cost, which approximates fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 9. CONCENTRATIONS OF CREDIT RISK

Concentration of credit risk with respect to any one insurer or security type are presented in the schedule of assets (held at end of year). The maximum loss in the event of nonperformance by any counter party is the value for each investment at December 31, 2024. The Plan does not anticipate nonperformance by any counterparties. None of the investments listed is in default as to interest.



NOTE 10. SIGNIFICANT UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 11. SUBSEQUENT EVENTS

Subsequent events have been evaluated through September 2, 2025, which is the date the financial statements were available to be issued. This review and evaluation revealed no material event or transaction which would require an adjustment to or disclosure in the accompanying financial statements.


