Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **1. Description of the Plan**

The following description of The Doctors Management Company 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan was established on January 1, 1987. The Plan is a defined contribution plan covering eligible nonunion employees of The Doctors Management Company (the Employer), a wholly owned subsidiary of The Doctors Company, an Interinsurance Exchange. The Plan is available to those employees who are age 18 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan is administered by the Employer. The Plan's trustee and record-keeper are Fidelity Management Trust Company (FMTC) and Fidelity Investments Institutional Operations Company, Inc. (Fidelity), respectively.

Contributions are participant directed, and each participant may direct contributions and account transfers between various fund options. Additionally, participants are allowed to direct their plan assets into self-directed brokerage accounts (BrokerageLink) through Fidelity Investments. Through these accounts, participants can buy and sell mutual funds, stocks, and bonds that are not available through the Plan.

#### **Contributions**

Participants may contribute up to 100% of their annual compensation and bonus subject to Internal Revenue Service (IRS) limitations.

The Employer makes matching contributions for the benefit of each participant equal to 200% of the participants' elective contribution, up to a maximum of 4% of each participant's compensation per pay period. In addition, the Employer contributes an additional 2% nonelective contribution to all eligible participants.

## Notes to Financial Statements (Modified Cash Basis) (continued)

### **1. Description of the Plan (continued)**

#### **Participant Accounts and Forfeitures**

Each participant's account is credited with the participant's and Employer's contributions and an allocation of (a) plan earnings and (b) forfeitures of terminated participant's non-vested accounts. Allocations are based on participants' compensation or account balances, as defined by the Plan.

Upon termination of employment, participants forfeit their non-vested balances. If a participant is rehired within a five-year period, the forfeited contributions are reinstated. Forfeited balances of terminated participants' non-vested accounts are used to (a) offset employer contributions, (b) pay plan expenses, and (c) reallocated to participant accounts. Unallocated forfeited balances as of December 31, 2024 and 2023, were \$16,299 and \$16,739, respectively, and are included in the Cash Reserve Fund of FMTC. The 2024 and 2023 forfeitures were \$23,964 and \$165,000, respectively, and forfeitures used to pay plan expenses for 2024 were \$24,506.

#### **Vesting**

Participants are fully vested in their voluntary contributions plus actual earnings thereon. Nonelective employer contributions are 100% vested immediately. Employer matching contributions vest as follows: an employee with more than one, two, three, four, and five years of service would be 20%, 40%, 60%, 80%, and 100% vested, respectively. In addition, benefits fully vest upon normal retirement, death, or permanent disability (while in the employment of the Employer), or upon termination of the Plan.

#### **Participant Withdrawals**

Withdrawals from the Plan are available upon termination of employment by the participant or upon the participant attaining age 59 1/2. Hardship withdrawals are also available to participants. Participants may elect to receive either a lump-sum amount equal to the vested account balance or a series of periodic payments over a selected term, as prescribed by the Plan.

#### **Plan Termination**

Although it has not expressed any intention to do so, the Employer has the right under the Plan to suspend, terminate, or completely discontinue contributions. In the event of plan termination, the full value of all participants' accounts would become fully vested and nonforfeitable.

### **1. Description of the Plan (continued)**

#### **Notes Receivable From Participants**

Participants are allowed to obtain loans in an amount not to exceed the lesser of \$50,000 or one-half of the participant's vested accrued benefit under the Plan. Interest rates on loans to participants ranged from 4.25% to 9.50%. These loans are to be repaid over 6 months to 5 years, or up to 15 years for the purchase of a primary residence, at the prime interest rate in effect on the date the loan was obtained and are fully collateralized by the participant's remaining vested account balance.

#### **Expenses**

Administrative expenses are payable by the Plan. The Employer can, at its discretion, elect to pay administrative expenses. The Plan paid the majority of such expenses in 2024.

#### **Revenue Sharing**

FMTC provides certain administrative services to the Plan pursuant to a Master Plan Services Agreement (MSA) between the plan administrator and FMTC. FMTC receives revenue from mutual fund and collective trust fund service providers for services FMTC provides to the funds. This revenue is used to offset certain amounts owed to FMTC for its administrative services provided to the Plan.

If the revenue received by FMTC from such mutual fund or collective trust fund service providers exceeds the amount owed under the MSA, FMTC remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay plan administrative expenses or allocated to the accounts of participants. During 2024, the Plan received revenue credit deposits in the amount of \$251,933, which has been recognized as other income. In the event that the Plan expenses exceed the amount available as described above, the Plan may make a payment to FMTC for administrative expenses not covered by sharing of the excess revenue.

### 2. Significant Accounting Policies

#### Basis of Accounting

The financial statements and supplemental schedule of the Plan are presented on the modified cash basis, which is a comprehensive basis of accounting other than U.S. generally accepted accounting principles (U.S. GAAP). Under this basis, investment assets are reported at fair value; investment income, including net realized and unrealized appreciation (depreciation) in the fair value of investments, is recognized in the period incurred; contributions are recognized when received rather than earned; and benefits and expenses are recognized when paid rather than as incurred.

#### Use of Estimates

The preparation of financial statements on the modified cash basis requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

#### Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.

#### Valuation of Investments

Accounting Standards Codification 820, *Fair Value Measurement*, defines fair value, expands disclosure requirements, and specifies a hierarchy of valuation techniques. The following are the levels of the hierarchy and a brief description of the type of valuation information (inputs) that qualifies a financial asset for each level:

- Level 1 – Unadjusted quoted prices for identical assets or liabilities in active markets where the specific security is traded.

### 2. Significant Accounting Policies (continued)

- Level 2 – Inputs other than Level 1 that are based on observable market data. These include quoted prices for similar assets in active markets, quoted prices for identical assets in inactive markets, inputs that are observable that are not prices (such as interest rates, credit risks, etc.), and inputs that are derived from, or corroborated by, observable markets. Financial models are often used to develop these prices.
- Level 3 – Developed from unobservable data, reflecting management’s own assumptions

When quoted prices in active markets for identical assets are available, these quoted market prices are used to determine the fair value of financial assets and these assets are classified as Level 1. In other cases where a quoted market price for identical assets in an active market is either not available or not observable, fair value is estimated using valuation methodologies based on available and observable market information or by using a matrix pricing model. These financial assets would be classified as Level 2. If quoted market prices are not available, fair value is determined by using broker quotes or an internal analysis of each investment’s financial statements and cash flow projections. In these instances, financial assets will be classified based upon the lowest level of input that is significant to the valuation. Thus, financial assets may be classified in Level 3 even though there may be some significant inputs that may be readily available.

The following is a description of the valuation methodologies used for financial assets measured at fair value, including the general classification of such assets pursuant to the valuation hierarchy.

Mutual funds – These are classified as Level 1 because quoted prices are available for these securities in an active market.

Common/collective trust funds and registered investment trusts – These assets are valued at net asset value (NAV) as a practical expedient as there is no readily determined fair value that the participant can access.

Other funds – These assets include the BrokerageLink Account, which comprises cash, money market funds, common stocks, exchange-traded funds, and mutual funds, which are classified as Level 1 because quoted prices are available for these financial instruments.

#### 2. Significant Accounting Policies (continued)

##### Distributions to Participants

Distributions to participants are recorded when paid.

#### 3. Investments

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in the fair value of investments, interest on notes receivable to participants and dividend and interest income for the year ended December 31, 2024, were obtained or derived from information supplied to the plan administrator and certified as complete and accurate by FMTC.

#### 4. Fair Value Measurements

#### 5. Tax Status

The underlying preapproved plan has received an opinion letter from the IRS dated June 30, 2020, stating that the written form of the underlying preapproved document is qualified under Section 401 of the Internal Revenue Code (the Code). Any employer adopting this form of the plan will be considered to have a plan qualified under Section 401 of the Code, and, therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **6. Related Party and Party-In-Interest Transactions**

Certain plan investments are shares of funds managed by FMTC or its affiliates. FMTC is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions for which a statutory exemption exists under ERISA.

### **7. Subsequent Events**

Management evaluated subsequent events for the Plan through September 30, 2025, the date the financial statements were available to be issued.
