INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of the
True World Holdings 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the True World Holdings 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of True World Holdings 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule of Assets Held as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO THE FINANCIAL STATEMENTS

NOTE 1 – DESCRIPTION OF PLAN

The following description of the True World Holdings 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General. The Plan is a voluntary, participant-directed, defined-contribution savings plan, which became effective on June 1, 1999. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

The assets of the Plan are currently managed and administered under the terms of an agreement between the Plan and T. Rowe Price Trust Company (“TRP” or “Trustee”), effective August 13, 2022. The Trustee is a qualified institution pursuant to ERISA.

Eligibility. All employees of True World Holdings, LLC and adopting employers (collectively the “Employer”), that are at least age 18, are eligible to participate in the Plan. All employees who have completed one year of service with the Employer, as defined in the Plan Document, are eligible for Employer Contributions.

As of December 31, 2024, the adopting employers, all of which are affiliated through common ownership, included: True World Foods Los Angeles, LLC; True World Foods New York, LLC; True World Foods Miami, LLC; Sea Ranch, Inc.; True World Foods Boston, LLC; One World Market, Inc.; True World Foods San Francisco, LLC; True World Foods Seattle, LLC; True World Foods DC, LLC; True World Group, LLC; Ikko International Trading, LLC; True World Foods Denver, LLC; True World Foods Atlanta, LLC; True World Foods Dallas, LLC; True World Foods Orlando, LLC; True World Foods Philadelphia, LLC; True World Foods Portland, LLC; True World Foods Raleigh, LLC; International Lobster and Maguro, LLC; True World Foods Phoenix, LLC; One World Market of Indiana, LLC; True World Foods Sacramento, LLC; True World Foods Chicago, LLC; True World Foods Columbus, LLC; True World Foods Tampa, LLC; True World Foods Detroit, LLC; True World Foods Minneapolis, LLC; Noble Village Group, Inc.; White Wolf Japanese Patisserie, LLC; and Sakurabana, Inc.

Participant Contributions. Participants may voluntarily elect to contribute a percentage of their pre-tax and/or post-tax compensation, as defined in the Plan, subject to amounts established by the Internal Revenue Code (the “IRC”). All participants who reach age 50 by the end of the Plan year may also make additional catch-up contributions, subject to amounts established by the IRC. All participants are automatically enrolled to defer 3% of their compensation each payroll period, treated as pretax deferrals, unless they choose a different percentage or choose to opt out of the Plan. Participants automatically enrolled in the Plan are subject to the automatic increase provisions of 1% each Plan year not to exceed 6%.

The Plan accepts rollovers and transfers as defined in the Plan document. Rollover contributions consist of contributions from other employers’ plans, which employees have elected to include with the Plan.

Employer Contributions. The Employer has elected to make discretionary matching contributions of 20% of elective deferrals up to the first 15% of compensation, as defined in the Plan Document, for participating employees.

The Employer may also make discretionary profit-sharing contributions, as defined in the Plan. There were no discretionary profit-sharing contributions for the year ended December 31, 2024.

Participant Accounts. Each participant’s account is credited with the participant’s elective deferral, any Employer matching contribution, any Employer profit sharing contribution, and the participant’s earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings (losses) or account balance as described in the Plan Agreement. Any profit-sharing contribution is allocated to participants’ accounts based on participants’ eligible compensation. Employer contributions to the Plan are invested in the same proportion as the participant’s contribution investment election.

NOTE 1 – DESCRIPTION OF PLAN (Concluded)

Investment Options. The investments may be made in various offered fund vehicles, and participants may elect to have their contributions invested in any of these funds. A separate account is maintained for each participant, and interest and dividends earned by each fund are reinvested in that fund. Participants may change their investment options at any time as long as they are in compliance with the Trustee's rules with regard to excessive trading. Additionally, participants can self-direct their investments ("Self-Directed Brokerage Fund").

Vesting. Participants are immediately vested in their contributions plus actual earnings thereon. A participant's vesting in Employer discretionary profit-sharing and matching contributions is based on years of service. A participant becomes 34% vested after two years of service, 67% after three years, and fully vested after four years. Amounts credited to a participant's account shall become fully vested upon death or disability.

Notes Receivable from Participants. Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of 50% of their vested account balances or \$50,000. Loans issued bear interest at the prime rate (7.5% as of December 31, 2024). A participant may have two loans outstanding at any given time. Terms depend on the type of loan; a general loan must be repaid within five years, while loans to acquire a primary residence shall be repaid over a longer time period, up to 10 years. Loans may either be repaid through payroll deductions or by a secure payment method and are secured by the balances in the participant's accounts.

Payments of Benefits. On termination of service, a participant may elect, at any time, to receive either a cash lump-sum amount equal to the value of his or her vested account, installment payments, partial payments or a rollover directly to their account of choice.

When a participant retires or reaches normal retirement age or terminates employment because of death or disability, the entire vested amount in the participant's account can be distributed in a lump-sum payment.

Participants have the option to leave amounts in the Plan up to the mandatory distribution date, which is defined as April 1 following the calendar year of attaining the age of 70 ½, if participants are still employed by the age of 70 ½, the mandatory distribution date generally is April 1st following the termination date of employment. When a participant dies, the entire amount in the participant's account is distributed to the participant's beneficiary(ies).

In-service Withdrawals. Participants attaining the age of 59 ½ may request a withdrawal of all or part of the vested portion of their accounts. Also, in the event a participant suffers financial hardship, as defined in the Plan, the participant may withdraw all or part of the vested portion of his/her pretax contributions, Roth contributions, and Employer matching contributions, excluding earnings. Participant rollover withdrawals may be made at any time.

Forfeitures. Forfeitures balances may be used to pay Plan expenses or to reduce Employer contributions. Forfeited accounts totaled \$31,708 and \$12,157 as of December 31, 2024 and 2023, respectively. Forfeitures in the amount of approximately \$3,400 were used to reduce Plan expenses for the year ended December 31, 2024. Forfeitures in the amount of approximately \$1,200 were used to reduce Employer contributions for the year ended December 31, 2024.

Recent Legislation. In December 2022, SECURE Act 2.0 ("SECURE 2.0") was enacted. SECURE 2.0 contains numerous significant changes for retirement plans, plan sponsors, and retirement plan providers. For example, SECURE 2.0 contains provisions related to, among many other things, increasing the required minimum distribution age, reducing required minimum distribution penalties, and removing required minimum distribution barriers for annuities. Many of the provisions in SECURE 2.0 went effective in 2023, but SECURE 2.0 will not be completely implemented until 2027. The Internal Revenue Service ("IRS") has issued additional guidance addressing specific issues arising from the implementation of the provisions of SECURE 2.0.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting. The accompanying financial statements have been prepared on the accrual basis of accounting.

Estimates and Assumptions. The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates. Future events and their effects cannot be predicted with certainty; accordingly, accounting estimates require the exercise of judgment. Accounting estimates used in the preparation of these financial statements change as new events occur, as more experience is acquired, as additional information is obtained, and as the operating environment changes.

Investment Valuation and Income Recognition. Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussions of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Excess Contributions Payable. Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding deduction to contributions. Excess contributions payable were \$-0- and \$1,748 as of December 31, 2024 and 2023, respectively.

Payment of Benefits. Benefits are recorded when paid.

Concentrations of Credit Risk. Substantially all of the Plan's investments are held by the Trustee.

Administrative Expenses. Certain administrative expenses of the Plan are paid by the Employer and are not included in these financial statements. The Employer does not intend to obtain reimbursement for such expenses.

NOTE 3 – INFORMATION CERTIFIED BY TRUSTEE OF THE PLAN ASSETS

The Plan's administrator ("Plan Administrator") has elected the method of annual reporting permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee has certified certain information included in the accompanying financial statements and supplemental schedule is complete and accurate as follows:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Note 4: All investment balances.
- The schedule of assets held for investment purposes at end of year as of December 31, 2024, as shown on Form 5500, Schedule H, Part IV, Line 4i.

NOTE 4 – FAIR VALUE MEASUREMENTS

FASB *Accounting Standards Codification* (“ASC”) 820, *Fair Value Measurement* establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1. Inputs to the valuation methodology are unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2. Inputs to the valuation methodology include (1) quoted prices for similar assets and liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; or (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability;

Level 3. Inputs that are both unobservable and significant to the fair value measurement.

A financial instrument’s level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds, Equities, Money Market Fund, and Self-Directed Brokerage Funds. Valued at quoted market prices.

Common Collective Trust. A stable value fund that is composed primarily of fully benefit-responsive investment contracts and is valued at the net asset value of units of the collective trust (“NAV”). The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months’ notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their accounts.

NOTE 6 – INCOME TAX STATUS

The Plan uses a Non-Standardized Pre-Approved Profit-Sharing Plan document sponsored by T. Rowe Price Retirement Plan Services Inc. effective August 15, 2022. T. Rowe Price Retirement Plan Services Inc. received an opinion letter from the IRS dated August 19, 2020 which states that the document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter; however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. The Plan Administrator is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

NOTE 7 – RELATED-PARTY TRANSACTIONS

Various investments are managed by the Trustee. These transactions are allowable party-in-interest transactions under ERISA and the regulations promulgated thereunder.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

NOTE 9 – CYBERSECURITY INCIDENT

On August 22, 2024, the Employer experienced a cybersecurity incident involving unauthorized access to its information systems. The incident, identified as a ransomware attack, resulted in the encryption of certain data and the temporary disruption of the Employer's ERP system and local network data store. The attack did involve the exfiltration of some customer and employee sensitive data based on the investigation to date. Certain personal and confidential information of all present and many past employees were breached. Management has evaluated the financial and operational impact of the incident and concluded that the incident will not have a material adverse effect on the Employer's financial condition, results of operations, or liquidity of the Employer or the Plan.

NOTE 10 – SUBSEQUENT EVENTS

Management has evaluated all known subsequent events from December 31, 2024 through September 25, 2025, the date the accompanying financial statements were available to be issued, and is not aware of any material subsequent events occurring during this period that have not been disclosed in the notes to the financial statements.
