Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of B.F. Saul Company Employees' 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate to the best of their knowledge and belief.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

NOTES TO THE FINANCIAL STATEMENTS
DECEMBER 31, 2024 AND 2023

NOTE 1 – DESCRIPTION OF THE PLAN:

The following brief description of the B. F. Saul Company Employees' 401(k) Retirement Plan (the "Plan") is provided for general information. Participants should refer to the Plan document and the amendments thereto for a more complete description of the Plan's provisions. Participants in the Plan include current and former employees of B. F. Saul Company (the "Company"), its subsidiaries and affiliated companies (collectively, the "Employers"). The Company is the Plan Sponsor and the Plan Administrator, and the Board of Directors (the "Board") of the Company has established a Committee that is responsible for oversight of the Plan. The Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and related fees and reports to the Board.

General

The Plan is a defined contribution plan covering all full-time and part-time employees as defined by the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Eligible participants may contribute (a) up to 100% of their pretax eligible compensation (as defined in the Plan), up to the maximum allowed by the Internal Revenue Code ("IRC"), and may designate those contributions as either traditional (pre tax) or Roth (after tax) and (b) amounts representing distributions from other qualified plans, as defined in the Plan's provisions. Participants who attain age 50 before the end of the calendar year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various options offered by the Plan. The Plan has an automatic enrollment feature under which participants are automatically enrolled in the Plan and contribute 2% of compensation each Plan year, unless the Participant affirmatively elects a different percentage or opts out of the Plan.

The Employers make matching contributions up to a maximum of 300% of the first 2% of compensation contributed by employees. During the years ended December 31, 2024 and 2023, the Employers made matching contributions totaling \$6,463,552 and \$5,846,908, respectively. The Employers may also make discretionary profit sharing contributions. No discretionary profit sharing contributions were made during the years ended December 31, 2024 and 2023.

Contributions are subject to certain IRC limitations.

Participant accounts

Each participant's account is credited with the participant's contribution, including any amounts rolled over from other qualified plans, matching contributions and allocations of profit sharing contributions made by Employers, if any, and investment earnings or losses, and is charged with applicable administrative fees. Such allocations of profit sharing contributions, if any, investment earnings or losses and administrative fees are based on participant earnings, account balances or specific participation transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

NOTE 1 – DESCRIPTION OF THE PLAN (Continued):

Vesting

Participants are immediately and fully vested in their voluntary contributions, rollover contributions and employer contributions, including any transfers from other plans, as well as actual earnings and losses thereon.

Payment of benefits

Upon termination of service due to death, disability, retirement or any other reason, a participant or beneficiary may elect, at that time or thereafter, to have the value of his/her vested interest paid to him/her in a single payment, multiple payments or to another qualified plan for his/her benefit.

Upon termination of service, if the vested value of a participant's account is less than \$5,000, his or her account will be distributed in a single lump-sum payment.

In-service withdrawals may be made by participants who are age 70½ or older, with each such withdrawal subject to the approval of the Plan Sponsor.

Notes receivable from participants

Participants may borrow from their account balance a minimum of \$1,000 and up to a maximum of (a) \$50,000, (b) 50% of their account balance or (c) the maximum allowed by the IRC, whichever is less. All loans are secured by the participant's account, may have terms from one to five years, or up to ten years if the purpose of the loan is the purchase of a principal residence, and bear interest at rate consistent with local prevailing rates as determined by the Plan Administrator. These rates range from 4.25% to 9.50% on loans outstanding at December 31, 2024. Principal and interest are paid ratably through payroll deductions. As of December 31, 2024 and 2023, notes receivable from participants totaled \$2,173,120 and \$1,942,783, respectively, and mature through 2032.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of accounting

The Plan's financial statements are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from estimated amounts.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued):

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Associated fees are recorded as administrative expenses when incurred. Notes receivable from participants that become delinquent are reclassified as distributions based upon the provisions of the Plan document. Because all loans are fully collateralized by participant's account balances, and defaulted loans are recharacterized as non-cash distributions, the Plan will not sustain credit losses on the loans. Accordingly, no allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Investment valuation and income recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Committee determines the Plan's valuation policies utilizing information provided by the investment trustees. See Note 4 for discussion of fair value measurements.

Contract value is the relevant measurement for the portion of the net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recognized principally on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and matching contributions from Employers are recorded in the year in which the participants contributions are withheld from compensation. Profit sharing contributions, if any, are recognized upon authorization by the Employers in the year the underlying compensation is recognized. Investment of all participant and employer contributions are participant-directed.

Benefit payments

Benefits are recorded when paid.

Administrative expenses

Administrative expenses, which are charged to participant accounts, include legal, audit, plan investment and advisory fees and check writing and loan administration. Certain expenses of maintaining the Plan are paid directly by the Employers and are excluded from these financial statements. Investment-related expenses are included as a reduction of the net appreciation or increase of the net depreciation in the fair value of investments.

NOTE 3 – INFORMATION CERTIFIED BY STATE STREET BANK AND TRUST COMPANY (“STATE STREET”) AND TRANSAMERICA LIFE INSURANCE COMPANY (“TLIC”):

The following is a summary of the asset information as of December 31, 2024 and 2023, and for the years then ended, included in the Plan’s financial statements and ERISA-required supplemental schedule obtained by management and agreed to or derived from information certified by State Street and TLIC, the trustees of the Plan. The Plan Administrator has obtained certifications from State Street and TLIC that the information provided to the Plan Administrator by State Street and TLIC, respectively, related to the following assets is complete and accurate to the best of their knowledge and belief. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor’s (DOL’s) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and ERISA-required supplemental schedule related to the following assets:

State Street and TLIC have certified the completeness and accuracy of \$25,466,691 of net appreciation in fair value of investments, \$5,214,453 of dividends and interest and \$154,415 of interest on notes receivable from participants related to the aforementioned plan assets for the year ended December 31, 2024.

State Street and TLIC have certified the completeness and accuracy of \$28,275,595 of net depreciation in fair value of investments, \$4,548,724 of dividends and interest and \$113,704 of interest on notes receivable from participants related to the aforementioned plan assets for the year ended December 31, 2023.

NOTE 4 – FAIR VALUE MEASUREMENTS:

Accounting Standards Codification (“ASC”) Topic 820, Fair Value Measurements and Disclosures, provides a definition of fair value and establishes a framework for measuring fair value and includes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the hierarchy are described as follows:

Level 1 Unadjusted quoted prices for identical assets or liabilities in active markets.

NOTE 4 – FAIR VALUE MEASUREMENTS (Continued):

- Level 2 Prices determined using other significant observable inputs that other market participants would use in pricing a security, including quoted prices for similar assets or liabilities.
- Level 3 Prices determined using significant unobservable inputs for the asset or liability; that is, inputs that reflect the reporting entity's own assumptions about the factors market participants would use in pricing the asset or liability, and would be based on the best information available in the circumstances.

The fair value measurement level within the fair value hierarchy of each asset or liability is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There were no changes to the methodologies used at December 31, 2024 and 2023.

Mutual funds: Mutual funds are valued at the daily closing price reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective investment trust fund: Valued at the daily unit value published by Nasdaq. The fund is not traded on any exchange.

Unitized stock trust: The unitized stock trust is valued as the sum of (a) the daily closing stock price of the common stock held by the unitized stock trust as reported by New York Stock Exchange ("NYSE") plus (b) the amount of cash held by the unitized trust.

NOTE 5 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT:

The Plan has a traditional, fully benefit-responsive guaranteed investment contract with TLIC that is reported at contract value. TLIC maintains the contributions in a general account. The account is credited with contributions, earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 0%. Such interest rates are reviewed on a semi-annual basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. the Plan's failure to qualify under Section 401(a) of the IRC or the failure of the trust to be tax-exempt under Section 501(a) of the IRC;
2. premature termination of the contracts;
3. plan termination or merger;
4. changes to the Plan's prohibition on competing investment options; and
5. bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. an uncured violation of the Plan's investment guidelines;
2. a breach of material obligation under the contract;
3. a material misrepresentation; and
4. a material amendment to the agreement without the consent of the issuer.

NOTE 6 – PLAN TERMINATION:

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan, in whole or in part, subject to the provisions of ERISA. In the event of complete or partial Plan termination, the Trustees of the Plan shall determine whether the assets of the Plan shall be liquidated and distributed or whether the assets shall continue to be held in trust and distributed in accordance with the terms of the Plan.

NOTE 7 – TAX STATUS:

Effective January 1, 2021, the Plan adopted a non-standardized form of a pre-approved profit sharing plan provided by Transamerica Retirement Solutions, LLC (“Transamerica”). The pre-approved plan provider, Transamerica, received on June 30, 2020, an opinion letter from the Internal Revenue Service as to the pre-approved plan’s qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

GAAP requires the Plan Sponsor to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken any significant tax positions that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS:

The assets underlying the Plan’s investment in the Saul Centers Unitized Stock Trust include shares of common stock of Saul Centers, Inc. (“SCI”) and cash. SCI is a publicly traded real estate investment trust listed on the NYSE, is related to the Employers through common trustees and directors and is also a participating employer of the Plan. At December 31, 2024 and 2023, the combined fair value of the SCI common stock and cash held in the Unitized Stock Trust was \$14,797,185 and \$15,462,978, respectively.

Effective March 1, 2016, the Plan and Transamerica established a service agreement, which included an Expense Budget Account (“EBA”), and established an annual required revenue amount of 0.08% per annum of assets held by the Plan, exclusive of the Unitized Trust. Effective September 1, 2021, Transamerica reduced its annual required revenue amount to 0.05% from 0.08%. Expected fund revenue in excess of the required revenue will be credited to the EBA as of the last business day of each month. These amounts will be used to pay Plan related expenses approved by the Plan Sponsor and, to the extent not used to pay such plan expenses, shall be allocated to Plan participants as of the end of the plan year at the direction of the Plan Sponsor.

NOTE 9 – RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities that expose the Plan to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for plan benefits.

NOTE 10 – SUBSEQUENT EVENTS:

The Plan Administrator has reviewed operating activities for the period subsequent to December 31, 2024, and prior to the date that financial statements are issued, September 30, 2025, and determined that no subsequent events are required to be disclosed.
