## Independent Auditors' Report

To the Participants and Plan Administrator of  
ABC Bus Companies, Inc. Employees' Retirement Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of ABC Bus Companies, Inc. Employees' Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of ABC Bus Companies, Inc. Employees' Retirement Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

## 1. Description of Plan

The following description of the ABC Bus Companies, Inc. Employees' Retirement Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

### General

The Plan is a defined contribution plan established effective January 1, 1992, as restated January 1, 2024. The Plan covers all employees of ABC Bus Companies, Inc., ABC Leasing and Muncie Reclamation & Supply Company (collectively, referred to as ABC Bus Companies, Inc., Employer or Company) who are age 18 or older, excluding employees covered by collective bargaining agreements, leased employees, nonresident aliens, non-United States source income and independent contractors. Employees become eligible for the Company's matching contributions on the first of the month after completing one year of eligibility service and attaining age 18. Long-term part-time employees who met eligibility requirements under SECURE Act are also eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended, (ERISA). Certain employees of the Company are the trustees of the Plan (the Trustees). The Plan's Trustees are responsible for oversight of the Plan. The Plan's Trustees determine the appropriateness of the Plan's investment offerings and monitors investment performance.

### Third-Party Administration

The Company has contracted Blue Ridge Associates (formerly Tax Sheltered Compensation, Inc.) as the third-party administrator of the Plan. Among other things, the third-party administrator handles most of the day-to-day administration of the Plan, ensures plan compliance and gives assistance to internal staff for handling participant inquiries.

### Contributions

The Plan allows for cash or deferred arrangement contributions allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are thereby permitted to elect to have a percentage, limited by Plan provisions, of their annual compensation as defined by the Plan, contributed as pre-tax 401(k) contributions or Roth contributions, to the Plan. Employees hired or rehired after January 1, 2009, who do not elect otherwise, will have \$1,000 withheld from their pay annually. This amount will be withheld prorata each pay period. The Plan allows participants age 50 and older to make catch up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit contribution plans. Contributions are subject to limitations.

Each year, at its discretion, the Employer may choose to make an additional contribution to the Plan. Such a contribution is a supplementary matching contribution allocated to those who have elected salary reduction contributions. For the years ended December 31, 2024 and 2023, matching contributions are calculated at 100% of deferrals up to \$1,000 and 50% of additional deferrals up to the maximum employer match of \$2,000. Matching contributions for the years ended December 31, 2024 and 2023 were \$507,932 and \$444,340, respectively. Contributions are subject to certain limitations. Participants direct the investment of 401(k) contributions and matching contributions into the various investment options offered under the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

## Participant Accounts

Each participant's account is credited with the participant's contributions, the Employer's supplementary matching contributions and an allocation of the Plan's earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

A separate Employee Stock Ownership Plan (ESOP) account has been established for each participant whose accounts were transferred to the Plan from the ABC Bus Companies, Inc. ESOP. The ESOP is frozen. The account is comprised of two subaccounts, one to hold any amounts transferred from the Other Investments Account within the ESOP and the other to hold ABC stock transferred from the ESOP. The stock is valued annually by an independent third-party appraiser.

During the Plan years ended December 31, 2024 and 2023, there was no dividend paid on outstanding employer common stock.

## Vesting

Employee 401(k) contributions, employer supplementary matching contributions and ESOP contributions, plus actual earnings thereon, are immediately 100% vested.

## Notes Receivable From Participants

Participants may borrow from their non-ESOP accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. There is a minimum amount of \$1,000. Loan transactions are treated as a transfer to (from) the investment fund (to) from a participant loan fund. Loan terms range up to 5 years (15 years for loans on personal residences). The loans are secured by the balance in the participant's account and bear a reasonable rate of interest. When a participant defaults on a loan, it is considered a deemed distribution. Interest rates on loans outstanding as of December 31, 2024 and 2023 ranged from 5.25% to 10.50%.

## Payment of Benefits

Upon termination of service, death, disability or retirement (age 65), participants may receive the value of the vested interest in their account in the form of a lump sum distribution. Participants are also allowed to take an in-service distribution upon attainment of age 59 1/2. If a participant terminates employment and the participant's account balance is less than \$7,000, the plan administrator can authorize the benefit payment without the participant's consent. The Plan allows for hardship distributions, subject to plan provisions.

## Voting Rights

Each participant is entitled to exercise voting rights attributable to the employer shares allocated to his or her ESOP account and is notified by the Trustees prior to the time that such rights are to be exercised. When the participant does not provide instructions to the Trustees, the Trustees shall vote all these shares in proportion to the results of the votes on the issue by the participants.

## Recent Regulatory Standards

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements.

## 2. Summary of Accounting Policies

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company's Board of Directors determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance companies, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Contributions

Contributions from plan participants and the Employer contributions are recorded in the year in which the participant contributions are withheld from compensation

### Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowances for credit losses have been recorded as of December 31, 2024 and 2023.

### Payment of Benefits

Benefits are recorded when paid. However, ESOP distributions are recorded as payable when a participant has requested a distribution and the Company has repurchased shares of common stock based upon the applicable prior year ESOP valuation, but the funds have not been paid to the participant.

## Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer's supplementary account. Expenses that are paid by the Employer's supplementary account are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

## Subsequent Events

Subsequent events were evaluated through September 30, 2025, the date the financial statements were available to be issued.

## 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts* are valued based upon the unit values of such pooled accounts held by the Plan at year-end. Unit values are based on the fair value of the underlying assets of the fund derived from inputs principally from or corroborated by observable market data by correlation or other means, although are not based upon quoted market prices in an active market. The underlying investments of the pooled separate accounts consist of mutual funds, each of which follows a separate investment strategy. Due to the nature of these pooled accounts, there are no unfunded commitments or redemption restrictions. Were the Plan to initiate a full redemption of the fund, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Employer common stock* is valued based upon an independent valuation by a third party. The appraisal considered the use of the cost, market and income valuation techniques, consistent with prior years. The appraiser took into account historical and projected cash flow and net income, return on assets, return on equity, discounted cash flows and estimated fair value of the Company's assets and liabilities, all of which include unobservable inputs. As of December 31, 2024, the appraiser applied a 10% discount per lack of marketability and an 10.75% discount rate to the discounted cash flow model. As of December 31, 2023, the appraiser applied a 10% discount per lack of marketability and an 11% discount rate to the discounted cash flow model.

Employer common stock may be redeemed following at least five years of participation and withdrawals may not be made more frequently than once in any plan year. Participant requests for payment during the current plan year will be made utilizing the preceding valuation date for the employer common stock. The investment in employer common stock is all allocated to participants and is presented in the following table:

## 5. Related Party and Party-in-Interest Transactions

ABC Bus Companies, Inc. common stock is held by the Sponsor of the Plan. During the years ended December 31, 2024 and 2023, the Company repurchased 3,311 and 107 shares of common stock from the Plan, respectively.

Certain plan investments are managed by John Hancock Life Insurance Company (U.S.A.), the Custodian and therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment manager services are included in net appreciation or depreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party-in-interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

## 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

## 7. Tax Status

The IRS has determined and informed the Company by a letter dated September 1, 2015, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving this letter, the plan administrator believes that the Plan is designed and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## 8. Risks and Uncertainties

The Plan invests in various investment securities, including employer stock. Market risks include general events which could impact the value of investment securities, such as a pandemic or international conflict. Investment securities are exposed to various risks, such as interest rate, market concentration and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
