INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Management
The ADCOM Group, Inc. 401(k) Plan
Cleveland, Ohio

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The ADCOM Group, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified to by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Basis of Accounting

We draw attention to Note B to the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note B, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

NOTES TO FINANCIAL STATEMENTS

NOTE A - DESCRIPTION OF PLAN

The following description of The ADCOM Group, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. *General*

The Plan is a defined contribution plan that was initially adopted by the management of The ADCOM Group, Inc. (the "Company" and the "plan administrator") on January 1, 1996, to provide benefits to eligible employees of the Company. Participation is available to all employees of the Company who have completed three months of service and are 21 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

2. *Contributions*

Participants may elect to defer a portion of their eligible compensation and contribute it to the Plan. Maximum contributions are subject to certain limitations which are established by the Internal Revenue Code ("IRC"). Participants may also rollover distributions from other qualified retirement plans.

The Plan allows for discretionary Company matching contributions for eligible participants. The discretionary matching contributions are invested in the same manner as participants' contributions. For the year ended December 31, 2024, the Company elected to contribute 50% of the first 6% of annual compensation that a participant contributes to the Plan on a pre-tax or Roth basis. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

The Company can also make a discretionary profit-sharing contribution. No such contribution was made for the year ended December 31, 2024.

3. *Vesting*

Participants are immediately vested in elective deferrals and the earnings thereon. Vesting in the Company's matching and profit-sharing contributions is based on a 6-year graded schedule. Participants are credited with 20% vesting per year of service, starting in year two and until they become 100% vested after six years of credited service. Participants also become fully vested upon death or disability.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

NOTE A - DESCRIPTION OF PLAN (CONTINUED)

4. *Participant accounts*

Each participant's account is increased by the participant's contributions, the Company's contributions, and investment earnings. Each participant's account is reduced by participant withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which each participant is entitled is the benefit that can be provided from that participant's vested account.

Plan participants are permitted to determine the investments within their account based on a combination of permitted investment options. The Company has the sole discretion to determine or change the number and nature of investment options in the Plan.

5. *Forfeitures*

Upon termination of employment, participants forfeit their non-vested balances. Forfeited balances of terminated participants' non-vested accounts may be used to reduce employer contributions or to pay administrative expenses of the Plan, as determined by the Company. For the year ended December 31, 2024, \$43,000 of forfeitures was used to offset employer contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,844 and \$985, respectively.

6. *Notes receivable from participants*

Participants may borrow from their individual accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms are generally limited to a five-year term but may be longer for the purchase of a primary residence. The loans are secured by the vested balance in the participant's account and bear interest at a rate commensurate with prevailing rates as determined by the plan administrator. Participants repay principal and interest ratably over the term of the loan through payroll deductions.

7. *Benefits paid to participants*

Upon termination of service due to separation of employment, death, disability, retirement, or any other reason, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested account balance.

The Plan also provides for the following in-service withdrawals: 1) early withdrawals by participants after they reach age 59½, 2) hardship withdrawals, if they meet certain restrictions, and 3) withdrawals for participants who become disabled.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

NOTE A - DESCRIPTION OF PLAN (CONTINUED)

7. *Benefits paid to participants (Continued)*

If a participant dies before distribution of his or her interest, the entire undistributed amount will be paid to the designated beneficiary in a cash lump sum as soon as administratively practical following the date of death. If the participant terminates because of total and permanent disability, the participant shall be entitled to receive a distribution of the entire value of his or her account as of the disability date.

NOTE B - BASIS OF ACCOUNTING

The financial statements are prepared on the modified cash basis of accounting. Contributions and investment income are recognized when received, and disbursements are recognized when made.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

NOTE C - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The significant accounting policies consistently applied in preparation of the accompanying financial statements follows:

1. *Investment valuation and income recognition*

The Plan provides for investments in pooled separate accounts and a guaranteed investment contract ("GIC"). Pooled separate accounts are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment adviser. See Note E for discussion of fair value measurements.

GICs are reported at contract value. Generally, contract value of the Voya Fixed Account is equal to the participant's deposits minus participant withdrawals plus credited interest. See Note F for discussion on the guaranteed investment contract.

NOTE C - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

1. *Investment valuation and income recognition (Continued)*

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when received. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

2. *Fair value measurements*

The Plan estimates the fair value of financial instruments using available market information and other generally accepted valuation methodologies. Fair value is defined as the price that would be received to sell an asset or would be paid to transfer a liability in an orderly transaction between market participants at the measurement date. The inputs used to measure fair value are classified into three levels:

Level 1 Quoted market prices in active markets for identical assets and liabilities.

Level 2 Observable market-based inputs or unobservable inputs that are corroborated by market data.

Level 3 Unobservable inputs in which little or no market data exists

Investments – The following is a description of the valuation methodology used for assets measured at fair value:

Pooled Separate Accounts: The investments in pooled separate accounts are held and managed by Voya Retirement Insurance and Annuity Company ("Voya" or the "Custodian"). The fair value of investments held in these accounts is based on their reported net asset value ("NAV"). The NAV is based primarily on observable inputs, the market value of the underlying investments, and are classified as Level 2.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. There have been no changes in the methodology used from 2023 to 2024. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

3. *Notes receivable from participants*

Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded when received. Related fees are recorded as administrative expenses and are expensed when they are paid. There were no outstanding notes receivable from participants at December 31, 2024 or 2023.

4. *Benefits paid to participants*

Benefits paid to participants are recorded when paid.

5. *Administrative expenses*

Certain administrative fees are paid from the general assets of the Company and are excluded from these financial statements. Participant loan fees and fees for plan distributions are charged directly to the specific participants. Investment related expenses are included in net appreciation in fair value of investments.

6. *Use of estimates*

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE D - UNAUDITED INFORMATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan Administrator received a certification from Voya Retirement Insurance and Annuity Company acknowledging the completeness and accuracy of all investments reflected in the statements of net assets available for benefits (modified cash basis) at December 31, 2024 and 2023, the supplemental schedule (modified cash basis) at December 31, 2024, the related investment activity reflected in the statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and investment related information in the accompanying notes to the financial statements. This information is unaudited by independent accountants.

NOTE F - GUARANTEED INVESTMENT CONTRACT

The Plan holds an investment contract which meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer.

The investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed by the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.00%. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan document (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

NOTE G - INCOME TAX STATUS

The Company adopted the CCH Incorporated d/b/a FTWilliam.Com Volume Submitter 401(k)/Profit Sharing Plan which has obtained an opinion letter from the IRS dated June 30, 2020. The IRS determined that the volume submitter document, as then designed, was in compliance with the applicable requirements of the IRC. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Company believes the Plan is qualified and the related trust is tax-exempt.

Management has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

NOTE H - PARTY-IN-INTEREST TRANSACTIONS

Certain administrative functions are performed by employees of the Company. These employees are also Plan participants. No such employee receives compensation from the Plan. Plan investments are shares/units of funds managed by Voya Retirement Insurance and Annuity Company, who also receives administrative fees from the Plan. These qualify as party-in-interest transactions.

NOTE I - RISK AND UNCERTAINTIES

The Plan invests in various investment securities. The Plan's investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits and participants' individual account balances.

NOTE J - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

NOTE K - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through date of the Independent Auditors' Report, which is the date the financial statements were available to be issued.
