INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of the
CSRA 1992 Employee Welfare Benefits Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of CSRA 1992 Employee Welfare Benefits Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise statements of net assets available for benefits and plan benefit obligations as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits and plan benefit obligations for the year ended December 31, 2024, and the related notes to the financial statements (collectively, the financial statements).

Plan management (Management), having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the Financial Statements

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (US GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that Management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (US GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with US GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect Management's responsibility for the financial statements.

In preparing the financial statements, Management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the ability of the Plan to continue as a going concern for one year after the date that the financial statements were available to be issued.

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with US GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of US GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with US GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental information in the accompanying Nonexempt Transactions for the Year Ended December 31, 2024, and Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of Management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with US GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

(1) Description of the Plan

The following description of the CSRA 1992 Employee Welfare Benefits Plan (the Plan) provides general information only. For a complete description of the Plan's provisions, refer to the Summary Plan Description that is provided under the Plan.

(a) General

The Plan provides medical, prescription drug, life insurance and other benefits covering eligible, enrolled employees of CSRA, Inc. and CSRA-affiliated entities (CSRA). On April 3, 2018, CSRA was acquired by General Dynamics Corporation, and CSRA became a wholly-owned subsidiary of General Dynamics Corporation (the Company, the Plan Administrator, or the Plan Sponsor). This merger did not result in an impact to the Plan participants, as defined by the Plan Document, and their eligible dependents. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Internal Revenue Code (IRC) Section 401(h) account (the 401(h) Account) of the Plan is associated with the General Dynamics Retirement Plan (Government) (the Government Plan). The Government Plan, including the 401(h) Account, participates in the General Dynamics Corporation Group Retirement Trust (the Master Trust) along with certain other plans also sponsored by the Company.

The Northern Trust Company (Trustee) is the Trustee of the Plan. In accordance with the CSRA, Inc. Voluntary Employees' Beneficiary Association Trust Agreement (the VEBA Trust), the Trustee administers and invests the Plan's assets under the direction of the Company and their investment manager, BlackRock Financial Management, Inc., for the benefit of the Plan's participants.

(b) Eligibility

For a description of the eligibility requirements, refer to the Summary Plan Description that is provided under the Plan. The Plan is closed to new hires.

(c) Benefits

The Plan provides medical and prescription drug benefits for eligible retirees and their dependents.

For eligible pre-65 retirees who are not Medicare eligible, subsidized benefits are provided.

For eligible post-65 retirees and their spouses who are Medicare eligible, benefits are provided through a health reimbursement account (HRA) and medical exchange administered by Via Benefits.

Retirees and their spouses who were Medicare eligible prior to January 1, 2020, remain on the medical exchange (the Exchange) administered by Alight, Inc. The Exchange permits Medicare Eligible retirees and their beneficiaries the opportunity to obtain individual insurance coverage from health insurance providers. As such, any agreement or policy that such retiree enters through the Exchange is solely with the insurer selected by the retiree.

Certain retirees are eligible for life insurance benefits provided through an insurance carrier.

(d) Contributions

Retiree medical benefits are funded by a combination of the VEBA Trust and 401(h) Account associated with the Government Plan.

If an employee is eligible for retiree medical benefits after their termination of employment or as a result of employment status change to something other than regular, full-time employment, the amount of their required monthly contributions post-termination or post-employment change will equal the cost of the monthly insurance premiums for Plan benefits under the coverage option chosen, less the amount contributed by the Company toward such cost. The Company subsidy amount will vary depending on the age and service as defined by the Plan.

(e) Refunds

Upon termination from employment, employees may request a refund of contributions if they have not yet met the eligibility requirements for a subsidy to an HRA as described in the Summary Plan Description. If an employee is not eligible for retiree medical benefits as described in the Summary Plan Description on the date they terminate employment with the Company, or the date their employment status changes to something other than regular, full-time, they will receive a refund of the contributions made while actively employed by the Company, adjusted for any applicable investment gains or losses. Contributions are not refunded once the employee reaches age 62 and has at least ten years of service.

During 2024, the Plan refunded \$41,622 to Plan participants, which is included in the Statement of Changes in Net Assets Available for Benefits.

(f) Funding Policy

Benefits available under this Plan that are funded by insurance contracts will be determined and paid for solely by the respective insurance carriers thereunder. Benefits available under this Plan that are payable under any self-funded arrangement will be paid in accordance with the funding methods established by the Company.

The Plan Sponsor's policy is to fund contributions in amounts that are expected to be required to provide the Plan with sufficient funds to pay the premiums and expenses of administering the Plan as amounts become due and payable.

Plan participants share in funding a portion of benefits provided by the Plan in accordance with applicable provisions of the benefits contracts. For the plan year ended December 31, 2024, participant contributions totaled \$220,387. Participant contributions in the amount of \$209,326 were remitted to the 401(h) Account. Participant contributions related to the Plan of \$11,061 were reflected within the Statement of Changes in Net Assets Available for Benefits.

(g) Risks and Uncertainties

The Plan invests in various investments through the VEBA Trust and its interest in the 401(h) Account. Detailed disclosures on the investments in the 401(h) Account are presented in the Government Plan financial statements as of December 31, 2024 and 2023. Investments are exposed to various risks, such as interest rate, market, liquidity, and credit risks, as well as risk associated with global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits and the funded status of the Plan.

In addition, the actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

(b) Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of investments are recorded on the trade date. Investment income consists of interest income, dividend income and net appreciation in the fair value of investments. Dividends are recognized on the ex-dividend date, the date on which an entity or an individual must own the stock to receive the pending dividend. Interest income is recorded on the accrual basis. Net appreciation includes the gains or losses on investments bought and sold as well as held during the year.

(c) Postretirement Benefits

The postretirement benefit obligations represent the actuarial present value of estimated future benefits that are attributed to employee service rendered through the valuation date. Postretirement benefits include payments expected to be made to, or for (1) currently retired employees and their covered dependents, (2) active employees after retirement from service and their covered dependents, and (3) former participating employees who made a one-time deferral upon termination of employment.

The present value of the expected benefit obligations is determined actuarially and is the amount that results from applying actuarial assumptions to historical claims cost data. The estimate of future annual incurred claims costs per participant is further adjusted for estimates of the time value of money (through discounts for interest) and the probability of payment (through decrements, such as those for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

(d) *Administrative Expenses*

The Plan Sponsor administers the Plan. Administrative expenses, including professional fees, are paid by the Plan or the Company. Certain administrative expenses are included in the 401(h) Account (see Note 6).

(e) *Due from Providers*

The amount shown as due from providers at December 31, 2024 and 2023 represent medical rebates.

(f) *Payment of Benefits*

Benefits are recorded when paid.

(g) *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(3) *Certified Investments*

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103.8 of the Department of Labor's Rules and Regulation for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments at fair value, investment information related to the 401(h) Account, and accrued interest at December 31, 2024 and 2023, and net appreciation related to the 401(h) Account and interest income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by The Northern Trust Company (the Trustee of the Plan).

(4) *Fair Value Measurements*

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 – Inputs to the valuation methodology that are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted markets prices that are observable for the asset or liability;
 - Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 – Inputs to the valuation methodology that are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Units of a Common Trust Fund: The fair value of this private investment security is determined using the net asset value as provided by the fund manager (Level 2). The investment is redeemable daily at net asset value, and there are no significant restrictions on redemptions.

(5) Tax Status

The Plan Sponsor holds the assets of the Plan in the VEBA Trust, which was designed in accordance with Section 501(c)(9) of the IRC issued by the Internal Revenue Service (IRS). The IRS has determined and informed the Plan Sponsor in letter dated January 3, 1996, that the Trust is exempt from Federal income tax, other than taxes on unrelated business taxable income, under Section 501(a) of the IRC. The Plan Sponsor and the Plan's counsel believe that the Plan and the VEBA Trust continue to be designed and operated in compliance with the IRS regulations.

Certain earnings related to the Plan assets may be subject to income taxes based on the provisions of Section 419(a) and Section 512 of the IRC. The Plan recorded an income tax receivable of \$145,000 and \$84,000 as of December 31, 2024 and 2023, respectively. Tax refunds of \$61,000 for the year ended December 31, 2024 in the Statement of Changes in Net Assets Available for Benefits are related to tax paid related to after-tax employee funds that were already taxed.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. There are currently no audits of the Plan for any tax periods. Under the applicable IRS Statute of Limitations, the Plan is no longer open to income tax examinations for years prior to 2021.

(6) 401(h) Account

A portion of the Plan's obligations were funded through contributions to the Government Plan in accordance with IRC Section 401(h). The following tables present the components of the net assets available for the 401(h) Account as of December 31, 2024 and 2023 and the related changes in net assets available for the year ended December 31, 2024.

(7) Plan Termination

The Plan was established by the Company with the intention that it shall be operated indefinitely and that contributions to the Plan, if required, shall continue for an indefinite period. Although it has not expressed any intention to do so, the Company reserves the right at any time to terminate the Plan in whole or in part subject to the provisions of ERISA. In the event of such termination, contributions shall cease as of the date of termination and the assets then remaining in the Plan shall continue to be used and applied for the payment of reasonable and necessary expenses incurred in connection with such termination, or the purchase of contracts issued by insurance companies for insurance or other benefits coverage, or as otherwise permitted by the Plan, the VEBA Trust, the 401(h) Account and applicable law.

(8) Benefit Obligations

The benefit obligations at December 31, 2024 and 2023 are principally comprised of postretirement health and life insurance benefits.

The following significant actuarial assumptions were used in the actuarial valuations of both postretirement healthcare and life insurance benefit obligations prepared each year:

- Mortality – RP-2014 total employee and healthy annuitant mortality tables with generational projection from base year 2014 using Aon U.S. Endemic Mortality Improvement Scale (2024) for December 31, 2024 and RP-2014 total employee and healthy annuitant mortality tables with generational projection from base year 2014 using Aon U.S. Endemic Mortality Improvement Scale (2023) for December 31, 2023.
- Retirement Rate - Sliding scale where 100% of employees expected to retire by the age of 70.

- Weighted Average Discount Rate – 5.56% and 4.94% at December 31, 2024 and 2023, respectively.
- Retiree participation rate – 50% for criteria A and 10% for criteria B and C pre-65 for December 31, 2024 and 2023.

The change in the postretirement benefit obligations for the year ended December 31, 2024, exclusive of benefits earned and paid, was a result of various factors, including changes in discount rates, and mortality scale. Other factors impacting the calculation of the expected benefit obligation include the updated census data reflecting actual experience during 2023 and anticipated experience during 2024, plus any other changes to the underlying data elements or coverage elections.

The foregoing assumptions presume that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation. The Plan sponsor currently has no intention to terminate the Plan.

(9) Related Party and Party-in-Interest Transactions

Certain investment funds held in the Master Trust are issued or managed by the Trustee or an affiliate of the Trustee and, therefore, qualify as exempt party-in-interest transactions. The Plan invests in units of a common trust fund managed by Northern Trust Investments, Inc., an affiliate of the Plan's Trustee, in the amounts of \$710,579 and \$897,635 as of December 31, 2024 and 2023, respectively. This investment and fees paid by the Plan to The Northern Trust Company and other service providers qualify as related party transactions.

Investments in certain collective funds held in the Master Trust are managed by Northern Trust Investments, Inc., an affiliate of the Trustee, in the amounts of \$2,795,388,711 and \$3,479,494,074, as of December 31, 2024 and 2023, respectively. An investment in a hedge fund in the Master Trust is managed by BlackRock Financial Management, Inc., in the amounts of \$864,450 and \$871,056 as of December 31, 2024 and 2023, respectively. Investments in certain collective funds held in the Master Trust are managed by BlackRock Institutional Trust Company, N.A., an affiliate of BlackRock Financial Management, Inc., in the amounts of \$3,254,485,210 and \$4,012,418,343 as of December 31, 2024 and 2023, respectively. These transactions qualify as related party transactions. There were also fees paid to BlackRock Financial Management, Inc. and The Northern Trust Company from the Master Trust and the Plan that qualify as related party transactions. The Master Trust also holds investment funds issued by certain investment managers which also qualify as exempt party-in-interest investments. Fees paid to other service providers also qualify as exempt party-in-interest transactions. Detailed disclosures on the related party transactions in the 401(h) Account are presented in the Government Plan financial statements.
