Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of the J. Jill 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Note 1 - Description of the Plan

The following description of the J. Jill 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan was adopted on July 2, 2009, and is a defined contribution profit sharing plan with a cash deferral arrangement covering all employees of Jill Acquisition, LLC (the “Employer”) who have completed six months of service if full time and one year of service if part time and attained age 21 (“Participant”), except leased employees and collectively bargained employees. Participants are eligible to begin participating in the Plan on the first day of the month following eligibility. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Substantially all investments are participant-directed.

Effective May 1, 2024, eligibility to participate in the plan requires that a participant have 30 days of service if full time. Effective December 1, 2024, participants who are considered to be Long-Term Part-Time Employees are eligible to participant if credited with at least three consecutive years beginning after December 31, 2020, with at least 500 Hours of Service in each year.

Participant Contributions

Participants may contribute up to 100% of their annual compensation as defined by the Plan, up to a dollar limit set by Federal law. A Participant may not defer an amount less than 1% of their annual compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (“Participant Rollovers”). Participants direct the investment of all contributions into various investment options offered by the Plan. Effective January 1, 2022, all new eligible participants are automatically enrolled in the Plan with a deferral rate of 6%.

Employer Contributions

Each year, the Employer, at its discretion, determines the amount of matching contributions and/or profit sharing contributions it will contribute to the Plan, subject to certain limitations. Eligibility to participate in profit sharing contributions requires that a participant have six months of service, (minimum of 1,000 hours worked during the Plan year) and be actively employed on the last day of the Plan year unless separated due to death, disability or attainment of early or normal retirement age. Effective May 1, 2024, eligibility to participate in profit sharing contributions requires that a participant have 30 days of service if full time. Effective May 1, 2022, the Employer elected to match 50% on the first 6% of compensation per employee per year. The Employer made a \$94,613 discretionary contribution for the 2024 plan year, of which \$11,985 was funded through forfeitures in March of 2025.

Participant Accounts

Each participant’s account is credited with the Participant’s contribution and a pro rata allocation of (a) the Employer’s contribution, (b) the Plan’s investment earnings, (c) an allocation of investment fees and (d) direct administrative expenses. Allocations are based on participant earnings, account

balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the Participant's vested account.

Vesting

Participants are immediately vested in their deferral and rollover contributions plus actual earnings thereon. Vesting in the Employer's contribution is based on years of continuous service. A participant begins vesting after one year of service and is fully vested after five years of service. Upon death, disability or attainment of normal retirement age, participants are fully vested in their accounts. Effective May 2024, participants are immediately fully vested in their accounts.

Forfeitures

The non-vested portion of a participant's account shall be forfeited as of the earlier of the date on which the participant receives a complete distribution of his or her account or the last day of the Plan year in which the participant incurs five consecutive one-year breaks in service. The Plan uses such forfeitures to offset Employer contributions or pay Plan expenses. At December 31, 2024 and 2023, forfeited non-vested amounts totaled \$23,867 and \$20,126, respectively. During 2024, \$63,158 of forfeitures were used to offset Employer contributions. \$11,985 of forfeitures were used to reduce the 2024 plan year contribution in March of 2025.

Payment of Benefits

In-service withdrawals from Participants' account balances, as defined, are permitted upon the attainment of age 59½. Hardship withdrawals are allowed from a Participant's deferral account only. Prior to January 1, 2019 at which point such restrictions were removed, hardships were allowed only after exhausting the maximum amount available to the Participant as a loan under the Plan and deferrals were suspended for a period of six months after receipt of a hardship withdrawal. Participants are entitled to their account balance upon death, disability, retirement or termination of employment. A participant may elect to receive a lump-sum amount, installment payments or annuity payments, equal to his or her account balance. In addition, if a participant's account is less than \$1,000, and a distribution election has not been made by the Participant, the Plan administrator may distribute the benefit to the Participant.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms range up to five years (or up to 15 years for the purchase of a primary residence). Participants are allowed only one loan outstanding at any given time. Loans are secured by the balance in the Participant's account and bear interest at a rate equal to prevailing local bank rates for similar loans. Principal and interest are paid ratably through payroll deductions.

Administrative Fees

Investment expenses and some administrative expenses are paid by the Plan and other administrative expenses are paid by the Employer.

Note 2 - Summary of Significant Accounting Policies

Basis of Presentation

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investments, Investment Valuation and Income Recognition

Investments other than fully benefit-responsive investment contracts (valued at contract value) are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measurement attribute for fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

The Plan administrator determines the Plan's valuation policies utilizing information provided by the trustee and custodians. See Note 4 for discussions of fair value measurements.

Benefits Paid

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could vary from the estimates that were used.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Contributions

Contributions from Plan participants and the contributions from the Employer are recorded in the year in which contributions are withheld from compensation.

Subsequent Events

The Plan has evaluated subsequent events through September 30, 2025, the date that the financial statements were available to be issued. No significant matters were identified for disclosure during the evaluation.

Note 3 - Information Certified by the Trustee and Custodian

Plan investments are held by the Plan's Trustee and Custodian, Empower Life & Annuity Insurance Company of New York ("Empower"). The fair value and contract values of all investments as of December 31, 2024 and 2023 and all investment transactions for the year ended December 31, 2024, including interest and dividend income and net appreciation, are reported to the Plan and certified as complete and accurate by Empower. Information included in the supplemental schedule, Schedule H, Line 4i - Schedule of Assets (Held at End of Year), and notes receivable from participants, have also been derived from information certified by Empower. The Plan offers investment choices to allow participants to create a diversified portfolio of assets based on a participant's risk tolerance. Participants may direct contributions to any of the investment options that consist of shares of mutual fund accounts and a guaranteed interest contract sponsored by Empower.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level I) and the lowest priority to unobservable inputs (Level III). The three levels of the fair value hierarchy are described below:

Level I – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level II – Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level II input must be observable for substantially the full term of the asset or liability.

Level III – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Note 4 - Fair Value Measurements (Continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 5 - Fully Benefit-Responsive Investment Contract

The Plan holds an investment contract that meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Fixed Interest Fund - SAGIC Diversified Bond Fund

The Plan has a benefit-responsive fixed interest fund with Empower, the recordkeeper through December 31, 2024. The SAGIC Diversified Bond Fund is valued by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit worthiness of the issuer. The contract promises to pay interest at crediting rates which are

announced in advance and guaranteed for a specified period of time as outlined in the group annuity contract. Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. There are no unfunded commitments related to this investment. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rates are based on a formula agreed upon with the issuer but may not be less than 0%. Such rates are reviewed on a quarterly basis for resetting. For the year ended December 31, 2024, the crediting interest rate was 3.30%.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendment to the Plan document (including complete or partial termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events, which would limit the Plan's ability to transact at contract value with the contract issuer, are probable of occurring.

Note 6 - Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events such as a pandemic or international conflict, which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Note 7 - Related-Party Transactions and Exempt Party-in-Interest Transactions

Plan investments include a fixed interest fund managed by Empower Retirement. Empower Retirement is the recordkeeper as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions. For the Plan year ended December 31, 2024, administrative fees of \$169,680 were paid to Empower Retirement. In addition, notes receivable from participants also qualify as exempt party-in-interest transactions, as defined by ERISA.

Notes to Financial Statements

Note 8 - Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Employer may determine.

Note 9 - Excess Contributions Refundable

At December 31, 2024 and 2023, the Plan had a liability of \$93,950 and \$82,632, respectively, which represented the return of excess contributions required to satisfy the relevant nondiscrimination provisions of the Plan. The excess contributions were returned to participants by March 13, 2025 and March 14, 2024, respectively.

Note 10 - Tax Status

The Plan has adopted the Empower Retirement, LLC pre-approved defined contribution plan. The Plan and related trust have been determined by the Internal Revenue Service (the "IRS") to be tax-exempt under Internal Revenue Code Section 401(a). The most recent favorable opinion letter from the Internal Revenue Service was received by the Plan, dated November 14, 2022. The Plan has been amended since receiving the opinion letter; however, the Plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
