Their report, dated October 4, 2024, indicated that sufficient and appropriate audit evidence was obtained to provide a basis for ERISA Section 103(a)(3)(C) audit opinion and therefore expressed an unmodified opinion on the financial statements.

NOTES TO FINANCIAL STATEMENTS

December 31, 2024

Note 1 – Description of Plan

NGP Management, LLC (the “Company”) established the NGP Management, LLC 401(k) Plan (the “Plan”) effective January 1, 1999. The following description of the Plan provides only general information. Participants should refer to the plan agreement for a more comprehensive description of the Plan’s provisions.

General – The Plan is a defined contribution plan covering substantially all employees (except union employees, nonresident aliens, leased employees, and independent contractors) of the Company who have reached the age of 18. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions – Contributions to the Plan are made by both the Company and participants. Participants may elect to defer up to 100% of their compensation, as defined in the Plan, subject to Internal Revenue Service (“IRS”) limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company provides a non-elective safe harbor matching contribution equal to 100% of the first 3% of compensation and 50% of the next 2% of compensation that a participant contributes to the Plan. The Company may make an additional annual discretionary profit-sharing contribution in an amount to be determined by the Company. During the year ended December 31, 2024 the Company did not make a discretionary profit-sharing contribution to the Plan. Contributions are subject to IRS limitations.

Participant Accounts – Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution, (b) Plan earnings (c) administrative expenses paid by the Plan. Allocations are based on participant earnings, deferrals or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are immediately vested in their voluntary contributions and the Company’s safe harbor matching contributions plus actual earnings thereon.

The Company’s discretionary profit sharing contributions made to each participant’s account are subject to vesting requirements. The Company’s discretionary profit sharing contributions vest in accordance with the following schedule:

Less than two years	0%
Less than three years and more than two years	20%
Less than four years and more than three years	40%
Less than five years and more than four years	60%
Less than six years and more than five years	80%
More than six years	100%

In the event of death, permanent disability, or retirement, a participant’s employer contribution account becomes fully vested.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, whichever is less. A participant can have no more than two loans outstanding from the Plan. The loans are secured by the balance in the participant’s account and bear interest at a range of 4.25% - 9.50% as of December 31, 2024, which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits – The Plan allows benefits to be paid in the form of one lump-sum cash payment or in partial withdrawals. Upon termination for any reason, a participant may elect to receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account. If the participant has \$5,000 or more in their account, he or she may elect to maintain the account after separation from the Company. The Plan includes provisions that allow the plan administrator to distribute the balance of a participant’s account into an IRA account without consent if the terminated participant maintains a balance equal or less than \$5,000. Hardship withdrawals are allowed under the provisions of the Plan and cannot exceed the amount required to meet the immediate financial need created by the hardship.

Forfeited Accounts – A participant who leaves the Company forfeits any non-vested balances. The Plan uses such forfeitures to reduce Plan expenses or reduce amounts otherwise required to be contributed to the Plan. During the year ended December 31, 2024, there were no forfeitures utilized for Plan expenses or employer contributions.

Note 2 – Summary of Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s Investment Committee determines the Plan’s valuation policies utilizing information provided by the investment advisors, custodians and insurance company. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowances for credit losses have been recorded as of December 31, 2024. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits – Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants' account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation of fair value of investments.

Date of Management's Review of Subsequent Events – The Plan has evaluated subsequent events through September 3, 2025, the date the financials were available for issuance.

Note 3 – Certified Investments

Certain information, including investments and notes receivable from participants held at December 31, 2024, and net appreciation in fair value of investments, interest and dividends, other income, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company (“Reliance”), a qualified institution. The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

Note 4 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds: Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds are held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes that its valuation method is appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Investment Contract with Transamerica

The Plan entered into a fully benefit-responsive investment contract with Transamerica. Transamerica maintains the contributions in a group annuity contract. The account is credited with participants' contributions and earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is the daily equivalent of the effective annual rate of interest applicable for the six-month period.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investments guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract value, as reported to the Plan by Transamerica, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Note 6 – Related Party Transactions and Party-in-Interest Transactions

Certain plan investments are managed by Transamerica Retirement Solutions ("Transamerica") and Reliance; therefore, these transactions qualify as party-in-interest transactions. The Plan made direct payments to Transamerica of \$92,104, which was not covered by revenue sharing. Certain employees of the Company who participate in the Plan provide administrative services to the Plan at no cost to the Plan. Notes receivable from participants also qualify as party-in-interest transactions.

Transamerica provides certain administrative services to the Plan pursuant to a services agreement between the Company and Transamerica. Transamerica receives revenue from mutual fund service providers for services Transamerica provides to the funds. This revenue is used to offset certain amounts owed to Transamerica for its administrative services to the Plan.

If the revenue received by Transamerica from such mutual fund service providers exceeds the amount owed under the services agreement, Transamerica remits the excess to the Plan on an annual basis equal to 0.20% of the total net assets available for benefits. Such amounts may be applied to pay plan administrative expenses or allocated to the accounts of the participants. At December 31, 2024, there was an excess of \$22,592, which is included in other assets on the statements of net assets available for benefits. The Plan or Company may make a payment to Transamerica for administrative expenses not covered by revenue sharing. During the year ended December 31, 2024, \$30,478 of investment fees and administrative expenses were covered by revenue sharing. This is included in the administrative expenses on the statement of changes in net assets available for benefits.

Note 7 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions. Any unallocated assets of the Plan should be allocated to participant accounts and distributed in such a manner as the Company may determine.

Note 8 – Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since the date of the determination letter, the Plan administrator believes that the Plan is designed, and currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Note 9 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.



