### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Sail Biomedicines, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## Notes to Financial Statements

As of December 31, 2024 and 2023 and for Year Ended December 31, 2024

### 1. DESCRIPTION OF THE PLAN

The following description of the Sail Biomedicines, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

#### *General*

The Plan is a defined contribution plan covering substantially all employees of Sail Biomedicines, Inc. (the “Company” or “Plan Sponsor”). The Plan was established effective as of January 1, 2019 and restated on January 1, 2024. The Plan is subject to the Internal Revenue Code of 1986 (“IRC”), as amended, and the Employee Retirement Income Security Act of 1974 (“ERISA”). All investments are participant directed.

Effective January 1, 2024, the name of the plan was changed from Laronde Inc., 401(k) Plan to Sail Biomedicines, Inc. 401(k) Plan.

Effective January 1, 2024, the Plan was amended to approve the merger of the Senda Biosciences Inc. 401k Plan into the Plan.

Empower Trust Company, LLC is the Trustee of the Plan and Empower Retirement, LLC (“Empower”) is the Plan’s recordkeeper.

#### *Eligibility*

Employees are eligible to participate in the Plan upon attaining age 21 with a plan entry date on the first day of the calendar month subsequent to attaining age 21. Employees who are union employees, leased employees, non-resident aliens and residents of Puerto Rico are not eligible to participate in the Plan.

#### *Participant Contributions*

An active participant may elect two types of contributions to the Plan subject to limitations as defined in the Code as follows:

#### *Elective Deferrals*

Each year, participants may contribute a portion of their pre-tax compensation, as defined in the Plan, subject to certain IRC limitations. Participants are allowed to make Roth elective deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may change salary deferral elections at any time which become effective as soon as administratively feasible after it is received by the plan administrator. Participants direct investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision

whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation.

## *Rollover Contributions*

Participants may also contribute amounts representing rollover distributions from other qualified plans, if the contributions satisfy the tax law requirements for a qualified rollover.

## ***Employer Contributions***

### *Matching Contributions*

The Company may, in its sole discretion, make a discretionary matching contribution equal to a percentage of eligible participants' elective deferrals. The Company, by actions of its Board of Directors, shall determine the amount, if any, of the employer matching contribution.

### *Non-Elective Contributions*

The Company may make a non-elective contribution in an amount determined by the Company. Participants who are eligible for non-elective contributions if they have met the eligibility requirements and are employed on the last day of the Plan year. If a participant terminates employment with the Company due to death, disability or attainment of the normal retirement age, they are eligible for non-elective contributions. There have been no non-elective contributions since inception.

## ***Vesting***

Participants are vested immediately in their elective deferrals, including rollover contributions, plus actual earnings thereon. Employer matching and non-elective contributions will vest according to the following schedule:

## ***Notes Receivable from Participants***

In accordance with the Plan's provisions, employees may borrow against their individual account balances. Participants may borrow up to the lesser of 50% of their vested account balance or \$50,000, which amount shall be reduced by the highest outstanding balance of loans, if any, during the preceding 12-month period over the current outstanding balance of loans. Loans are to be repaid at least quarterly, generally within 5 years of issuance. Loans shall bear interest at a rate determined by the Plan Administrator. Principal and interest on the loans are to be paid ratably through payroll deductions.

## ***Distributions***

Distributions are made as lump sum payments or installment payments.

## ***Retirement, Disability or Death***

Participants who retire or become disabled will be entitled to 100% of their account balance. Upon death, a participant's beneficiary will be entitled to 100% of the account balance, payable in accordance with the Plan document.

## ***Other Termination of Employment***

Upon termination of employment for any reason other than retirement, disability, or death, participants shall be entitled to receive the vested amount of their account balance as soon as administratively feasible following the date of termination.

Distributions can also be made as in-service hardship withdrawals and upon attaining age fifty-nine and a half.

## ***Forfeitures***

At December 31, 2024 and 2023, there were no forfeited non-vested accounts. These accounts will be used to reduce future employer contributions or pay administrative expenses. In 2024, employer contributions were reduced by \$0 from forfeited non-vested accounts.

## ***Participant Accounts***

Each participant's account is credited with the participant's contributions, employer contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## *Investment Options*

The Plan provides for participant-directed investment options by allowing participants to choose from a number of available investments.

## *Plan Termination*

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their employer contributions.

## **2. SIGNIFICANT ACCOUNTING POLICIES**

### *Basis of Accounting*

The accompanying financial statements have been prepared on the accrual basis of accounting.

### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that effect the reported amounts of asset, liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

## *Contributions*

Contributions from Plan participants and Company matching contributions, if any, are recorded in the year in which the employee contributions are withheld from compensation.

## *Payment of Benefits*

Benefit payments are recorded when paid.

## *Administrative Expenses*

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and the processing of benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

### **3. CERTIFIED INVESTMENT INFORMATION**

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC, a qualified institution.

Empower also certified the information included in the Schedule of Assets (Held at End of Year).

### **4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Valuation is based on observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liabilities fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

## ***Investment Valuation***

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the net asset value of shares held by the Plan at year end. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Trust Fund:* The Invesco Stable Value Trust, which holds public investment securities is valued using the NAV provided by Invesco Trust Company. The NAV was quoted on a private market that was not active; however, the unit price was based on underlying investments which were traded on an active market or had observable inputs. The collective trust fund's underlying investments sought to preserve capital and provide a competitive level of income over time that was consistent with the preservation of capital. The collective trust fund did not have any unfunded commitments relating to its investments, nor any significant restrictions on redemptions.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 5. TAX STATUS

The Plan has adopted a non-standardized pre-approved profit sharing plan with CODA. The Internal Revenue Service (“IRS”) has determined and informed CCH Incorporated by a letter dated June 30, 2020, that the plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or the Department of Labor (“DOL”). The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the IRS and DOL; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to examinations for years prior to December 31, 2021.

## 6. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

## 7. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Empower provided record keeping services to the Plan, Empower Trust Company, LLC provided trustee services to the Plan, and Compass Retirement Consulting Group provided administration services to the Plan. Transactions with Empower, Empower Trust Company, LLC and Compass Retirement Consulting Group qualify as party-in-interest transactions.

Fees paid for investment management services are included as a reduction of the return earned by each mutual fund. Notes receivable from participants also qualify as party-in-interest transactions.

Management has evaluated subsequent events through September 30, 2025, which is the date the financial statements were available to be issued. There were no subsequent events that require adjustment to or disclosure in the financial statements.
