## REPORT OF INDEPENDENT AUDITORS

To the Retirement Committee of  
Mago Construction Company, LLC Profit Sharing Retirement Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Mago Construction Company, LLC Profit Sharing Retirement Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule of Schedule H, line 4i – Schedule of Assets (Held at End of Year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

### 1. DESCRIPTION OF THE PLAN

The following brief description of the Mago Construction Company, LLC Profit Sharing Retirement Plan (the "Plan") is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a safe harbor defined contribution profit sharing plan established by Mago Construction Company, LLC, and its affiliates, Bardstown Asphalt Company, Inc., and TAPCO, Inc. (collectively referred to as the Company) and is subject to the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan covers all employees who are at least 21 years of age. To be eligible for elective deferrals and the safe harbor match, an employee must have at least six months of service. To be eligible for profit-sharing and discretionary matches, an employee must have at least one year of service. An employee will receive credit for one year of service upon completing at least 1,000 hours of service in the first year of employment or in any subsequent plan year. A participant is enrolled into the plan on the first day of the month following the satisfaction of the eligibility requirements.

For the Plan year an employee first becomes a participant, the allocation of the Company's discretionary contribution and profit-sharing contribution will be determined by taking into account the employee's compensation only for the portion of the plan year in which the employee is deemed a participant. An employee must still complete 1,000 hours of service and be an active employee as of December 31<sup>st</sup> to receive the company contribution.

In addition, the Plan was established in accordance with the Davis-Bacon Act ("Act"), which requires certain levels of fringe benefits to be paid to employees working on federally funded projects covered by the Act. The Plan was also established in accordance with prevailing wage requirements for certain state-funded projects. Employees who do not meet the above eligibility requirements become participants on the date on which work is begun on a project subject to the Act or similar state law, when such employees' level of pay does not already include certain fringe benefits. For any plan year, if an employee earns compensation for work subject to a prevailing wage, the employee is immediately eligible to receive a prevailing wage contribution to the Plan, regardless of their general eligibility status.

#### Contributions

The Plan permits eligible employees, through a salary reduction deferral election, to make annual Roth and pre-tax contributions up to the current Internal Revenue Service deferral limits. Employee rollover contributions are also permitted.

The Company matched 100% of the first three percent and 50% of the next two percent of each participant's elective deferral for the year ended December 31, 2024. The Company may make an annual discretionary profit-sharing contribution; however, the Company elected not to contribute a profit-sharing contribution for 2024. Company contributions included in the statement of changes in net assets available for benefits for 2024 relate to safe harbor contributions and prevailing wage contributions.

### Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's safe harbor contribution, the Company's prevailing wage contribution, the Company's discretionary match, as well as allocations of the Company's discretionary profit-sharing contribution, forfeitures, and the Plan's earnings. Participant accounts are charged with an allocation of investment and other transaction expenses paid by the Plan. Allocations are based on participant account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants are fully vested in all employee, prevailing wage, and safe harbor contributions, plus actual earnings thereon at all times.

The Company's discretionary match and profit-sharing contributions are fully vested at the end of six years, with partial vesting as follows:

### Forfeited Accounts

Forfeited non-vested accounts can be used for plan expenses or to reduce future Company contributions. There was no balance in forfeited non-vested accounts at December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, there were no forfeitures used for administrative expenses.

### Benefit Payments

Upon termination of service due to death, disability, or retirement, participants are entitled to receive a lump-sum payment equal to the value of the participant's account or periodic installment payments. The Plan also permits hardship withdrawals and in-service withdrawals, subject to certain restrictions as defined in the plan document.

### Administrative and Investment Management Expenses

Administrative expenses could be paid by the Company or the Plan at the Company's discretion. Administrative expenses paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. The Company provided significant administrative services at no expense to the Plan. Investment management fees are charged to the Plan as a reduction of investment return and are included in the investment loss reported by the Plan. All other expenses are paid by the Company.

### Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its discretionary and profit-sharing contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become fully vested in their Company contributions.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### Basis of Accounting

The financial statements of the Plan have been prepared on an accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

### Investment Valuation and Income Recognition

Investments held by a defined contribution plan are required to be reported at fair value. The Plan invests in investment contracts through a common/collective trust. Fair value for this common/collective trust is based on the net asset value of the fund as reported by the investment advisor. The Plan also invests in pooled separate accounts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodian, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends and interest are recorded when received. Net depreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

### Risks and Uncertainties

The Plan invests in various securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

### Payment of Benefits

Benefit payments are recorded when paid.

### Tax Status

The Plan has adopted a pre-approved plan document sponsored by Frost Brown Todd LLC, which has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by various federal and state taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the accompanying financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Subsequent Events

The plan administrator has evaluated events or transactions occurring subsequent to the statements of net assets available for benefits date for recognition and disclosure in the accompanying financial statements through the date the financial statements are available to be issued, which is September 29, 2025.

### **3. INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Life Insurance Company ("John Hancock"), the custodian, has certified to the completeness and accuracy of all investments reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the schedule of assets (held at the end of year) as of December 31, 2024, and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

### **4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

However, in accordance with Subtopic 821-10, certain investments that were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Pooled separate accounts:* Investments in pooled separate accounts are credited with earnings and gains or losses on the pooled investments. The separate accounts are stated at fair value as reported to the Plan by John Hancock, based on the quoted market prices of the underlying mutual funds. The unit value of the separate accounts is calculated by dividing the total value of the assets of the separate account by the number of units in the separate account. The investment strategies for the pooled separate accounts vary based on the degree of risk chosen by the participants.
- Common/collective trust:* Valued at the net asset value (“NAV”) of units of the John Hancock Stable Value Trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

### Investments Measured Using the Net Asset Value Per Share Practical Expedient

The following table summarizes investments for which fair value is measured using the net asset value per share practical expedient as of December 31, 2024 and 2023. There are no practical redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

### **5. PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Company, and certain others. Professional fees and the majority of other administration expenses of the Plan were paid by the Company.

John Hancock is the recordkeeper and custodian of the Plan, and Merrill Lynch is the investment advisor; both receive payment from the Plan through a revenue-sharing arrangement rather than a direct payment. Blue & Co., LLC, is the independent auditor of the Plan and receives payment from the Company. Retirement Plan Resources is the third-party administrator and receives payment from either the Plan or the Company, depending on the service provided.

### **6. RECONCILIATION TO FORM 5500**

The Plan sponsor has elected to show the underlying investments of the pooled separate accounts on Schedule H of Form 5500. Therefore, instead of showing the pooled separate accounts on Schedule H, line 1c(10), the underlying investments of the pooled separate accounts, which are mutual funds, are shown on Schedule H, line 1c(13). Likewise, the investment income is shown on Schedule H, line 2b(6) instead of line 2b(7).
