### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Sharp Shopper, Inc. Profit Sharing & 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Sharp Shopper, Inc. Profit Sharing & 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

### Opinion

### Notes To Financial Statements

#### Note 1 – Plan Description

The following description of The Sharp Shopper, Inc. (the “Company”) Profit Sharing & 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan with a 401(k) provision covering all employees of the Company who have completed 1,000 or more hours of service in a twelve consecutive month period, and have attained the age of twenty-one. The Plan was amended effective January 1, 2022 to allow Roth deferrals and in-plan Roth rollovers. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions – Each year, participants may contribute up to 100% of eligible compensation, not to exceed the annual amount permitted by Federal law. Catch-up contributions are permitted for eligible participants age 50 or older by the end of the calendar year. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a common collective trust fund and various mutual fund options for participants.

The Company may, at its discretion, decide to match participant contributions to the Plan. For the years ended December 31, 2024 and 2023, the Company contributed a matching contribution equal to 100% of the amount deferred by the employee, up to 4% of compensation. Additional contributions by the Company are at the discretion of the Board of Directors. There were no such additional discretionary contributions during 2024 or 2023. The matching Company contribution and additional Company contributions are directed into the various investment options by the participants.

Participant Accounts – Each participant’s account is credited with the participant’s deferred contribution and allocations of the employer matching contribution, Plan earnings, and the Company’s discretionary contribution. Each account is also charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are immediately vested in all contributions, plus any earnings thereon.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loans must be repaid within five years unless the loan was used in the purchase of a primary residence. The loans are secured by the balance in the participant’s account and bear interest at the prime rate plus 1%. The rate of interest on all outstanding loans as of December 31, 2024 was 4.25 – 9.50%, respectively. Principal and interest is paid ratably through weekly payroll deductions.

#### **Note 1 – Plan Description – Continued**

Payment of Benefits – Upon termination of service, a participant may elect to receive a lump-sum distribution equal to the vested value of his or her account. Automatic distributions will be made to terminated participants with vested balances less than \$1,000. If a terminated participant's vested balance is in excess of \$1,000 but less than \$5,000, the third party administrator will roll over the distribution into an individual retirement account (IRA) absent a distribution direction from the participant. If the terminated participant's vested balance exceeds \$5,000, a written request from the participant is required before distribution. In-service distributions may be made regardless of separation from service provided the participant has reached normal retirement age. Hardship withdrawals are permitted from any account which is fully vested.

#### **Note 2 – Significant Accounting Policies**

Basis of Accounting – The financial statements of the Plan are prepared under the accrual basis of accounting.

Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – The Plan's investments are stated at fair value as determined and certified by the Plan's Trustee. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year end. The common collective trust fund is recorded at fair value based on the underlying assets.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits – Benefits are recorded when paid.

Administrative Expenses – All administrative expenses will be paid by the Plan unless paid by the Company. Certain administrative expenses associated with the Plan were paid by the Company.

Subsequent Events – Events that occurred subsequent to December 31, 2024 have been evaluated by the Plan's management through September 24, 2025, which is the date the financial statements were available to be issued.

#### **Note 3 – New Accounting Standards**

Pronouncements issued by the Financial Accounting Standards Board (FASB) with future effective dates are either not applicable or are not expected to be significant to the Plan's financial statements.

#### **Note 4 – Investments**

As of December 31, 2024 and 2023, the Plan's investments are held in a trust fund administered by Ascensus Trust Company.

During the years ended December 31, 2024 and 2023, the Plan's investments in a common collective trust fund and in mutual funds, including gains and losses on investments bought, sold and held during the year, appreciated in fair value by \$1,297,787 and \$1,757,249 respectively.

#### **Note 5 – Fair Value Measurements**

Generally accepted accounting principles in the United States of America have an established framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

### Note 5 – Fair Value Measurements – Continued

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at quoted market prices, which represent the net asset value (“NAV”) of shares held by the Plan at year end.

*Common collective trust fund:* The Plan invests in a common collective trust fund. The Fund is designed to deliver safety and stability by preserving principal and accumulating earnings. This fund is primarily invested in guaranteed investments contracts and synthetic investment contracts. The fund is valued based upon the NAV of the underlying investments. Participant-directed redemptions have no restrictions, however, the Plan is required to provide a one-year redemption notice to liquidate its entire share in the fund.

#### **Note 6 – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

#### **Note 7 – Tax Status**

The Company adopted a non-standardized pre-approved Profit Sharing Plan, which received a favorable opinion letter from the Internal Revenue Service on June 30, 2020. The opinion letter stated that the Prototype Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan did not apply for a separate determination letter; however, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require the Plan to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service and the Department of Labor. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 8 – Parties-In-Interest Transactions**

As previously discussed, the Plan may issue loans to participants that are secured by participant account balances. All of these transactions qualify as party-in-interest transactions.

Everence Trust Company provided investment advisory services to the Plan. Fees paid by the Plan for these services amounted to \$13,322 and \$31,167 for the years ended December 31, 2024 and 2023, respectively.

Ascensus Trust Company provided record keeping services to the Plan. Fees paid by the Plan for these services amounted to \$6,134 and \$8,774 for the years ended December 31, 2024 and 2023, respectively.
